Premeditated Suicide.

On Thursday evening of last week, while Mr. and Mrs. Robert Watt, of Bay City, were coming down the Garibaldi beach and when near Bar View Smith's place, they discovered the lifeless body of an unknown man partly buried in the sand, with a bullet hole in his forehead. The remains proved to be a man who came in on the steamer Sue H. Elmore a week previous, who had been stopping at Garibaldi, rooming at Postmaster F. M. Shearer's place and boarding with N. McMillian. The last seen of the man was on Wednesday evening on the beach, when he appeared to be acting a little strangely, throwing his arms about, but as those who saw him did not think for one moment that he contemplated committing suicide, they paid but little attention to him.

The man proved to be J. M. Smith, of Colfax, Wash., and from his effects that he left at Postmaster Shearer's, there is no doubt that it was a case of premeditated suicide, as the following letters will prove which were found in his valise:

Garibaldi, Ore., June 16, 1904.

R. H. Lacy, Colfax, Wash.

Dear R. H.—When you receive this, if you ever do, I shall have "crossed the divide." If an found have me buried here, if not, advise any of my relatives against a useless search, for "when the sea gives up its dead" I will be in the procession. You can use your own judgment as to the kind of accident that happened, not that it will matter to me, but it will save gossip and explanation among my acquaintances and to some a feeling of horror, and will soon be forgotten. I had rather my sister never knew, if possible.

Thoroughly appreciating all your kindness to me, and thanking you sincerely for it, wishing you and yours all the happiness that is possible to humanity. I am as ever, sincerely and affectionately yours,

J. M. SMITH.

P.S.—I am stopping with the postmaster here.

Pinned to this letter was the following note:

Garibaldi, Ore., June 15, 1904.

Mr. Shearer.—Please notify R. H. Lacy, Colfax, Wash. Turn over my effects to him and oblige.

J. M. SMITH.

The man was about 60 years of age, and from all appearance was in good circumstances. His papers showed that he was a large taxpayer that he had been deputy county clerk of Whitman county, Wash., that he belonged to the Masonic and K. of P. lodges at Colfax, and from all appearance was very methodical in setting down in a memorandum book his personal expenses, such as paying for his meals and in the purchase of the revolver that was to end his life. He had no money, but a check for \$50, made payable to him from the Colfax National Bank on Portland, had not been cashed, but was with the letter.

Coroner Reynolds went down to Garibaldi on Friday morning, and after making an investigation, did not think it was necessary to hold an inquest and had the body brought to this city. He notified his friends and the K. of P. at Colfax, and the reply came back to turn the body over to the members of that order for burial, which took place on Sunday, the funeral service being conducted by Rev. E. M. Patterson in the Christian church and the burial in the Oddfellows' cemetery, a large number of K. of P. being present.
