Up To City Officials.

BAKER CITY, Ore., Aug. 15.—Sheriff Brown has changed his plans regarding the enforcement of the gambling and Sunday laws. He has decided, in view of the fact that it is considered first to be the duty of municipal officers to enforce the law, that he should first notify the various officers that if they fail in this duty he will proceed to do so himself. Accordingly, he has issued written notices to all the city and precinct officers in the county that if they do not do their duty in the premises he will begin at 12 o'clock, midnight, August 20, to enforce the laws against gambling and Sunday opening.

Several of the leading gamblers and saloonmen have announced that they will obey the mandate of the Sheriff; others say they will not pay any attention to it. Sheriff Brown said today that when the time limit for the city and precinct officers to act expired he would proceed to enforce his order in every part of the county. A large number of prominent business men and property owners have protested against the action of the Sheriff, but he says he has been asked by prominent citizens and heavy taxpayers to enforce the law, and he is going to do so without fear or favor.

FIRE SWEEPS ON.

Flames Running Across Linn County.

ALBANY, Or., Aug. 16.—One of the most disastrous fires in the history of Linn County commenced yesterday in the forests about 14 miles from Lebanon, in the eastern part of the country. Already the large shingle mill of Gilbert Bros., together with 75,000 shingles, the a mily, homes and a number of buildings adjacent thereto, have been devoured by the greedy flames, and the end is not yet. Residents of that section of the country have been fighting the conflagration with a desperation born of necessity, but as yet have made no impression on the flames.

There are a large number of small mountain hamlets and settlements in the eastern part of the country, which are utterly without protection against such danger. Sweet Home, Foster, Soda-ville and Waterlog, all settlements of more or less importance, are situated in the midst of thick growths of fir and pine timber, and will certainly be destroyed should the wind carry the fire to their immediate neighborhood.

At the present time the fire is headed toward Foster and spreading rapidly, but is some distance away. The fire is now beyond human control and spreading with alarming rapidity.

There is not a finer body of timber in Oregon than that which dresses the mountains of Eastern Linn County, through which the fire is now raging. Already 30 square miles of magnificent timber has been converted into charred stumps, and the loss is thousands of dollars.

The fire has already crossed three mountain streams, each of which the fire-fighters had hoped would check the mad flames.

The only hope is now that a rain will come to quench the flames. No loss of life has yet been reported. Should the flames be unchecked until they reach the mountain villages, however, fatalities are almost sure to follow.

Gilbert Bros. lost all their property in the holocaust. The fire started from the camp fires of blackberry pickers who were camped in a large field of vine-covered logs near Gilbert's mill.

Salmon Few But Fine.

ASTORIA, Or., Aug. 15.—The 1904 fishing season closes officially today, but as there is a fair run of fish in the lower river and some large deliveries are being made it will be a couple of days at least before anywhere near accurate figures on the pack can be secured.

The season has been a disappointment to everyone connected with the industry with the single exception of the gillnetters, as it was a year when much was expected in the way of returns from the large number of fry that have been turned out from the several hatcheries. Extensive preparations were made for handling big runs, new plants were erected and the capacity of nearly every cannery and cold-storage plant on the river was increased, so that it would have been possible to have put up a pack fully double that of last year had the fish come in.

The estimated pack of the canneries in 1903 was 329,000 cases, on the basis of four dozen pound cans to the case. This season it will fall fully 100,000 cases below that and the total may not be over 200,000 cases. This shortage means a greater loss to the cannerymen than appears on the surface, for the majority of them had made contracts with their Chinese crews to pack a much larger number of cases than they have put up, and these contracts must be paid at the rate of about 42 cents per case.

For the first time in a number of years the various packers reached an agreement early in the season by which the price of the canned product was fixed at a figure that would be remunerative and at the same time would permit the paying of a good price for the raw fish, and the opening figures of 5 and 6 cents per pound have been maintained throughout the season until recently, when a drop was made to 5 cents flat. While the runs of fish have been small and consisted principally of a few spurts, the quality of the catch has been excellent, and the greater portion of the pack will command the highest market price.

One peculiar feature of the season has been that the trappers and seiners have done comparatively nothing, but the gillnetters, as a rule, have made better catches than for several years. Especially is this true of the men accustomed to drifting in the lower harbor and close to the mouth of the river. The cold-storage pack is short fully as much as is that of the canned product. Last season about 8000 tierces of pickled fish were put up and this year the total is only about 4800 tierces.

Monday was the beginning of the closed season for salmon fishing, but it is wholly disregarded by fisherman on the Columbia River. It is announced that State Fish Commissioner Kershaw told the fisherman on his visit last Saturday that they might continue to take salmon from the Columbia River and its tributaries until notified to close down. The fishermen announce that there will be no closed season observed until salmon ripe for spawning appear in the river, which they think will be about September 1.

DEMAND THE CITY.

Request the Surrender of Port Arthur.

TOKIO, Aug. 17.—The Emperor's order to release the noncombatants at Port Arthur, coupled with a demand for the surrender of the fortress, was delivered yesterday (Tuesday). An answer is expected today.

LONDON, Aug. 17.—A dispatch to the Central News from Tokio says a big oil warehouse at Port Arthur is blazing furiously, and that the position of the besieged is such that the Japanese are urging them to surrender.

Mining the Defenses.

ST. PETERSBURG, Aug. 17.—A dispatch received from Chefoo tonight, dated August 16, and giving undated advices from Port Arthur, says the Japanese during a bombardment occupied strongly fortified positions with a number of siege guns. After two hours, several of the Japanese guns were silenced. The Japanese, the advices say, are no longer trying to play their guns in the higher positions, which are too easily reached by the fire of the fortress, but are busying themselves with mining operations against the defenses.

The spirit of the garrison continues to be excellent, and Lieutenant-General Stoessel is going everywhere encouraging the troops. The fortress is well supplied with ammunition and provisions.

The mining fleet still in the harbor is capable of effective work in hindering the operations of Vice-Admiral Togo's fleet.

There is no sickness in the fortress, and the losses in the successive fights are by no means so heavy as reported from Japanese sources.

Shells Drove the Fleet Out.

CHEFOO, Aug. 16.—Today's sortie of the Russian warships from Port Arthur is regarded as a confirmation of previous reports that the Japanese have occupied an important land position, the fire from which compelled the Russian vessels to leave the harbor. It is certain that they returned to their former anchorage after the sortie.

Junks which left Port Arthur August 13th report that heavy fighting was continuing.

Pallada Probably Lost.

TOKIO, Aug. 16.—It seems certain that the Russian protected cruiser Pallada was torpedoed and sunk during the naval battle of August 10. She failed to return to Port Arthur, and has not been reported since Admiral Togo's fleet departed on various mission the night of August 10, when the Russians retreated.

Belated reports from various vessels continue to reach Admiral Togo. The Japanese destroyers and torpedo-boats made a series of attacks during the pursuit of the Russian warships. One destroyer reports that she hit a vessel of the Pallada type, and it is thought the vessel foundered. It is believed to be probable that the entire crew were either killed or drowned.

If she is afloat she will speedily be reported, and if destroyed it is probable that some of her wreckage will be found.

Whole Squadron in Rescue Work.

WASHINGTON, Aug. 15.—The Japanese Legation today received a cablegram from the Foreign Office at Tokio, saying that Admiral Kanimura reports that at dawn on August 14 his squadron discovered the three vessels of the Vladivostok squadron off Ulsan southeastern coast of Korea, steaming southward. The Russian vessels on sighting the Japanese squadron attempted to escape northward, but were prevented and fighting commenced at 5:23 a.m.

All the enemy's ships caught fire several times by reason of the Japanese shells and apparently suffered heavily, especially the Rurik. Eventually, the Russians fled at full speed northward, leaving behind the Rurik, which afterward sunk. Thereupon the whole Japanese squadron began the rescue of the drowning Russians and picked up about 600.

A New View of the Czar.

British comments on the assassination of Plehve are said to be singularly cold and critical. The London press recognizes, even while it deprecates the act, that the murder of the Czar's strongest Minister was the logical outcome of the stern repressive policy of which he stood as the exponent and executor. In view of the events of the last two years, and especially in connection with the death of Plehve, the English press is now asking whether this description of the Czar as given in "The Quarterly Review" article by "a high Russian official" is not nearer the truth than the general impression of him that has prevailed in Europe and in America since his memorable act in calling the peace conference at The Hague:

"From his accession his majesty has been filled with a spirit of self exaltation. Nikolai Alexandrovitch soon began to look upon himself as the centre of the world, the peacemaker of mankind, the torchbearer of civilization among the 'yellow' and other 'barbarous' races, and the dispenser of almost every blessing to his own happy people. Taking seriously this his imaginary mission, he has meddled continuously and directly in every affair of state, domestic and foreign, thwarting the course of justice, undermining legality, impoverishing his subjects, boasting his fervent love of peace, and yet plunging his tax burdened people into the horrors of a sanguinary and needless war. . . . Between humanity and divinity he believes himself a tertium quid."

Even granting the possible truth of this description, it is difficult not to feel pity for a Czar whose dreams soared so high and who is now confronted with their sudden collapse. It is a pathetic spectacle that is presented when the contrast is drawn between the ambitious, hopeful, peace loving Czar at the beginning of his reign and his present position, confronted by sedition and anarchy at home and a disastrous war in the East. Altogether, the Czar is in a position in which he might profitably reflect upon the remark of Lord Palmerston made half a century ago: "Nothing can be more deplorable than an inheritance of triumphant wrong."

A plea for a change will fall on deaf ears if the voter remembers that the United States has made a remarkable advance in all material interests in the last four years.

It will be a little awkward for Democratic orators to explain that they not only support the party platform, but also the private views of the candidates as expressed in telegrams and confidential letters.

It is announced that the olive branch has been adopted as the new emblem of Democracy. It is not large enough, however, to conceal the axes.

Quite a Number Who Can Boast of Personal Favore from King Edward.
