Fall Salmon Run Failure.

ASTORIA, Or., Oct. 31.—Advices from Oregon outside rivers convey the information that the run of Fall salmon is an utter failure. Only at one point are fair catches being made, and it is estimated by local packers that the output will be only about one third of last season. The protracted dry spell is believed to be responsible for the failure of the supply.

There has been a remarkable shortage in the canned fish product of the Pacific Coast this year. Thus far the shortage seems to have had but little effect on prices, but packers expect the market to advance shortly after the holidays. Most of the peck of Columbia River canneries was sold in advance, so packers will not benefit by any rise that that may ensue. It is agreed by those who closely follow the market that the shortage this year will leave the market in good shape for next season's output.
