Mills sued John Zuercher for \$200, who claimed he was entitled to that amount of money as the balance of a commission in a real estate deal. The jury, after being locked up several hours, took a different view and brought in a verdict for Zuercher, which puts the cost of the suit on Mills, amounting to \$50. Articles incorporating the Tillamook Transportation and Tug Company were filed with the County Clerk on Friday, the capital stock being \$25,000, and the incorporators are C. B. Hadley, F. S. Whitehouse and F. E. Dodge. The company is organized for the purpose of operating a line of steamers for the coast trade and towing lumber schooners into Tillamook Bay to avoid the delay which they were subjected to in previous years in being compelled to beat about outside for the want of a tow boat. From Assessor A. M. Hare's census returns the following figures give the population of Tillamook County and that of the two incorporated cities. Rights of Way Soon Ready. HILLSBORO, Or., Oct. 18.—The Board of Trade here is pushing the matter of a right of way between Banks and Buxton for the Pacific Railway & Navigation Company, the new company formed by E. E. Lytle, for the purpose of building a railroad into Tillamook country, the eastern terminus being this city. Mr. Heidel, who has the work in hand, reports that the rights between the two above named points will be ready to turn over to the company within a week. The rights are already secured between this city and Banks a distance of 10 miles, and part of the line is ready for the rails. Extensions of the time are now being signed, to correspond with the requests of the new company, which is taking up the right of way of the Portland & Nehalem. The Board of Trade committee on the matter of receiving \$40,000 subscriptions for first-mortgage bonds reports some progress. Part of the issue has been subscribed here. Assurance has been received that the Portland Chamber of Commerce will aid in procuring the amount. Jury List for Circuit Court. Suits have been filed in the circuit court by Handley & Thayer, who are attorneys acting for the county, against Mrs. Edith M. Alderman, administratrix of the estate and the bondsmen of the late Sheriff H. H. Alderman, to recover about \$8,000, which the county claims he was short in his accounts, which had been expeted by Clark & Buchanan, who found the delinquencies. Two suits were filed against the estate, one having been already disposed of against the county and the other is pending in the circuit court and is more than likely to meet a like fate, so the attorneys have sued the bondsmen, after a long delay in bringing the matter as to the amount of how much Alderman really owes the county. Attorney Ralph Dunway, who will represent Mrs. Alderman and the bondsmen, claims that \$1,800 is all that is due the county, which they offered to settle but refused by the county. We do not know whether we are right in advancing this theory, that to settle the amount of the shortage, it will have to be placed in the hands of a referee. Sue H. Elmore's Fine Mitigated. ASTORIA, Or., Oct. 28.—A letter was received at the local Custom House this afternoon from Lawrence O. Murray, of Washington, D. C., acting Secretary of the Department of Commerce and Labor reducing the \$500 fine recently assessed by Collector Robb against the steamer Sue H. Elmore, to \$100. The fine was imposed on the vessel for carrying 18 passengers in excess of her limit on her trip from this port to Tillamook on September 7. The letter received today, after reciting the protest to Captain Schrader, says: "The department considers that there was a violation of law. The fines incurred, however, are hereby mitigated to \$100 in all, provided the money remain subject to the department's control, or, if not received, that the mitigated penalty be paid within a reasonable time from this date. On such payment, you will refrain from proceedings for the enforcement of any further fine in the case." Brumbach-Page. Will C. Brumbach, of Ilwaco, and Miss Josephine Page, of Fort Canby, were united in marriage Tuesday morning, the 24th of October, at 10 a. m., in the parlor of the Parker House in Astoria, Justice of the Peace J. P. Goodman officiating. Death Roll of Railroads. WASHINGTON, Oct. 24.—The statement of railroad accidents recently issued by the Interstate Commerce Commission covered only the last quarter of the last fiscal year. The figures for the entire fiscal year are now given as follows: Total number of passengers killed in train accidents, 350; passengers injured in train accidents, 6498. The total number of employees killed in train accidents was 798; injured, 7052. There were 187 passengers killed in other than train accidents, and 3563 injured; 2463 employees killed in other than train accidents, and 38,374 injured; a grand total of all classes of 537 passengers killed and 10,050 injured, and 3261 employees killed, and 45,426 injured. This shows an increase of 117 passengers killed and 1963 injured, and a decrease of 106 employees killed, and an increase of 2160 employees injured. There were 6224 collisions during the year, with a money loss of \$4,849,054, and 5371 derailments, with a money loss of \$4,862,602, a total of 11,595 collisions and derailments a total money loss of \$9,711,656 being done by damage to cars, engines and roadways. Testimony gathered in Boston shows that William Rockefeller and H. H. Rogers divided \$3,565,000 as the profits of a Boston gas deal. Philanthropists of the McCarty type are not neglecting the illumination of the human race. It is not generally known that ants are very close relations to hornets, wasps and bees, or that some wasp store honey. One species, we learn from "The County Gentleman," was described by Azara, one of the early Spanish naturalists in South America. The nest is egg shaped, and is suspended to a branch. Particoes are made to shoot the rain off above the entrances, and the outer wall is very thick. The combs are full of rather tasteless honey. In Uruguay another wasp makes honey, but it is poisonous to human stomachs. In the hornet, bee, wasp and ant the poison of the sting or bite is the same, namely, formic acid.
