Well, it is like this: Like most every business man in the city, we have had a big run of business since the saloons and gambling joints have closed up, consequently we are able to give our readers four more pages of interesting reading matter.

The Astorian is in high ecstasy over the agitation it has started for a railroad from Astoria to Tillamook, although it does not make it clear how this is to be accomplished. But how slow of the city by the sea. Astoria might have been a busy and prosperous city today had it pulled for a railroad to Tillamook City instead of to Portland some few years ago.

We have been trying to figure out why it is that the Hon. George Washington Kiger should want to enter the political arena, and we can come to no other conclusion than this, that George must have a mortgage on ex Senator Maxwell's political sack, which must be getting musty after being put away in the political scrap-heap of that deposed local statesman.

Deputy District Attorney Cooper has received a letter from the ex-democratic editor, and now a fugitive from justice, wanting to know what his bail would be fixed at if he came back to Tillamook. Frank Weatherly, with others, was indicted by the last grand jury for selling "rot gut," and there is a little mystery how they got next and were not arrested and made to pay a fine. As the law breakers are "squealing" on one another it would be proper for Frank to return and join the band of democratic "squealers" who are making Tillamook famous.

"To be eligible as a member of the common council, a person must be a qualified elector of the state and a taxpayer on real property within, and a resident of the ward of the city which he is to represent."

This is the qualifications for a councilman in Tillamook City, and needs no argument to prove that a person who is elected without these qualifications have no legal standing whatever in the city council. It is foolishness and absurd to argue otherwise. The provision is a wise one and should be lived up to, for it was placed there to prevent those who have no property interest and the transient class from running the city government. Councilman King struck the right cord when he said, "Gentlemen, if I did not have the proper qualifications when I was elected I do not want to serve, and will gladly step down; neither do I want to serve in the city council if any member is not legally entitled to serve."

The newspapers of the Coast Counties, fully alive to the needs of Western Oregon, are unanimous in their demands for harbor improvements and railroad connections to open up and develop this long neglected portion of the state, which is immensely rich in undeveloped resources. Tillamook must join the coast counties in their efforts to accomplish something, for what this county needs is transportation and shipping facilities to get lumber to market. It will be noticed that Senator Fulton is thoroughly in accord with the newspapers of the Coast Counties, and his efforts are greatly appreciated, in introducing bills for appropriations for the improvement of coast harbors, amongst which is a bill for \$50,000 for Tillamook bay. All the Coast Counties have implicit confidence in Senator Fulton, and true to the interests of this section of Oregon, it is not surprising that the newspapers of the Coast Counties looked about for the best material for a congressman to assist Senator Fulton, and they are almost unanimous for Walter L. Tooz. The spirit of the Press in the Coast Counties is to open up and develop Western Oregon, and it can be done with united effort. The newspapers are showing a united effort, not only in endorsing Mr. Tooz for congressman, but in their determination to make Western Oregon a center of industry and commerce. The Press has struck the key note, and with united effort, the prospects in the Coast Counties never looked brighter.

No one in future will be able to say they could not get a combination and then feel sore because they were turned down. The primary election law gives everybody a square deal, and no matter what office a person may aspire for he can circulate a petition and thereby have his name placed on the primary ballots. It is free and open for anybody to participate who wish. It will be a straight party vote, and instead of

a convention nominating a party ticket as heretofore, the voters who register in time will do so, and the person receiving the highest number of votes for each office will become the candidate. It is going to be interesting to know whether those who take part in this primary election will support the candidates when it comes to the election. Here is a good opportunity for the republicans in Tillamook county to drop their foolish factional fights and support the party's nominees. They ought to do it if they think anything of party principles. It entirely rests with the republicans themselves whether they want to win at the coming election or whether they will court defeat again. It will be a straight party vote at the primaries, and it should be a straight party vote at the election if the republicans think anything of their party. The democratic "knockers" will as usual circulate all manner of political lies about prospective republican candidates, for they know it is only by causing dissension in the republican party that they can expect to win.

For several years it has been the unpleasant duty of the Headlight man to buck up against those who violate the law and the professional "grafters," and in doing so we expected and have met with the vindictive opposition of that class, and it is only in recent years that public sentiment was aroused and the people lined up and took a decided stand on this important and far-reaching question—the enforcement of the law in this city and county. The Headlight, true to its constituents and the best interests of the people and county, had but one plank to walk and advocate. True we succeeded in arousing public interest, yet for all that the agitation must go on account of the violators of the law being so daring and determined to violate the law, as they are doing repeatedly in Tillamook City. We have repeatedly stated that when the laws are enforced it adds money to the city's or county's treasury, and when they are not it is the taxpayers who have to go down in their jeans. Tillamook County could and should have had several thousand dollars added to its treasury had the peace officers done their sworn duty, so it is not surprising that a large number of taxpayers are wanting the sheriff's salary reduced as a consequence of this non-enforcement of the law. The gambling "grafters" could not carry on their games if the laws were enforced the same as sheriffs in some of the other counties are raiding the "grafters' joints, but no one ever heard of anything like that in Tillamook county. There is another course open. But it is not to criticize the judiciary or the district attorney, but to relate a few facts. Whenever the gamblers were arrested and were in a tight place, they would plead guilty and get a light sentence, and laugh at the easy manner in which they got off and then start in right off and carried on their games. As a light sentence seems to have but little effect it is to be hoped that when the next batch of gambling "grafters" and violators of the law are bagged, the district attorney will advise and the bench will coincide in imposing a penalty which will send the violators of the law to prison. We do not like to advise such a thing, but it is simply like this, there are a few persons who are so daring and determined to violate the law, nothing short of sending them to jail will make them respect the laws of the country.
