

Editorial Snap Shots.

Pity the sorrows and the troubles of the office seekers.

Watch the grass grow and the milk flow in Tillamook county.

The railroad situation looks good now that Lytle has got the "dough." And as to what the Wilsey people are doing remains a secret, but we hope they have got the "dough" as well.

A person writing from the south part of the county says that if the Nestucca toll roads are leased for five years he will leave the county and that some of his neighbors will do the same.

From present indications it looks as though H. M. Cake is going to land the senatorial cake with a good rousing majority at the primary election. That Mr. Cake is a clean, capable man, and in every way fitted for the position, everybody must readily admit.

The Headlight man wonders whether he will ever be forgiven for committing such a grievous crime advocating a vote to be taken on the toll road question. We certainly must be a terrible bad man for doing that in this bottled up neck of the woods, which needs opening up.

The democrats of this county extend a pressing invitation to the republicans to get into a factional fight, for this is what the democrats are figuring upon to get elected. But there is not going to be a factional fight, but a clean cut issue and a clean sweep for the republicans.

The city council "fired" the city marshal on Monday. If some of the previous city councils had done the same thing the city would not be in the financial pickle it is now in. So it is about time that the city affairs should be run in the interest of the city and not in the interest of a few individuals.

The brethren of the Masonic fraternity attended service on Sunday and listened to an excellent sermon on "Charity," but it seems to have made very little impression on some of them, for two days later, to the surprise of everybody, one brother was publishing libelous matter about other brothers and besmirching their good characters and reputation. So much for Masonic charity in Tillamook when the brethren are so untruthful and uncharitable one to another.

Pendleton added a big "wad" to its city treasury a few days ago. The mayor had the saloons raided and a little army of gamblers were run in, and the next day they were all fined, the players and the gamblers, from \$25 to \$72 each, and the few who managed to get away in the big round up, immediately left town. Wouldn't it jar everybody if the officials did anything like that in Tillamook so as to help the city out financially? We may be all surprised one of these days.

H. M. Cake, who is a candidate for nomination on the republican ticket for United States senator, so we are reliably informed, will land the nomination with a big majority. This is not surprising news, for it was generally conceded that when Mr. Cake announced himself a candidate that he would receive the hearty support of a large number of friends all over the state. It is the character of the man and his clean record that is bringing him so prominently into prominence, for this is an age when the people are looking for men of honest integrity and who are clean. Such is H. M. Cake, and the people of Tillamook will never regret casting their vote for him. We predict that he will land the nomination with a good big majority, and it will be big enough to convince the state legislature that he is decidedly the choice of the people.

The three republican candidates for county judge, H. P. Goodspeed, W. T. West and J. S. Stephens, all think, of course, that they are going to land the nomination. But they cannot all do so. Each will be able to get a certain number of votes at the primary election, for all of them have a number of supporters. From what we can gather from the trend of opinion in the precincts in the center of the county Goodspeed appears to be a long way in the lead, but as to the other precincts we are not in a position to say, although it is said that Mr. Stephens has quite a following in the neighborhood of Beaver, but it will be found on election day Mr. West will have quite a following in the south part of the county. It was the republicans in Fairview and Bay precincts who centered upon Goodspeed which gives him an advantage in the race for county judge.

We understand that a number of the county clerks in other counties have refused to have anything to do with taking land office proofs in their offices, consequently everyone has to go to the land office with their witnesses. It is to be hoped that the county clerk of Tillamook won't do likewise, for by his consenting to take proofs it is saving at least of \$100 for those who prove up on a homestead or a timber claim. It seems that the land office is now so particular that the county clerks do not care about taking the responsibility, and as there is but little in it for the work required, they have refused to have anything more to do with it. Still for all that, for the convenience of the people of this county, it is to be hoped that County Clerk Lamb

will consent to take land office proofs, for it would be a wasteful expense of money and time for those who would have to go to Portland.

The republicans who are running for office are carrying on their campaigns in a friendly spirit, and there appears to be a most friendly spirit existing amongst them, notwithstanding the fact that the democratic "push" has started in to besmirch republicans who are up for office and who are running a clean campaign. Most every republican can see that this is another attempt to bring about another factional fight in the party, but it will meet with failure, for it is plain, with a very few exceptions, that republicans are opposed to a factional fight in the coming election. The Headlight has done nothing, and will not do anything to create discord. It is up to the republicans to nominate good men, men whom they can trust, to conduct the business of the county, but should they elect the wrong men, it generally revolves itself around to this, the taxpayers have to pay the fiddle for all kinds of deals and tricks.

We have been asked several times who will land the nomination in the republican party for sheriff. We are free to admit that it is a little difficult to make a forecast. One thing we do know, that no matter who gets the nomination, the defeated candidates are going to get in and help elect him. This appears to be an understanding the aspirants came to amongst themselves, and it is the proper and most upright way for any person to play politics. Henry Crenshaw, Henry Leach, C. S. Atkinson and L. M. Alley are all good men for the position, but at present it looks as though the race was between Crenshaw and Leach. As there are so many republicans who are friends of both of them, it is hard to tell who will get this vote and win out in the primary election. Alley is sure of getting a good vote in the north part of the county, which gives him an advantage and a good start, and the same may be said of Atkinson in the other end of the county, but, unfortunately, for him he is not so well known in the county.

It will be noticed that Tillamook has lost another suit in the persecution—not prosecution—of Mrs. Alderman. As long as the county court will allow the bills and the taxpayers have to foot the bills this persecution will go on. This is the third suit the county has lost and had to pay the cost out of the taxes and the attempt to remove Mrs. Alderman as administratrix of the estate was only another case of persecution, which was frustrated by an injunction, and when this comes on to be heard the people of this county will have an opportunity to hear for themselves the pettifoggery manner in which the matter of recovering Alderman's is proceeding. People are about disgusted, and they have a right to be under the circumstances. Well, as long as the taxpayers have to pay the cost, this persecution will go on. It was the same kind of persecution in the case that was brought against Homer Mason by the county judge and the attorneys he employed to do the work of the district attorney and sheriff.

Washington County officials did not show a very magnanimous spirit toward Tillamook County when it leased and made a toll road of the Wilson River road between Gales creek and the county line. That is another successful move to keep Tillamook County bottled up in its present bottled up condition, despite the fact that the people of Forest Grove are opposed to the road being leased. Finding that the gig was all up fleeing the traveling public over that road in this county, a raid was made on the Washington county court to offset the opposition to the toll roads in Tillamook county. It looks as though, in considering the matter of toll roads, the people's wishes are entirely ignored and they have no voice in the matter whatever. At a time when there is such a demand for good roads it is surprising that the people have to submit to such an antiquated method. The real reason that Tillamook County is bottled up with toll roads is because some people have a good thing grating the traveling public, which, probably, the Washington county officials did not take into consideration. However, it is as much a black eye to Forest Grove as it is to Tillamook, for it will hoodoo the proposition to turn the Wilson river road into a road district so that a good road can be built between Tillamook City and Forest Grove.

So as to give the citizens an opportunity to have a voice in the matter of leasing the Nestucca toll roads, the question should be submitted to a vote of the people, which can be done either at the primary or general election in June without any additional cost to the county. This is the right and proper course to pursue, in fact, it is the only way, and whatever is the verdict of the citizens, let that prevail. To bring the matter to an issue, and so that there should be no misunderstanding, we have addressed the following communication to County Judge W. W. Under and similar letters to Commissioners G. W. Bodyfelt and G. Loerabel.

In view of the fact that a large number of citizens are opposed to the Board of County Commissioners leasing the Nestucca toll roads for five years, and to allow the citizens an opportunity to decide the question by a direct vote of the people, will you consent to defer the mat-

ter of leasing the Nestucca toll roads until a vote is taken at the primary election in April or at the general election in June, whichever you think is best; and as County Judge will you agree to order an election for that purpose? Should, however, a majority of the citizens be opposed to leasing the toll roads, and other toll roads, would you, in your official capacity, abide by the majority vote of the people? An early answer, for publication, will greatly oblige."

Here is a clean, square cut issue that the citizens should decide, and no matter what the verdict of the people may be, let the majority rule.

The first to reply was Commissioner Bodyfelt, and this is what he says:

TO THE EDITOR TILLAMOOK HEADLIGHT.
DEAR SIR,—Of course I am in favor of the legal voters deciding the matter in regard to the toll roads. We have not leased it yet, and do not know that we will or not. I will agree to ordering an election to that effect if it comes up properly. I am for free roads when we can get them, but as road districts Nos. 5 and 6 have only about \$1,500.00 a piece, I do not see where the money is coming from to make them good roads. To take on about 22 miles or more roads, with all that we have now, I tell you it looks gloomy at best. The bridges will have to be rebuilt this summer on both roads or the travel will have to go back to the old trouble of fording again.

So, Mr. Baker, please show up both sides to the question. But if the voters say free roads, I would most willingly abide their wishes. Yours for prosperity and good roads.

One of the campaign slogans of S. B. Huston, of Hillsboro, for congress, is that he is the only man who stands for Roosevelt's fair policy and control of corporations.

Walter L. Tooze makes that the twelve words he wants printed on the ballot with his name: "Will support Roosevelt's plan for control and regulation of railroad rates."

Coming into the republican party on the gold standard, an issue that is forever settled, Mr. Huston naturally wants to get some catchy issue to conceal the paucity of his republican record.

The fact is Mr. Tooze has boldly heven out his own platform, and has covered all the important issues, and does not budge his chances of success on any hobby or one-plant platform.

No one is supplying him with ideas or with campaign funds or campaign management. He is making his own campaign direct to the people. He will have reached every voter of every party before April 20th.

So aggressive and fearless and independent a man naturally draws the fire of the opposition. He has been the target for abuse and misrepresentation, and has never retaliated.

All kinds of campaign tricks will be tried by the federal machine and the gunshoe brigade to defeat Walter L. Tooze for the nomination, but they will not succeed. The people are back of his candidacy.

The report is being scattered broadcast by the Huston and Hawley followers that W. L. Tooze is going to withdraw in favor of Huston or Hawley is both absurd and unjust to Mr. Tooze.

It is all the more foolish when the nomination and election of Mr. Tooze is almost a certainty.

There may be some reasons for Huston and Hawley withdrawing, but no reason for the only republican candidate to pull out of the race.

The prospects for Mr. Tooze's nomination and election grow brighter every day, and loyal support is being pledged from all quarters. This thread-bare trick won't work.

The camp following politicians who have no convictions, but a desire to get their name as well give up the shallow tricks. Let them point out a weak spot in Mr. Tooze's platform, a break in his armor of Republicanism.
