Doing Good for Oregon.

Nearly every clover field or field of vetches in the Willamette Valley is a living monument testifying to the efficient work of Dr. James Withycombe for the advancement of the agricultural industry in this state. It is true that a very few farmers raised clover in Oregon before Dr. Withycombe's aggressive work began, but it was the generally accepted theory that Western Oregon was not suited to production of that crop. Farmers had raised wheat on their farms year after year until the productiveness of the soil had been nearly exhausted. Then they adopted the scheme of bare Summer fallowing, thus losing one crop every two or three years, without permanently improving the condition of the soil. On the contrary, bare Summer fallowing permitted the loss of some of the soil constituents that are necessary for the production of good crops.

It was Dr. Withycombe who began the agitation which has resulted in the general adoption of the plan of rotation of crops in Western Oregon, in which plan the growing of clover and vetches is included. Dr. Withycombe hammered away in season and out of season, urging the necessity for raising clover, which will supply nitrogen to the soil. One by one the farmers came to his way of thinking, and today every traveler upon the railroads in the Willamette Valley looks out upon rich fields of clover that not only furnish unsurpassed food for dairy cattle, but preserve the fertility of the soil. Whether Dr. Withycombe shall be elected Governor or not, he will always be remembered by the farmers of Oregon as one of their greatest benefactors—a man who worked tireless for what he knew to be best until he made it win.—Oregonian.

A Great, Saloonless City.

The San Francisco Chronicle said last week: "San Francisco for the past fortnight has been absolutely free from disorder and virtually free from crimes of violence. There have been no street brawls. No drunken brute has beaten his wife. No gamblers have murdered each other in low resorts. Except with some dealings with sneak thieves, the occupation of the police courts is gone. It is a most impressive object lesson of the value to society of the restriction of the liquor traffic. We are promised a continuance of this peaceful condition for a considerable time to come, save only as drunken men may drift over from Oakland, where the authorities have been so reckless as to allow saloons to open. We may be compelled to renew the quarantine against Oakland."

Such a statement, coming from such a source, is significant. In its period of terrible affliction, the city of San Francisco not only got along without saloons, but would tolerate none. Possibly some children will live to see great American cities, even if not stricken with calamity, "free from disorder and crimes of violence, where there will be no street brawls"; where for a fortnight "no drunken brute has beaten his wife"; where "gamblers have not murdered each other in low resorts"—all of which, and much more, more than can be told or even more than hinted at in print, is due to the liquor traffic, to the saloons.

Saloons are generally recognized as an evil, and it is said they are a necessary evil. It seems from this statement in the San Francisco Chronicle that for a fortnight they were not a necessary evil even in that great and hitherto wicked city. There is a large suggestion in this fact.—Oregon Journal.

Open Letter.

To the voters of Oregon, Greeting: Gentlemen: The undersigned submit to you a few of our reasons for asking you to ratify, by your affirmative votes, the Amendment granting equal rights to women, which has been placed before the voters through a petition numerously signed by the men of Oregon under the initiative and referendum.

This movement has grown under your management from the small beginning known as the Married Woman's Sole Trader Bill, enacted by your Legislative Assembly in 1872, until it has reached such vast proportions as to attract the attention of the civilized world. A Constitutional Amendment proposing women's enfranchisement, submitted to you in 1884, brought us an affirmative vote of 11,223. This Amendment was again submitted to your suffrages by Legislative initiative in 1900, bringing us a vote of 26,265. Although the population of the commercial centers had more than doubled in sixteen years, the "No" vote was only increased by 226, while the "Yes" vote was augmented by 15,042. This, to us, is a palpable augury of the triumph which we confidently look to you to consummate for us on the 4th day of June by placing "X" between "302" and "Yes" on your ballots. Do this and you will honor our flag of truth, the only power we can offer in our defense against the balloted forces of the opposition. Do this and you will honor Oregon, your mothers and yourselves.

For a man to receive the nomination of representative bound by these principles, is a sufficient guarantee that the interest of the producing class will be his guiding motive, first, last, and all the time, that a county judge and commissioners would handle the toll road and all other questions subject to the will of the people and that other offices would be conscientiously administered.
