DOLPH KNOCKED OUT

for the Recount is Set for Next Tuesday.

Treasurer P. W. Todd, who was defeated by Carl Haberbach, republican candidate, by the margin of 7 votes, has petitioned for a recount, and Circuit Judge Gallo will set next Tuesday for the recount to be made. Thayer & Johnson attorneys for Mr. Todd, who in his petition claims that the judges and election counted votes for Haberbach should have been counted and who committed other errors; illegal voting was carried on; and the precinct should be thrown out for the reason, it is alleged, that L. S. Thayer, who was one of the judges of the precinct, was a resident of Yamhill county, Oregon, and not Tillamook County. Attorney T. Botts will represent Haberbach.

Writing from Oakland, Cal., on June 17th, to her uncle and aunt, Miss Tillie Anderson gives some interesting experiences of the earthquakes in California; Well, last night about ten we had another pretty good hard shake. I tell you we turned pale and I almost started to run out as it stopped. But we could hear the rumbling and roar for a long time before it shook. It is a good warning, and one could run out before the shake if one would only have presence of mind. To-day is Sunday, and we have been home all day, as it is so hot out in the sun one could almost melt.

I tell you the city looks awful. I wish you could see such destruction, the half has never been told, and cannot be imagined unless seen. Now it looks like some new mining camp, with one story buildings everywhere among the ruins, where they can hardly be seen for piles and piles of brick and bent iron. But it is a shame the way they deal out the food and clothing sent to the refugees. It never reaches them the way it is intended. The Hearst Relief Committee has done more good than all the others put together. All the people in his camps are treated lovely, and he deserves praise.

When we heard that Oregon had sent so much cheese, we would like to have had some of it, but I don't think it ever went into circulation. Some merchants will speculate on it, as they were trying to do with the flour. I have a portion of coffee given out in the city. They handed me out about three tablespoons full, and said that had to last one week for five people. It is an outrage the way they treat people that go for food. I kept the coffee and will always carry it with me as a relic of the time I stood in the bread line in San Francisco. An experience worth a great deal to us all, and one we are not apt to meet with again. I don't mind the experience of standing in line, but I hope and pray that I may never again feel the earth shake again as it did then. Of course, we thought that the world was coming to an end. Never dreamed but that any minute the earth would open and swallow us up. Such feelings as one went through can never be described: Women and men screaming and dogs barking, and the angry world trembling.

But of course one is as much in danger any place as here, so there would be no use in running away from it. We might run into worse.

The Canadian minister of agriculture has issued a statement concerning the results of government aid to the creamery industry. The system seems to have been wonderfully successful and most beneficial to both country and individual. The plan, which was begun about ten years ago, was for the government to give financial assistance to creameries, assume the management, provide proper equipment, and manufacture the butter for the patrons at a charge of 4 cents a pound. One cent additional was charged as a reserve fund for the repayment of the loan, and 2 cents more for any debts that may have been upon the plant. The government paid annually for rents and use of the premises a sum not exceeding 7 per cent of their value. When the loan or advance was repaid the creamery was turned over to the owners, usually a joint stock company. As a result, the debts have been paid-off, new buildings erected, new and first-class equipment installed, and a thriving industry moulded out of what was a few years ago a practically defunct and bankrupt business. The returns from the creameries are making the foundations of the country's present prosperity.—Homestead.
