He was greatly pleased with the location and intends erecting a factory of 35,000 pounds capacity per day. He was wanting a site free, but as this was out of the question at present, he was willing to have free water for five years. At a meeting of the Tillamook water commission and exclusive committee of the Tillamook Development League on Monday night, it was decided to give Mr. Fredenhagen free water for three years provided he erected his factory according to agreement.

"SQUEALING!"
Law Breakers in Same Class as the Ex-Convict.
The recent raids on gambling joints and the round up of those who have been violating the local option law was the cause of considerable discussion, not only in this city, but all over the county as well, and Sheriff Crenshaw and Deputy District Attorney Cooper are generally commended for the round up and bringing the law breakers to the bar of justice. There are, however, those who are complaining because it turned out that the star witness in the cases, J. C. McNamara, was an ex-convict. This the officials did not know when he informed them who were the law breakers, but it is plain to see that it is the old saloon faction that is trying to make mountains out of this little incident. What McNamara has testified to on the stand was the truth, and this is what made the law breakers squirm.
It depended greatly upon whose ox was gored. As long as McNamara had money to blow in, the law breakers were glad to sell him booze and take his money, and he was such a fine fellow he was able to work his way, by secret knocks, into "Jilly" Stephens' gambling joint. He was considered a prince and fine fellow as long as he had money to blow in. It is reported that W. O. Chase considered him a fine, gentlemanly fellow, who took him to his home and there started up a twenty-one game, so as to get his money, and even furnished him with wine. Yes, the gamblers, bootleggers and whiskey sellers opened their gambling joints, "blind pigs" and homes to this ex-convict so as to "graft" onto his money, and as long as they were doing that McNamara was one of the best of citizens and they praised him as a fine fellow. All this was while the law breakers were working a "graft" upon him, but instead of this their ex-convict remaining docile while they kept up the "grafting" process, he turned the tables upon them. When this was discovered the gamblers, bootleggers and whiskey sellers commenced to howl, and they have not stopped howling yet. They have threatened his life, tried to frighten out and their attorneys have abused him in open court. But somehow this ex-convict cannot be bluffed out. All this, however goes to prove the guilt of the law breakers, and shows up perfectly clear that it is a case of whose ox is being gored, for he was a fine fellow in the estimation of the law breakers when he had money to blow in, and would have remained a fine fellow, no doubt, only that he was squealed, like one of the bootleggers, on the stand. The public knows the rest. Sheriff Crenshaw

obtained an opening, which he had been looking for for a long time and he pulled them up so suddenly that it came as a surprise to them, and although the law breakers may howl like blazes about the ex-convict, the general verdict of the citizens of Tillamook county will be that the law breaker are in exactly the same class as the ex-convict and that they were birds of a feather until the squealing commenced. The law breakers are no better and are no worse than the ex-convict.
In the jury case where Delaney Ellison was charged with violating the local option law, Ellison admitted selling the beer to J. C. McNamara, but "squealed" on J. P. Allen, of whom he said he obtained four bottles, paying him \$1 for five. The jury was unable to agree, five being for conviction and one (Pinkey Stillwell) for acquittal. Ellison is again on trial Friday morning.
Tom Browne and Frank Buttz were each found guilty for violating the local option law and Justice White fined each of them \$100. Their attorneys appealed the cases to the circuit court.
T. B. Turney, who has been in the business for a long time, from whom the boys obtained whiskey, pleaded guilty and was fined \$50. It was reported to us some time ago that the boys raided a number of hen roosts in the east part of town and took their plunder down to Turney and he put them in the pot and boiled them.
The case against Nick Job was dismissed.
