Ex-City Marshal E. A. Edwards' house was broken into Monday night and \$70 stolen from Mr. Edwards' pockets. He had been nursing his wife, who is quite sick, and having lost a good deal of sleep, laid down on the bed late at night and went to sleep for two hours. When he awoke he went to his pants pockets for a chew of tobacco, which was hanging behind the door, when he found that his waist of \$70 had disappeared. It was his intention to have put it in the bank the previous day but was not down town.

The tug Geo. R. Vosburg has been put into commission again, and will tow for the Miami Lumber Company, which is the name of the company which bought the saw mill at Hobsonville, who have three lumber schooners of their own which will carry lumber from here to San Francisco. Captain Dodge is in command of the Vosburg, and while outside towing in one of the schooners, the Queen, on Sunday, the cable broke, and the weather being rough he had to leave her and the captain brought the tug to this city in the evening. The tug was outside today, but unable to find the schooner.

Another serious defect in the building of the new court house, and which might have caused a most serious accident, was discovered in the sheriff's office Monday. The chimney from the boiler in the basement runs through the sheriff's office, and this had cracked on two sides about a quarter of an inch and began bulging out, and with the heavy weight above, it was thought that the entire chimney might crash down through the building. To prevent this, four heavy bands were made and the chimney drawn partly together again, holes having to be cut through the wall into the prison to get the iron bars through which were used to keep the chimney intact.

Over a large portion of the central part of the state the annual rainfall is less than 10 inches, while in Tillamook county, on west slope of the coast range

at an elevation of a little over 1,000 feet, the annual rainfall is over 130 inches. Another section with large rainfall extends along the west slope of the Cascades mountains, beginning in Multnomah county and running south nearly to Marion county. There the rainfall amounts to slightly over 90 inches annually. There is also a small area in the northwestern portion of Curry county where the precipitation amounts to a little over 90 inches. Over the greater portion of the Willamette valley the rainfall is less than 50 inches, and in southern Oregon it is less than 35 inches being only 20 inches at Astland, which is in a prominent fruitgrowing section of the state.

Bills Introduced by Beals.

Besides the bill to ascertain the amount of timber on each quarter section Representative Beals introduced the following bills:

For protection of salmon in Tillamook Bay and its tributaries, closed season March 20th to July 15th and from March 20th to December 10th, above specified points in Main river, Kilchis, Wilson, Trask, Tillamook.

For cheese and dairy inspector of Tillamook County, appointed by the State Dairy Commissioner; salary \$1500 a year, and appropriating \$3000 annually.

To compel all corporations to list their property with the county assessor of that amount of taxes can be secured. A repeal act.

To require license by domestic and foreign corporations doing business in the state.

For the paying of 10 per cent of all fees from the sale of spirits, malted and otherwise, to the state treasurer.

For the increase of poll tax from \$3 to \$4 per annum.

Tillamook City is getting safe and sane on the question of the enforcement of the law. Good. The spirit of progress is in the air.

Chapter I.—Is there any truth in the report that there was a \$10,000 graft in the construction of the city water system?

The lawbreakers say they can't get justice any more in Tillamook. This is really too bad, for it is now more difficult to get men to hold up juries.

Bill Smith is an object of pity and compassion, for it is generally known that he has not been right in his upper crust. Please don't laugh at his ravings.

We wish to call the attention of the taxpayers to this fact, that Sheriff Crenshaw will not put in bills and draw down double pay for making arrests, the same as his democratic predecessor had done.

Sheriff Crenshaw made another raid this week. He found out that Rollie was going to publish some libelous matter about him, and swooped down on the office and made Oak Nolan and Rollie "craw fish."

Rollie W. Watson, who wanted to be mayor; Bill Smith, who wanted to be county surveyor; and Oak Nolan, who wanted to be county judge, all of whom were turned down and repudiated by the people, makes a trinity of blackmail, insanity and bombast.

When the local option law was voted into effect in Tillamook county the attorney for the saloon keepers was going to knock it to smithereens on technicalities. It turned out to be a fizzle, for the technicalities were only raised to defeat the will of the people. New technicalities are now to be raised with a view to clearing some of those who were found guilty of violating this law. It is time that we had more justice and less technicalities and quibbling in our justice and circuit courts.

From a broad gauge point of view the recent round up of law breakers in Tillamook City, those who gave Sheriff Crenshaw their moral and financial support, are deserving of a word of commendation in their effort to make this a clean, respectable and law abiding city where citizens can do their trading. The law abiding citizens, who are for the enforcement of the law, are the friends of Tillamook City, while, on the other hand, those who have been constantly violating the law are the opposite.

The Oregon Mist, heretofore a republican newspaper at St. Helens, announces that it will be independent in local politics in future. An independent news paper may sound good, and as there is a tendency amongst editors to be more independent, but still for all that the reading public prefer a newspaper, no matter what its politics, that is on one side of the fence or the other. Some persons think that the country newspapers ought to cut politics out, yet we notice this that when an election comes round they admire a strong party newspaper and have no use for independent sheets without any backbone.

It is not necessary for the Headlight to jump in and defend the characters of M. W. Harrison, H. T. Botts, F. R. Beals, A. W. Severance, Geo. B. Lamb, Henry Crenshaw, Chester Holden, T. H. Goynes, Alva Finley, Carl Haberlach, W. W. Wiley, and others whom Rollie Watson, Oak Nolan and "Bell-Wether Smith" are trying to belittle and besmirch. All we ask the public to do is to size up the characters and reputations of the former citizens and compare it with the characters and reputations of three latter, and ask the citizens which stand the highest in the estimation of the public, and which they would trust with their money and the conduct of county and city affairs. Let the public be the judge and the jury in this matter.

The reason why Rollie has undertaken to "roast" County Clerk Lamb is because the latter has quit him. Mr. Lamb had treated Rollie fair, putting many a dollar into his pocket. But without any reason whatever, and when Rollie and Oak Nolan were foolish enough to believe they could run the republican party, Rollie jumped in and singled out and discriminated against Mr. Lamb, and published a lot of matter which he had to apologize for afterwards. It was Mr. Lamb who was then discriminated against. Now it is Rollie. It depends,

as we have previously said, whose ox is being gored. Rollie "roasted" a friend when there was no occasion to do so, for Mr. Lamb had made a good public servant, and, like a good many other persons who cannot stand Rollie's bombast, dropped him cold.

In the state legislature on Tuesday Fred W. Mulkey was elected U. S. Senator for the short term and Jonathan Bourne, Jr. for the long term. If Senator Bourne is as active and energetic for the state as he was in securing the nomination he ought to make a good Senator for Oregon.

Representative Beals is going to turn out a good legislator, for his bill to ascertain the amount of timber on each 1/4 section is a move in the right direction. The bill might be improved in this respect, that whenever there is a doubt as to the accuracy of the amount of timber on any quarter section, the assessor ought to be empowered to employ a reliable cruiser. There is no doubt but what the correct way would be for the county to have the timber cruised, but as this would entail considerable time and a large outlay of money, we think, when everything is taken into consideration, that Representative Beals' bill will accomplish what is desired if the timber owners will give a correct estimate of the amount of timber there is on their land, the same as the farmers and dairymen have to give in of the improvements and stock upon their places.

It is opposed to compromising taxes, such as the back taxes on the sawmill, whereby the county was banded out of several thousand dollars, while the poor man, if he failed to pay his taxes, had his property sold at Sheriff's sale.
