Sudden Death at the Fair.

Quite a little excitement was caused at the noon hour on Friday, when the streets were thronged with people attending the fair. A. S. Ayer was talking to his youngest son, Earl, on the sidewalk, when he suddenly fell dead where he stood. The cause of death was called, but could do nothing for the unfortunate man, for life was extinct. Coroner Reynolds had the body removed to his undertaker's establishment, but did not think it advisable to hold an inquest, heart failure being the cause of death. The deceased was 59 years of age, being born in Vermont on the 6th April, 1848. He married Miss Mary Jane Smith, who died 22 years ago, leaving two sons, Forrest and Earl. He went to California some 20 years ago, and since then has been in most of the Western states, coming to Tillamook in 1900 with his sons and located at Blaine. He was a Mason 30 years, and the members of the lodge in this city took charge of the funeral arrangements, the burial being in the Oddfellows' cemetery on Sunday, the religious service being conducted by Rev. D. L. Shirude, pastor of the M. E. church. Mr. Ayer was a man who was well respected, and his sudden death came as a great shock to his sons, who have the sympathy of the community in their bereavement.

Dairy Dots.

In Belgium all cows over three months old are to be seen wearing earrings. Breeders are obliged to keep a record of all cattle raised by them, and each animal has a registered trade number, which is engraved on the ring fastened to its ear.

Milk-giving is a bred-in-the-bone characteristic and a matter of slow breeding that. Keep the good milk and keep her female calves.

Don't expect to have good milkers and good beef cows in the same herd. If you want milk it will not pay to feed beef cows twelve or fifteen years in order to have a big old cow to sell. Old cows do not sell for high prices at any time.
