As usual, when it comes to defining law, the lawyers are all at sea, another instance of this is seen how they interpret what can and what cannot be done during this holiday season.

Read the editorial, "What Kind of Appeal," from the Oregonian, which appears on another page, for it shows that people lost their head and their reason when they withdrew their money from the banks.

We can't see why the city caucus should be a "lively affair," unless someone is on the scrap. It is more likely to be a tame affair. It may be a new class of bosses are about to make the attempt to run the city.

It is impossible to make people believe that the country can go from a condition of great prosperity down to bedrock in a few days, and at a time when they have more money in their jeans and in the banks than they ever had before.

Some of our citizens are objecting to poor Old Bossy running at large within the city limits. And Old Bossy is the main stay and support of the city and county, for what would Tillamook City amount to if it wasn't for Old Bossy?

It begins to look as though the term of the circuit court will have to go over until April on account of Governor Chamberlain's bugaboo holiday proclamations, for the circuit judge cannot be in two or three places at the same time.

We extend our sympathies to the attorneys on account of being "held up" by the governor, but then it is a genuine democratic, scare-crow "hold up," anyway. Having made one blunder, the governor keeps on blundering day after day.

We are in favor of government savings banks and the parcels post, and may be a convert to government ownership of railroads if the railroad make people pay big rates on watered stock and if Oregon is to be bottled up by Harriman much longer.

We don't see that the democratic attorneys have any cause to roast the governor. They are getting precisely what they voted for—their business held up and cut off at the pockets. So, why get tired, gentlemen, occupying a prominent seat in George's band wagon?

Governor Chamberlain is still "holding up" the courts by his calamite holiday proclamations, and no matter how important it may be to the state and to litigants, our saarercrow governor is using the power given him to "hold up" the courts in the interest of the banks.

After every financial crisis, then follows a season when bank officials blow out their brains or take their lives in some other way. Last week several bankers, who were simply gamblers and gamblers with depositors money, took a short cut to avoid their disgrace by ending their lives.

It is no uncommon thing for people to lose their heads and not vote intelligently at elections, but when it comes to bank depositors losing their heads because someone has said "Booh!" why, that is no reason why they should get excited and draw their money out of the banks.

The governor has not only "held up" the courts but has "held up" the pay of those who have claims against the county, thus keeping a large sum of money out of circulation. We, in this neck of the woods, will be glad when the governor gets tired scaring people looking through his calamity goggles.

We are glad to see that the Tillamook High School has entered the Oregon High School Debating League. With perseverance and persistent effort there is no reason why our high school should not stand well in these debates, even though the high school pupils are somewhat handicapped by not having access to valuable libraries.

Tillamook county has a statu quo appearance and feeling since the exodus of railroad men commenced, with others since joining in the procession, for there was but scant hope of finding profitable employment the coming winter with the railroad work and saw mills closed down. However, it gave us all a slight foretaste of the lively times which must

come soon, and to stay.

By stopping work on the railroad, it is going to delay the development of the county at least another twelve months. It is somewhat of a disappointment to a number of persons, but most people in this isolated neck of the woods have been schooled well in the virtue of patience, knocking up against so many transportation difficulties and disappointments. So it is useless for us to counsel patience to Tillamookers, who possess that virtue already.

The county has about \$12,000 less outstanding indebtedness than a year ago. Let the good work go on and get the county out of debt as soon as possible, for had the county officials in years gone by kept within the income, there would be no need of their taxpayers having to pay several thousands of dollars interest every year and an indebtedness of some thing like \$51,845.82 staring them in the face, and which will have to be paid at some time.

Considering that a railroad was being built, bringing a class of men who are prone to acts of lawlessness, it is gratifying to know that Tillamook county has been exceptionally free from crime this year, with no one incarcerated in the county jail since Arsttil, the bank check forger occupied it and was sent to the state penitentiary last spring. It must be that the local option law had some thing to do with this satisfactory state of affairs, and is proving itself to be an economic measure as well, for the taxpayers are not boarding prisoners nor paying large sums of money to prosecute them.

The city cows, and likewise the city chicken, are to be a bone of contention at the city election, because there are a number of our citizens who want to see them kept up, but they have not gone far enough, for dogs and cats should be included in the ordinance also, especially as the dogs have become so numerous and a nuisance barking at all hours of the night. Whether Tillamook City has grown to that municipal importance to prohibit the running at large of chicken and cows, that is for the citizens and not for us to decide. True it is that cows running at large in a city are to some extent a nuisance, especially in the business streets, but this much can be said in behalf of the city bovines, they keep the grass down all over the city, and do good that way. But, as we said before, if the citizens want the cows and chicken kept up, so also keep up the dogs and cats, for it will help to abate another nuisance—the flea nuisance—and lousy dogs running at large. One thing we do know, that by being allowed to keep cows, a number of poor persons in this city in past years, have found it a great help to them in making a living.

Some malicious, evil disposed persons have been circulating reports that the Tillamook County Bank had closed, writing to people in the country to that effect and advising them not to take any checks on that bank. Reports of this character have reached us for several weeks, and even the false reports had reached the Portland newspaper offices, so busy had the preparators of the truth become in their efforts to besmirch the Tillamook County Bank. We can say to every depositor in that institution that if every bank in the country was as safe and conservatively conducted as the Tillamook County Bank there would be no bank failures nor would depositors lose one cent. The efforts of the evil disposed persons did not succeed, because the people of the county and the depositors and business men had implicit confidence in Mr. M. W. Harrison, president and cashier of the bank. Mr. Harrison is just as careful and conservative in running the bank as he was in running his farm, and the people know this, and they know also that he is no flighty speculator, is not in the bonus business, has not been addicted to gambling in stocks or the gambling table, has paid every person he owed one hundred cents on the dollar all the years he has been in the county, has never been mixed up with shady schemes to fleece the people, and he and the directors of the bank are ready to place their private fortunes at the back of the bank, which is not necessary, for we can assure our readers that the Tillamook County Bank is in fine shape, and always has been in fine shape and doing a fine business along safe business lines. Some few persons at first did get a little uneasy on account of the malicious falsehoods, but it did not take them long to see that it was a prearranged scheme to besmirch the County Bank at a time when people were a little excited. Here we have another striking object lesson of the malicious spirit of some persons in this city, whose object is to pull down and do up successful institutions like the County Bank and respectable, honest citizens like Mr. Harrison. We are glad to say that the people look upon the local situation in this way also, and appear to have a pretty correct idea by whom and the source where the malicious lies were concocted.

President Scouts Panic Scare.

"The White House, Washington, D. C., Nov. 17, 1907.—My Dear Mr. Cortelyou: I have considered your proposal. I approve the issue of the fifty millions of Panama bonds which will be immediately available as the basis for additional currency. I also approve the issue of \$100,000,000, or so much as you may find necessary, of \$50 3 per cent interest-bearing Government notes, the proceeds of the sale of which can be at once deposited by you where the greatest need exists, and especially in the West and South, where the crops have to be moved. I have assurance that the leaders of Congress are considering a currency bill which will meet in permanent fashion the needs of the situation, and which I believe will be passed at an early date after Congress convenes two weeks hence.

"What is most needed just now is that our citizens should realize how fundamentally sound business conditions in this country are and how absurd it is to permit themselves to get into a panic and create stringency by hoarding their savings instead of trusting perfectly sound banks. There is no particle of risk involved in letting business take its natural course and the people can help themselves and the country most by putting into active circulation the money they are hoarding.

"The banks and trust companies are solvent. There is more currency in the country today than there was a month ago, when the supply was ample. Since then \$55,000,000 in gold has been imported and the Government has deposited already \$60,000,000. These are facts and I appeal to the public to co-operate with us in restoring normal business conditions. The Government will see that the people do not suffer if only the people themselves will act in a normal way. Crops are good and business conditions are sound, and we should put the money we have into circulation at once to meet the needs of our abounding prosperity.

"There is no analogy at all with the way things were in 1893. In November 30, of last year, there was in the Treasury but \$161,000,000 in gold. On Nov. 14, of this year, there was in the Treasury \$904,000,000 gold. Ten years ago the circulation per capita was \$23.23. It is now \$33.23. The steps that you now take, the ability of the Government to back them up, and that not a particle of risk is involved therein, give the fullest guarantee of the sound condition of our people and the sound condition of our Treasury. All that our people have to do now is to go ahead with their normal business in a normal fashion, and the whole difficulty disappears; and this end will be achieved, if each man will act as he normally does act, and as the real conditions of the country's business fully warrants his now acting. Sincerely yours, "THEODORE ROOSEVELT."

Bryan has Faith in the Banks.

Mr. Bryan, in speaking of the Wall street flutter, said:

We are in the midst of a financial stringency that is in some respects more acute than that of 1893. I am not going to blame the President or a Republican administration, but I know who would be blamed if I were President. If I were President, every cross road Republican would be blaming me. The panic of 1913 came 12 years after the Republic took power and 11 years before they surrendered power to the Democrats. I am not going to blame the President, because I don't think blame should be laid at his door. I'm going to do him the justice to say I won't join the chorus of Eastern financiers who want to make him the scapegoat. Those who violate the law should be blamed, not those who have turned on the light recently.

There is no excuse of the people being afraid that their banks are not solvent. What is the cause of this panic? The President is not to blame. Who is to blame? The Republican leaders who had control of the country for 47 years. They have so chained us to Wall street that when a Wall street gambler fails, our business world trembles all over the country.

The common people and not the Wall street gamblers should handle this situation. The man who will draw out his money now, when he does not need it, is in the same class as the man who would refuse to aid his country in time war. This is a time when great patriotism is needed.

A recent news telegram from Louisville, Ky., says: An uncanny mist has been falling steadily day and night for four weeks on the spot where Van Smith killed his brother-in-law, Bill Bartley, near Glasgow in Warren County, last May. The phenomenon both puzzles and alarms the people there. The mist almost amounts to a rain, but it covers only an area some 20 feet across. The spot has been visited by several hundred people during the past few days, among them their State Senator, C. Gillinger, who walked across the tract and the mist dampened his hat and clothes.
