**New TRANSPORTATION LINE FOR TILLAMOOK.**  
**Direct from San Francisco-- Lower Freight Rates.**  
 The people of Tillamook county will be glad to hear that the Miami Lumber Company has decided to put on a line of steamers between San Francisco and Tillamook, to carry passengers and freight between the two ports, which is a long felt want in this county. The steamer Minnie E. Kelton is the first vessel to be put on the run. She is a vessel of one thousand tons capacity, has accommodations for 40 passengers, and capacity for a million feet of lumber, and will make a trip every twelve days. The freight will be brought from Hobsonville to Tillamook City in a 35 ton gasoline vessel, and the company, so we are informed, will have their own warehouse in this city.  
 The following letter from the Miami Lumber Company has been addressed to a number of business men of this city:  
 Gentlemen:—When the improvements now being made to our mill at Hobsonville are completed and we resume operations, it is our intention to ply Str. "Minnie E. Kelton" (1000 tons capacity) between Tillamook Bay and California ports. This vessel would make at least two trips a month and might possibly complete a voyage to this city every twelve days. Besides the steamer we expect to run three sailing vessels to the mill steadily, so will be in a position to handle freight from here to good advantage.  
 We have found San Francisco the best market in which to place orders considering price, quality and assortment, and we figure we can handle your business as it should be and at a less rate of freight than you are now paying.
