Another case of suicide occurred on Wednesday from carbolic acid. J. K. Craven, a respected citizen of this county, who lives at Meda, went to his barn at eleven o'clock on Wednesday morning and took a dose of carbolic acid and lived three hours after doing so. Mr. Craven came to this city several weeks ago for medical treatment, suffering with stomach trouble. It is supposed that he became esopendent on account of ill health. The remains were buried on Thursday.

L. H. Smith committed suicide in this city on Saturday morning, who, having become tired of life and his mode of living, took poison. Smith was a drinking man and did carpentering work. Saturday morning he sold his tools to C. E. Reynolds, saying that he was going outside to work. He went to the drug store and bought a bottle of carbolic acid, after which he went home, going to his bedroom. He wrote a short note to his wife on a tablet, bidding her good by. Taking off his clothing, he laid down on the bed and took a dose of the carbolic acid, where he was found by his wife. Smith having been dead some time when Mrs. Smith had occasion to go to his room. Coroner Reynolds was called, and after making an investigation did not think it necessary to hold an inquest.

FOR ENFORCEMENT OF LAW IN TILLAMOOK.

Mayor Johnson's Commendable Letter to the City Fathers.

A meeting of the city council was held on Tuesday evening, when Mayor S. S. Johnson and Councilmen Wilt, Williams and Lamb were present. The following bills were allowed:

Mayor Johnson submitted the following commendable communication to the city council:

Tillamook, Oregon, June 2, 1908.

Gentlemen of the Common Council:

For the third time Tillamook County has registered in an election a majority in favor of the local option law.

This law has been in force within the county during the three and one half years just past, and during most of this time there have been constant and well founded rumors that the law was being violated.

It is immaterial what may be our individual opinion as to the wisdom of the law. It is of no consequence that its enforcement necessitates inquisitorial methods somewhat at variance with American ideals. It is enough to know it is a law that has been upheld by the courts.

Hence, I call on the members of the Common Council and all good citizens of the city to co-operate with the State and County authorities in suppressing the unlawful sale of intoxicating liquors within the city limits. I promise to lend whatever aid lies within my power.

The city authorities have no jurisdiction over violators of the law. So, all that can be done is to assist as best we can the county authorities. To this end I shall be pleased to receive information from any and all persons, such as would probably lead to the arrest and conviction of violators of the law. Upon receiving such information the city peace officers will be directed to make a thorough investigation; and any persons discovered violating the law will be prosecuted under the city ordinance in the Recorder's Court for selling intoxicating liquors without first obtaining a license. This is the only prosecution the city can institute, and such prosecution will be no bar to a subsequent prosecution in the State Courts under the local option law.

The City Attorney, if requested so to do, will assist the District Attorney in prosecutions in the State Courts.

The peace officers of the city will be directed to make weekly reports to the Mayor of all persons observed in an intoxicated condition, as well as all persons found with intoxicated liquors in their possession.

A copy of this report will be submitted to the District Attorney and with the data given therein he may proceed to bring such persons before him, in accordance with the State law.

The success of the city authorities in suppressing the practice known as "bootlegging" will depend greatly upon the co-operation of the law abiding people of the city; and once more I earnestly solicit such co-operation.

HIS PLAIN DUTY.

It is Now up to Mayor Johnson to Show his Sincerity and Make Good.

Mayor Johnson's letter to the city council about the enforcement of law is certainly a commendable document if the spirit of the communication is carried out to the letter. All that we need say in regard to it is that it looks to us that the Mayor has been on the wrong side of the fence and is now ready to do the right thing. But why this sudden change of front for the enforcement of law? It is certainly surprising to us. It was Mayor Johnson and a number of others who ran out of town a detective who was sent here by the District Attorney, and at the taxpayers' expense, to round up the violators of the law, which was a most serious offence in itself. Although we are informed that the Mayor regretted his hasty action when sober judgment prevailed, it soon had its demoralizing effect. The parties who were arrested then were selling liquor without a license and to prove whether the Mayor is sincere in what he says, it is not too late for the city attorney to prosecute these cases. Another case we wish to cite. A complaint was sworn to by J. I. Rupp against Tom Browne for using as profane and disgusting language as was ever heard in this city. He pleaded guilty in the justice court with the expectation of getting off with a small fine, but the justice surprised him by imposing a fine of \$50, which was paid. It seems that Browne went to Mayor Johnson and City Attorney Talmage and told them what he did, the result of which is a writ of review has been filed in the circuit court for the purpose of getting the money back. It is not too late for the mayor and the city attorney to enforce the city ordinance for using abusive language against Browne. It is his second offence, for he used disgusting language before to the annoyance of one of the churches in the city on a Sunday morning, and Mayor Botts swore out the complaint, which make a good precedent for Mayor Johnson to follow. The Mayor says: "The city attorney, if requested so to do, will assist the district attorney in prosecutions in the state court." We, therefore, make the request that the city attorney and the mayor assist the state in the Browne writ of review now pending in the circuit court, and as they are attorneys for the defendant in this case they will have to do the somersault act to square themselves. We simply mention these few facts to show how difficult it was for the county officials to enforce law and punish offenders when the city officials work in the opposite direction. But we do not want to keep harping on these matters, but the Press and the public can only judge public officials by the record they have made and are making in being lined up with those who are opposed to or are in favor of law and order. We believe that Mayor Johnson down in his heart is wanting to do what is right for the city, and whatever indiscretion he may be guilty of in the past will soon be forgiven and forgotten if the city officials will prosecute the cases we have mentioned above, which will be the best kind of evidence the people can have that Mayor Johnson is sincere in his effort to round up the bootleggers and others for violating city ordinances. Mayor Johnson has made public what he will do, and the Press in behalf of the people of this city have cited three clear cases where he can make good, for the records are prima facie evidence that they are guilty by their own confessions.

THE ELECTION.

Chamberlain Beats Cake for U.S. Senator.

The election on Monday passed off quietly in Tillamook County, all the republican candidates receiving large majorities with the exception of J. S. Stephens, who was beaten by his democratic opponent, P. W. Todd, by 260 votes. The republican state ticket carried by a big vote with the exception of Cake for U.S. senator, Chamberlain polling about 1,500 more votes.

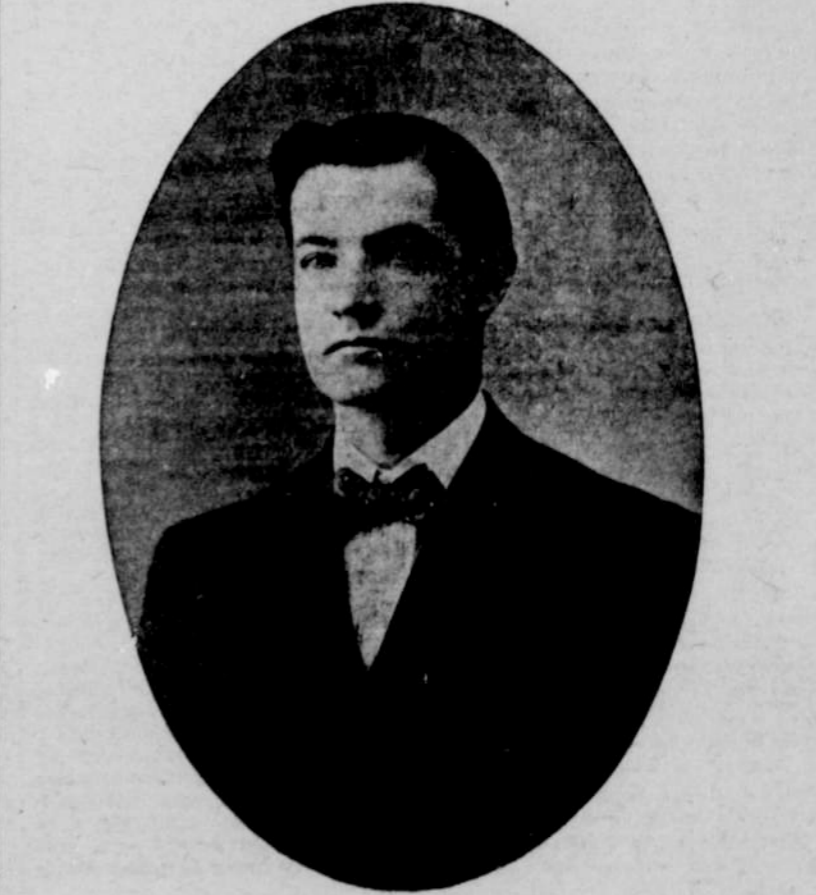

TO THE PUBLIC.

The people of Tillamook County have again voted to prohibit the sale of intoxicating liquor. This makes it my duty to continue the arrest and prosecution of anyone who sells liquor. I have at all times tried to enforce this law, with all the other laws, and have put in a great deal of time and have spent money from my own pocket to do so, but I have been compelled to rely somewhat on information from others. I shall still have to rely on others to a certain extent, and I appeal to the people to stand by me in this work. I am assured of the support of a great majority of the people in this matter, but I want to ask each and every one who knows, or shall know of the violation of the local option law, to give me all the information they can of such matters. I shall investigate all complaints made and use every effort to procure the conviction of every violator of this law, showing neither fear nor favor to anyone, but I shall need the hearty co-operation of all. It has been difficult to procure sufficient evidence in some cases on account of the false statements of those who know the facts. It is your law and you are interested in its enforcement, so I make this appeal to arouse an interest in the enforcement of the law and for assistance so that I may be able to see that the law is enforced. I have made no promises before election so I am not bound to anyone. I take my stand after election, and I certainly hope that the people of Tillamook County will stand back of their officers for the enforcement of the law.

PROHIBITION GAINS.

Twenty Counties Have Voted Against Liquor and Nine For it.

Oregon's nine dry counties will be increased to 21 next month, when the dry mandate of Monday's Prohibition elections shall go into effect. All of the eight dry counties voting on the question retain Prohibition. They are: Lane, Linn, Curry, Tillamook, Lincoln, Yamhill, Sherman and Willows.

The 13 new dry counties are Crook, by 209 majority; Douglas, by 400; Jackson, by 200; Josephine, by 300; Umatilla, by 700; Union, by 850; Wheeler, by 200; Gilliam, Grant and Malheur.

Counties which voted against Prohibition are: Marion, by 200; Clackamas, by 50; Coos, by 8; Washington, by 300; Columbia, by 80, and Wasco, Harney, Klamath and Lake by small majorities.

Four counties did not vote on county Prohibition: Benton, already dry; Multnomah, Clatsop and Baker.
