Dr. Smith was called to Netarts last Friday to see M. J. Cone, who was in a dangerous condition, and we are informed that he has grown worse since then. Cone is suffering with blood poisoning and erysipelas, the result of a fracas in which he got into a fight with Jesse Davis, who bit Cone in the nose. Davis was bound over to the circuit court, and should Cone's injuries prove fatal, Davis will be charged with manslaughter.

The Hillsboro Independent says that indications point strongly to a resumption of work on the P. R. & N. Contractors have been inspecting the line and it is said the chief engineer this week privately stated that it would only be a short time before work would begin. It is believed recent activity in electric lines and the belief that Tillamook is the ultimate destination of the United Railways has influenced the decision to complete the steam line.

He has appealed the case to the circuit court with a good prospect of getting a double dose of experience as well as fine. Those who know the temper of the Tillamook people say he was fortunate

in escaping a coat of tar and feathers and a free ride on a fence rail.—Sheridan Sun.

Hendricks, editor and proprietor of the Daily Oregon Statesman of Salem, and "lord of the manor" of Bay City, near Tillamook City, was in the city yesterday, accompanied by his brother-in-law and friend, D. B. Snyder. Both gentlemen have the pleasantest words possible for the Tillamook country including Bay City, of course; and they kindly included Astoria in the general up-lift of the coast country which they presaged in unstinted terms. They left for the Capital City on last evening's express.—Astorian.

W. H. Owens, of Long Prairie, was brought to the city on Wednesday by Sheriff Crenshaw, to be examined for insanity. His mind has been affected for some time, and since his wife's death he has grown gradually worse, laboring under the delusion that there was a conspiracy to kill him, that the doctors killed his wife, and other things equally as absurd. He was examined by Dr. Smith, the county physician, and County Judge Goodspeed, who adjudged him insane. Owens was committed to the insane asylum and the attendants were telephoned for to take him to Salem.

Miss Garfield, who teaches shorthand and typewriting, is the only teacher who is re-elected, all the other teachers who taught last term declining to serve again.

**Burned Out on Sunday Morning.**

Dec Tomlinson sustained a bad loss early Sunday morning when his home and furniture, on the Tillamook river, were totally destroyed by fire. It was about six o'clock when Mr. Tomlinson was milking in the barn, which is some distance from the house, and while Mrs. Tomlinson was returning from the barn that she noticed the house on fire. As their children were inside, their parents hurried to the house and rescued them, but not in time to save the building or their furniture, the fire having obtained such a strong hold on the building when it was first discovered that it was only a few minutes before the house was one mass of flames. The fire originated in the flue from the stove pipe, the ceiling and roof catching on fire. Mr. Tomlinson's loss amounts to about \$1,500, and besides the loss of the house and furniture, a number of family trinkets and the harness were burned up, including a large quantity of preserved fruit put up by Mrs. Tomlinson. As Mr. Tomlinson did not carry any insurance, it is a great loss to him and his family.

Work at the oil well had to be closed down owing to the rope stranding. It has been in service for over a year and was 3,000 ft. in length and 3,000 pounds in weight. This is the second rope used in this enterprise and a new rope will have to be obtained before work can be resumed.

**Judge Burnett Takes Motion Under Consideration in Hembree Case.**

Arguments were made today in the Hembree case at Dallas to set aside the judgment and Judge Burnett took the matter under advisement until the 21st September.

**Arrested for Peddling.**

John Morton and Ira Smith, who brought in about a dozen buggies on Saturday, were arrested on Wednesday on a complaint sworn to by E. E. Tyler charged with the crime of peddling, hawking, vending, selling goods, wares and merchandise without first having obtained a county license. They had a preliminary hearing before Justice Sappington and admitted selling buggies without obtaining a license, but the justice sustained a motion that the prosecution had not proved that they hawked or peddled the buggies, so dismissed the case.

A section of the laws under which the complaint was made is as follows:

Sec. 3.—Any peddler, hawker, or itinerant vender, who shall in any county in the state, without having first obtained a license in such county so to do in the manner hereinbefore provided, peddle, hawk, vend, or sell any goods, wares, or merchandise mentioned in section 1 of this act, shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than \$300 nor more than \$500, or imprisonment in the county jail not less than one month nor more than one year; provided that the provisions of this act shall not apply to any incorporated city or town which by its charter, is vested with power or authority to issue licenses to peddlers, hawkers or itinerant vendors.

We understand that other complaints will be filed against Morton and Smith, including one by the county to force payment of taxes on the buggies.
