A suit was filed in the circuit court by William Dowd against Hilda Cooper which is for an injunction to restrain defendant from selling or disposing of certain property on the Trask river and that a deed executed by plaintiff to defendant be set aside.

There is a change of program twice a week, and the service given is a good one, for it includes an amusing comic sketch as well as a dramatic play, besides other features.

Tillamook Building Company, a corporation, plaintiff, vs. J. H. Oliver and James C. Cox, defendants, is a suit filed in the circuit court, in which it is claimed that Oliver agreed to sell a certain lot to the company and to take shares, but instead of doing so he sold the lot to J. C. Cox, the object of the suit is to compel Oliver to live up to his agreement.

A mild case of small pox developed last week, when R. Schofield was taken down with the disease, and in consequence the E. O. D. Laundry and his residence were quarantined. It is thought that he contracted the disease through some infected clothes sent to the laundry. Dr. Smith is the attending physician, and he does not look for any spread of the disease.

Sheriff Crenshaw and Dr. Smith were called north this afternoon to attend a Dago who had attempted suicide by cutting his throat. The Dagoes have been having trouble on account of one of the men making improper overtures to one of the Dago's wives who is doing the cooking, and the other Dago started in to castrate the man, but he succeeded in getting away before they got through doing so.

George F. Rodgers, mayor of Salem, came in on Tuesday and left this morning for Cloverdale. This was his first visit to Tillamook and he was greatly surprised to find such a wealth of undeveloped resources. Another thing which delighted him was the splendid music rendered by the Tillamook Concert Band on Wednesday evening, remarking that it was a band which any city in the State would be proud of.

Victor Peltz met with a serious accident on Wednesday by the explosion of a dynamite cap in his hand, which blew off the top of his right thumb and index finger. The most peculiar feature of the accident was in the nail of the thumb being blown into the boy's face, entering the flesh below the eye, making such a small hole that it was a surprise how it came there. Dr. Ross attended to the boy's injuries, and he had to lance the face to remove the nail.

The Republican meeting held at the opera house on Wednesday evening was well attended, which was addressed by Mr. Geo. F. Rodgers, mayor of Salem, who discussed the issues of the day from a republican standpoint. He took up the free trade policy of the democratic party, also free silver, and criticized the democratic platform, which was made to get votes on but not to stand upon. Mr. Rodgers' remarks were well received. The Tillamook Concert Band rendered some excellent music previous to the speaking.

On Friday evening of last week the Woodmen of the World, Alder Camp No. 219, of this city, elected several applicants and A. D. Cridge, district organizer, installed the following officers: Consul Commander, E. W. Stanley; Advisor, Wm. Bodyfelt; Clerk, Carl Habertach; Banker, P. W. Todd. Bay City Camp was invited to witness and assist in the initiation of November 9th. It is the possible intention of the Camp and Circle to give some sort of a dance and entertainment in the near future. After the Camp had closed Alder Circle, Women of Woodcraft, spread a fine supper which was responded to with faith-

fulness. The Tillamook Band, over twenty strong filled the hall with good music for over an hour, for which thanks were given in the name of the Camp and Circle by Organizer Cridge.

W. Langworthy was arrested, charged with violating the local option law, and had a trial before Justice Sappington on Wednesday. Deputy District Attorney Cooper asked for a jury trial, but Attorney Johnson objected, contending that the state had no right to ask for a jury trial. The Justice ruled that the State was not permitted to ask for a jury, which appeared to be a great surprise to the deputy district attorney, as the justice had granted a jury trial by request of the State in the Nick Job bootlegging case. W. B. Sutton testified that on the 27th September he went into the old Steinhilber building, where he found W. Langworthy and a sewing machine agent, Langworthy was in bed. Sutton sat down and asked if they did not have some beer. The sewing machine agent answered "Yes," and went out of the room and returned with several bottles. Sutton and the machine agent drank it, and the former ordered more. When Sutton went to pay for it he found he did not have enough money with him, so he borrowed \$2 from the machine agent. Sutton laid the money down on a stand by the head of the bed in which Langworthy was lying and went out. It was also proved by evidence that 12 barrels of beer, making 864 bottles, had been shipped to him between July 15th and October 2nd. When the sheriff searched the place he found a box containing half a dozen bottles of liquor, addressed to the defendant at Bay City. Justice Sappington did not think the evidence strong enough to convict, so dismissed the case.

UNGENTLEMANLY CONDUCT IN POST OFFICE.

Mayor Johnson and Postmaster Severance in a Rough and Tumble Fight.

The ungentlemanly conduct of Mayor S. S. Johnson on Wednesday afternoon turned the post office into a rough house and a sanguinary fight ensued between the Mayor and Postmaster Severance, the first and only round ending when Uncle Sam's stamp licker had the city's chief dignitary down flat on the floor and commencing to give him a good licking. He was pulled off.

The ruction came about in this way: Postmaster Severance was standing at the money order window talking to J. A. Dahlgren, the photographer, when Mayor Johnson stepped into the post office, and after looking into his box, went to the money order window, and Mr. Dahlgren thinking that the mayor had some business there, stepped on one side. Johnson wanted to know from Severance why he had sworn out a complaint against W. Langworthy, who was tried that day for a violation of the local option law. Severance replied by saying that that was his business. Johnson said that Severance had no right to do so, and the postmaster persisted in saying that as a citizen of the United States he had a perfect right to swear out a complaint against anyone who violated the law, and he would do so against the mayor if he had violated the law. Johnson then accused Severance of perjury, saying if it wasn't for the fact that there was a Republican district attorney he would have him indicted for perjury. It being called a perjurer which raised the postmaster's ire, and he said to Johnson, "You're a liar!" Before another word could be said Johnson let his fist fly through the window and struck Severance in the face. The latter would not stand that without resentment, and as quickly as possible slipped through the door and was trying his prowess as a citizen called upon to defend himself against a savage attack on one's person. Blows were freely struck and in the scuffle which ensued the mayor's butt went through the glass of the door. Dahlgren once succeeded in parting them but he could not hold them. Severance succeeded in getting Johnson down, with his face to the floor. In that position the mayor was unable to ward off Severance's thumping, and fearing that some thing serious might happen to Johnson if Severance was allowed to keep on striking him in the face, Dahlgren and Ire Smith, who happened to be passing at the time, pulled Severance off. Dahlgren took Johnson outside the postoffice and told him to go home, which he did. Thus ended another ungentlemanly, disgraceful affair.
