CONTRACT IS LET FOR LYTLE ROAD.

J. W. Sweeney Successful Bidder for Big Railroad Construction Job.

The contract for the construction of the final 53 miles of the Pacific Railway & Navigation Company was let Monday. J. W. Sweeney, Isaac Blumauer and S. N. Binmauer were the successful bidders. It is understood that the Harri-man engineers' estimate of \$2,000,000 was scaled about \$500,000.

It has been understood for a considerable time that Sweeney and his financial backers were the lowest bidders, the one obstacle to clinching the contract being the delivery of a bond for \$100,000. The usual bond would be 10 per cent on the total or \$150,000, but it is generally believed that President E. E. Lytle, of the Pacific Railway & Navigation Company strained a point in this respect to give the benefit to a local contractor.

Mr. Sweeney was unable to obtain his bond up to Monday, but he was able to furnish proofs that the bond would be forthcoming before the final date given him by Mr. Lytle, and with this understanding he was informed he might consider the contract his, but was not permitted to sign up until he could definitely produce his bond. The bonding company is said to have been annoyed by the efforts of the other contractors who have tried to prove Mr. Sweeney incapable of carrying out the contract.

It is understood that the amount of Mr. Sweeney's bid approximated very closely \$1,500,000, although no confirmation could be had from Mr. Lytle. Caughern & Woldson, of Spokane, who have handled some of the C. M. & St. P. work, were the next lowest contractors, being about \$30,000 above Sweeney in their bid. A. J. McKabe was third bidder, and was still \$30,000 to the bad. Mr. Sweeney was a sub-contractor on Southern Pacific extension from Drain to Coos Bay, and when further construction was stopped he withdrew.

The contract is one of the largest let in the state of Oregon, and is certainly the largest contract let in Oregon for some years. By commencing immediate construction it is thought the whole line may be completed by the summer of 1910, and probably in time to take care of a portion of the beach traffic in that season.

Many difficulties confront the contractor. He must construct wagon roads where no but rough trails exist. This will call for an expenditure of probably \$200,000, and this must be done before the contractor is reimbursed a cent. The distance is 53 miles. There are 19 tunnels of varying length, and in many places the roaring mountain torrents must be bridged. Much of the construction embraces rock work exceptionally heavy in character.

Julius Kruttschnitt announced to President Lytle over a month ago that the funds were at the disposal of Mr. Lytle for the building of what will become a subsidiary Harriman line. Mr. Lytle has earned some little distinction as a railroad builder, having been the builder of the Columbia Southern to Shaniko and the Condon road to Central Oregon. He also made the Harriman survey up the Deschutes Canyon. "I have now enough confidence in Mr. Sweeney," said Mr. Lytle Monday, "to give him the contract. I expect he will make good this week with his bond, and anyway he has until Friday to obtain it."

COURT DISGUSTED AGAIN.

Attorney Nolan had to Apologise--Court Admonished Attorneys.

Another instance of the disgraceful and disgusting manner in which some of the Tillamook attorneys conduct their cases took place on Saturday last in the circuit court, just one week after attorney Johnson's disgraceful conduct in the same court room.

The case of Andy Nolan vs. the First National Bank was up for trial before Judge Galloway. Attorney Nolan appeared for plaintiff and Attorney Holmes for the defendant. It was an action for money, and James Walton, cashier of the bank, was on the witness stand. Attorney Nolan caused a great deal of surprise when he asked Mr. Walton when he and Gus Kunze entered into an agreement to steal this money from Nolan and Stewart.

Attorney Holmes objected to any such question being put to the witness and appealed to the court.

Attorney Nolan withdrew the question and said he would put it in a different way, and instead of doing so, he asked Mr. Walton when he and Gus Kunze entered into a conspiracy to defraud Nolan and Stewart.

Judge Galloway became indignant that the attorney should use such methods in conducting his case, and forthwith Nolan had to apologize to the court and to the witness, after which the judge admonished the attorneys who had been insulting the court and witnesses, and he was going to take measures to stop it. He said it was a disgrace to Tillamook, and on that account the Tillamook Bar had a bad reputation. On his circuit he said that Tillamook was the only place where the attorneys insulted the court and the witnesses.

After three weeks of Circuit Court, Judge Galloway adjourned court Saturday night. J. O. Drummond vs. Miami Lumber Co. Writ of review. Sustained and justice to assess costs.

Elton Long vs. Gustav Trimpter. Damages. Decided that defendant is a life owner in the estate.

W. G. Dwight vs. Alex. McNair. To quiet title. Non suit asked for by plaintiff and allowed.

M. H. Larsen vs. Marston, Bush and others. To restore deed. Taken under advisement.

William Hines and others vs. William Maxwell and others. To set aside deed. Demurrer overruled and case continued.

Peter Brant vs. Christopher Mills and others. Foreclosure. Granted.

C. G. Van Patten vs. Thomas J. Harris for a new trial overruled.

Andy Nolan vs. The First National Bank. Suit for money. Dismissed and costs assessed to plaintiff, and the money paid into court to be returned to defendant.

Peter Jenck vs. Tillamook county, Writ of review. Sustained.
