And to show his faith in the city's growth and expansion, he has bought city property.

The receipts from fees for May in the County Clerk's office amounted to \$411.25, which is plain proof that that office is a source of revenue to the county and shows the large amount of work County Clerk Holden and his deputy have to do, yet all the county is paying Deputy County Clerk K. Mills \$50 a month for a \$100 job.

James Walton, jr., cashier of the First National Bank, and Rudolph Kunze were the first fish to be caught violating the new law on Sunday, and next day complaints were sworn out against them by Deputy Fish and Game Warden A. A. Osborn. It was their intention to have taken out licenses, but they failed to do so in time.

F. R. Beals has sold O. E. Wilson's property to B. T. Randall for \$3000, and there is a misunderstanding somewhere, for the property was sold to B. C. Lamb some few weeks ago, so there are now two deeds on record from Mr. Wilson. This is the corner on Main street which had the buildings burned off in the recent fire, and is one of the choice business corners in the city.

Those who are breeding horses in this county will be very fortunate in having an opportunity to breed to one of the highest classed horses of the Pacific Coast, viz., the trotting stallion Major Weitzel, which will make a fall season in this county, and should avail themselves of this opportunity and try to make it an object for Dr. E. F. Rogers to bring his stallion to Tillamook another year.

County Clerk Holden is issuing fishing licenses to all females and males under 15 years of age free of charge, and males over 15 are charged \$1. It is illegal for anyone to fish before they have first obtained a license, which they must carry with them when they go fishing. As the new fish law is distasteful to those who own land along the rivers and streams, a large number of the farmers have posted notice prohibiting persons from trespassing, hunting or fishing.

A raft of piling, belonging to the Chapin-Potter Realty Company went to sea early Monday morning. It contained 720 lineal feet, and the piling was worth over \$500, not including the chains and anchors which went to sea with it. The raft was caught in the swift current in the bay and dragged its anchors, and G. A. Jones endeavored hard to anchor or stop it, and when below the Sound Pigs he had to cut the gasoline launch Bay-ocean loose from the raft and run for safety to prevent being carried out to sea also. The raft remained intact when it went over the bar, and if it does not pile up on the beach, which it is likely to do, it will be a menace to shipping until it goes to pieces. As was expected, the

raft broke up after it had been tossed about by the sea, and strange as it may seem, 200 of the piling went ashore on the ocean side of Bayocean Park, which belongs to the Clappa Potter Realty Co.

Geo. W. Grayson and daughter, Mrs. Clark Hadley, have returned from their visit to Tennessee, where they participated in a family reunion. Mr. Grayson's parents being quite old. While in the South they saw the destruction which follows in the wake of a cyclone. They visited several places of national interest and Washington, D.C., on their return, which afforded them plenty of enjoyment visiting the government buildings. Mr. Grayson predicts a large wheat crop in the South and East.

GRADUATING EXERCISES
Large Gathering at the High School Commencement.

On Friday evening commencement exercises of the Tillamook High School, also of the 8th grade, were held in the opera house, with an attendance which did justice to the occasion, and every seat taken in the gallery as well as below. The evening was delightful. The stage was appropriately decorated with banners and pennants, conspicuous among them being large class banners of the four years, the colors of the graduating class, violet and gray, predominating. Ferns, evergreen and flowers embellished the other decoration.

The music was furnished by Jenkins' orchestra, every number of which was well received. The Juniors acted as ushers, with assistants from some of the lower grades as flower girls.

The program opened with a selection by the orchestra, followed by introduction by Prof. Goldsworthy. A duet was sweetly rendered by Mable Goyne and Fay Burke. Albert Bramwell, an industrialist, spoke on "Ambitions and Industry," and handled his subject well. An essay, "Beyond the Alps Lies our Italy," by Nellie Hanenkratt, contained some excellent thoughts. "Ideals and Inspirations" was the subject of another essay given by Lillian Young. Vida Rogers gave the "Class Will," with the usual beauephments in such cases made, which caused much amusement among those directly interested. Lillian Anderson, the popular soloist, charmed the audience with a selection, "Sing Me to Sleep." The "Class Frolic" was given by Evan Ross, each teacher and Senior being properly, some very amusingly, disposed of. The violin duet by Chester and Ruby McGhee, with piano accompaniment by Eva Wheeler, was surely a "concord of sweet sounds," greatly enjoyed, and as an encore rendered an equally delightful number, "Annie Laurie," piano and violin duet. Helen Bibby, as valetictorian, gave an oration on the subject "Life," full of excellent thought appropriate to the subject, and the earnest, forceful manner in which it was presented held the attention of the audience from first to last. "Class Mates," sung by a high school chorus, was well received.

Prof. Rutherford was listed for an address, but being unable to come, his place was well taken by Rev. Robinson, who, in his brief remarks, covered many vital points in the life of the young people today, remind them that to whom much is given of him shall much be required, and urging them to noble effort in the world's work for the betterment of God and humanity, and to lend sympathy and helpfulness to those less favored than themselves.

The presentation of diplomas was by Mr. H. T. Botts, who also gave the graduates many helpful hints. A literal avalanche of flowers awaited the class, and congratulations and good wishes given by a host of friends who wish the class of '09 all success.

Baccalaureate Service.
The Baccalaureate service held in the U. B. church, was well attended, notwithstanding the dismal weather on that occasion. The church was prettily decorated with flowers, the altar and choir loft being especially attractive. A chorus from the High School furnished most of the music. Mrs. Poorman sang a duet, also Miss Ruby McGhee, which were very pleasing. The invocation was by Rev. Dunlop, of the M. E. church, and the Presbyterian pastor, Rev. Robinson, offered prayer.

Rev. Haven, of the Christian church, preached a most forceful and eloquent sermon to the graduates, with marked attention from them as well as the audience in general. Characters of

historic fame were cited as examples of success and also failure, but character and devotion to high principles of living were emphasized as the only real success in life, or as being worth while, coupled with making the most of one's endowments mentally and physically, for the benefit and helpfulness of one's fellow men and those round about. With the privileges which the young people of today enjoy, more is expected of them than of preceding generations, and the questions of the future will necessarily be solved by those now starting out in life; hence the best cultivation possible of all the faculties is essential in our present young people.
