**WANTS HOMES FOR THE
 SETTLERS.**

**Agricultural Land Now in the
 Reserves to be Thrown
 Open Again.**

MY DEAR SIR,—Ever since I became
 a member of Congress I have been urging
 that all lands suitable for homesteads,
 now included in the forest reserves,
 should be returned to the public domain.
 I took the matter up again with the
 Secretary of Agriculture in a letter,
 copy of which I enclose herewith, and I
 think his reply will be acceptable in
 formation to the readers of your valuable
 paper. I shall urge that this survey be
 completed as soon as possible.

DEAR SIR,—I have the honor to
 acknowledge receipt of your letter of
 May 28th, in relation to lands, probably
 agricultural in character, which have
 been included within the national forests
 in the State of Oregon.

I am now having a survey made of
 the forests with a view to ascertaining
 the facts in this very connection, and if
 we find that considerable areas have
 been included that are more suitable for
 farms and are not watersheds that
 should be reforested, the intention is to
 have them turned back to the public
 domain. I am going out myself this
 summer to the mountain states to in-
 quire into this question.

MY DEAR SIR,—During recent years
 there have been somewhat extensive
 additions to the national forest areas in
 Oregon. The insertion of the provision
 in the Agricultural Appropriation Act
 of March 4, 1907, led, I understand, to
 the addition of considerable areas, just
 prior to the approval of the bill
 which areas appear to have been quickly
 determined upon.

Because of this there have been in-
 cluded in the national forests in Oregon,
 not only agricultural and grazing lands,
 and lands with but little forest on them,
 but also lands that were patented and
 that had been settled for considerable
 periods.

The purpose of this letter is to respect-
 fully inquire whether all or any of the
 areas now included in the national
 forests in Oregon were, prior to their
 inclusion, examined, or surveyed, and
 the lands included in the national
 forests classified as agricultural, grazing,
 timber, etc., as shown by the re-
 cords of your department. If they were
 not so surveyed, or examined and class-
 ified prior to their inclusion, have they
 been since for the purpose of restoring
 them to the public domain for homes
 for the people of the United States, the
 lands which are agricultural, grazing, or
 not sufficiently timbered as to justify
 their retention in the national forests in
 the judgment of the department?

Numerous inquiries are made of me
 relative to public lands in Oregon suitable
 for entry under our general laws. Also
 frequent applications are made to me
 to present the claims of those who desire
 to enter lands within the national forests
 in Oregon which are represented as
 agricultural lands.

From all the information I possess, it
 would appear that agricultural and
 grazing lands, aggregating large
 amounts, are at present included in the
 national forests in Oregon. I respect-
 fully suggest that if a survey, or exami-
 nation were made and all lands other
 than those proper for forest reserves were
 excluded from the national forests in
 Oregon and returned to the public
 domain for entry under our general land
 laws, it would result in benefit to all
 concerned. For generations the policy
 of our government has been to en-
 courage our people to make homes every-
 where within our boundaries, and the
 result has been the incomparable up-

building of our country. The contin-
 uation of this policy would not be detri-
 mental to our national forests policy
 in any way whatever, but would prove
 of great advantage to it. As Honorable
 Gifford Pinchot, Chief Forester, well
 said in the hearing before the House
 Committee on agriculture at the first
 session of the 60th Congress "I think it
 is safe to say that we have no such
 uniform set of friends anywhere as the
 men who are living inside the boundaries
 of these (national) forests."

I earnestly desire that all lands not
 to be finally included in the national
 forests in Oregon should be restored to
 the public domain for homes for our
 people in accordance with the immem-
 orial practice of this government.
