Editorial Snap Shots.

Be a booster this year, with a whole lot of civic pride mixed with it.

Hoek! Hoek! Hoek! Rollie W. Watson is back again in the sanctum sanctorum of the Herald office. Shake, Bro.

Those who feel they have a \$5 howl (Owl) coming can now howl with a little more satisfaction now the Owl rustler has been brought back to face the hoot, hoot, hooting music.

A report was circulated Tuesday that the snap shot man had sold out. This caused the denizens of the White Corner to prick up their ears and bray, and "Billy" passed the cigars to increase their exultation. But, alas, their ears are now flopped over and their braying suddenly ceased when they found out that there was no truth in the report. Pass the cigars around, "Billy," to the Headlight staff.

The Oregonian says that "not 10 per cent of the cases brought into court ought ever to be there. They are trifling contentions, not based on justice but on human perversity and littleness. Most of them are fomented by those plagues of society who expect to live by strife and litigation—the so-called lawyers." Those who have watched the proceedings of the courts in Tillamook will admit there is a great deal of useless and nonsensical cases, and it is easy to see who are to blame for this.

We are going to take exception to one incident in Mayor Coates' excellent message, in which he speaks of the flattering endorsement his administration received at the last election. It seems to us that it would have been proper for the mayor to have called attention to the large number of transients who have been herded and taken to the polls and voted at the last two elections, for this is a matter which calls for some change. When a large number of transients, who pay no taxes, can be herded together and out-vote those who pay taxes, this certainly calls for some remedy.

The question of a sewerage system is again touched upon by Mayor Coates in his annual message. We will admit that the city is needing a system of that character and will have to have one to prevent sickness and the spread of disease. The question of cost, however, is a matter which is somewhat complex, for the reason that the water system about absorbed the limit of the city's bonded indebtedness. To cope with this difficulty the city would have to increase its borrowing powers or devise a plan whereby the entire cost of a sewerage system can be met by an equal assessment against the property owners.

The Oregonian, giving a long account of the orgies in Portland on new year's eve, says:

"Liquor enough was consumed to float the Pacific squadron. The scene was swarming with swarthy and

chorage for a torpedo flotilla. Noise enough was made to drown the combined cannonading of squadron and flotilla in full action."

Evidently Portland is in a fair way to become "dry," for it was the abuse of the liquor traffic and the utter disregard for decency and law by saloon keepers which are the causes of so many counties in Oregon being in the "dry" column. If the Oregonian correctly depicts the situation in Portland on new year's eve, the local option law applied to that city for a few years would have a wonderful effect in putting a stop to the disgraceful drunken orgies.

Quite a few individuals have cut a great swath and had a mushroom importance running the Herald, but it is a noticeable incident that as soon as the powers behind the throne become tired with them that their heads are suddenly decapitated and fall into the basket. Next please. People soon see through the whole thing of turning over a newspaper to unreliable individuals so that a few persons can control it and vent their spleen on others. Take, for instance, when Dolan and Murphy assumed management of that newspaper, they were without means and tools in the hands of others, which a few anonymous writers dare not deny, for the individuals whom they put confidence in gave the whole matter away. Strange, isn't it, that a few business and professional men cannot get along with their own business affairs without wanting to run and control a newspaper?

Tillamook County and City enters upon a new year and the probabilities are that this will be a most important one in their history. All admit that there is a bright future for the county, and that this city is splendidly situated and can be made a pretty, attractive city and the center of industrial commerce and industry. These are the things which all should strive for the coming year. The city has had a good many knockers in the past, which have retarded its growth and progress, and a large amount of uncalled for personal animosity. All this should be relegated to the back ground and a spirit of civic pride should take its place. We hope that from now on there will be a united effort, and a pull altogether, to make Tillamook City an industrial center as well as an attractive residence and up-to-date business city. That is what the Headlight will strive for, and with everybody boosting the advantages of the city and county, the next few years will bring about wonderful improvements.

Service on Juries.
 It is complained that men of character and standing, in the management of business and affairs, shirk jury duty. The reason is not far to seek. To men of quiet disposition and breadth of judgment, who detest petty strife, jury duty is irksome and abhorrent. Men who keep out of lawsuits themselves are unwilling to set as jurors upon the petty and miserable contentions of others.

Men who avoid litigation with their neighbors, who will pocket indignities and accept losses rather than "go to law," have a natural and altogether reasonable disinclination to serve on juries and hear and try out the petty and miserable quarrels of others. Not 10 per cent of the cases brought into court ought ever to be there. They are trifling contentions, not based on justice but on human perversity and littleness. Most of them are fomented by those plagues of society who expect to live by strife and litigation—the so-called lawyers, who are turned out every year from law schools, so-called, to prey on the public.

Men who don't want to engage in this business, or to be instruments of it, are unwilling to serve as jurors. Men who will not "go to law" themselves, but prefer to submit to losses and injuries, rather than "take the law" of those who have done them wrong, don't like to be bothered and harassed and pestered by the quarrels of others. Is it unpatriotic to dislike

"service" of this description? Then every quiet, sensible and peaceable man must be called unpatriotic—Oregonian.

Death of G. W. Sappington.

We are sorry to announce that Judge Geo. W. Sappington died on Tuesday, at Hebo, and the remains were brought to the city the next day.

He was stricken with paralysis which proved fatal after several days. The remains were buried to day in the Oddfellows' cemetery.

Geo. W. Sappington was born at Mt. Sterling, Kentucky, on the 8th Nov., 1861, and crossed the plains in 1845. He was raised at McMinnville, Yamhill County, Oregon, and was married to Mary Laughlin in 1865, who died some years ago. He was married the second time to Mary E. Robertson on the 3rd of July, 1888. He came to Tillamook about 18 years ago, and in 1898 was elected County Judge on the republican ticket, and at the last county election was elected justice of the peace for the second justice district.

He leaves eight children, viz: F. L. Sappington, of Portland; Mrs. Adie Laughlin, of Carlton, Ore.; and Mrs. Della Carver, Mrs. Mary Johnson, Wert Sappington, Mrs. Effie Jensen, and Ward and Harry Sappington, all of Tillamook County.

Locating the Dolph Road.

TO THE EDITOR TILLAMOOK HEADLIGHT.
 Dolph, Ore., Dec. 28, 1909.

Mr. Rollie W. Watson, Tillamook, Oregon.
 DEAR SIR & FRIEND.—There is a well advanced move here in regard to the changing of the road around the Dolph Hill, and I am of the opinion that if a change is to be made that said change should be thoroughly investigated and located in the right place before any money is expended foolishly on a new section of road. I believe that it is for the best interests of the people of Tillamook and especially the South part of the county, and the Little Nestucca people in particular, to keep a look out for this change of road and keep their eyes open.

I understand, that for personal interests of a certain party here, that it is agreed to open a road to land back of the present "Toll Road" to the east. It has been represented to the Yamhill County Court to leave the present road near the Arch Myer's place and swing to the East, and come out at the summit again. This change added to the "Toll Road" makes the road longer—(benefit one); opens a road to a ranch back in the mountains for a certain party—(benefit two); and gratifies a personal motive—(benefit three).

I understand it has been represented to the Yamhill County Court that this change will be cheaper for them to build and throws most of the change on Tillamook County, and that is the expensive part. The party engineering this scheme has been ordered to go ahead, so I understand and backed by the Yamhill County Court. It has been represented by this party that the "Sour Grass Route" would cost \$30,000 and that the personal benefit change would cost about \$4000.

If there is any practical route there, why did not the railroad surveyors go that way instead of driving their stakes on the "Sour Grass Route"? When we have a water grade via the "Sour Grass Route" and no more expensive road to build, does it look sensible to make an experimental change and still have the same "Summit" elevation to climb up to?

This personal benefit change contemplated will make the "Little Nestucca Road" outlet two miles further away than it is now. Now, Mr. Watson, I think that you have influence enough with automobilists and your friends throughout the southern part of the county to see to it that this road change is made in the right place, in the first place.

From what I have heard things have been cleverly misrepresented to the Yamhill County Court and they are favorable to this experimental change. I wish you would look out for this matter as I expect it will be before the Tillamook County Court, see that they are not humbugged.

If the change is made as set forth in the above letter, there will yet remain between two and three miles of "Toll Road" in Yamhill County; on the other hand if the "Sour Grass Road" is built it will eliminate the toll road and be placed on an easy railroad grade survey.
