Editorial Snap Shots.

Those who continue to nurse their old sores in this progressive city had better bury them forthwith for there is now no room for sore people.

It does look like a foolish trick to shut off the water and go to the expense of removing an hydrant and placing it in the center of the sidewalk at the corner of the school building.

The Executive Board, in appointing the promotion committee for the Tillamook Commercial Club, did not, like the County Court, overlook the Press. As the Headlight has stated before, the county newspapers do the promotion work at all seasons of the year and will remain the principal factors in advertising the county, no matter what other efforts may be used in other directions, for there are scores of advertising schemes and a whole raft of advertising fakirs who travel over the country grafting business men and others.

There appears to be another report going the rounds that the Yamhill County Court is being induced to lease to L. Shortridge a toll road. The news reaches this county through people coming to this county from Yamhill, who claim that there is a dicker going on. In behalf of the people of Tillamook County the Headlight strongly and emphatically protest against this county, or even Yamhill county, being bottled up with toll roads, and it is high time that county officials put their foot down on toll road graft and hold up methods worked upon the traveling public. Probably the Tillamook Commercial Club will take action in this matter just to show the strong sentiment there is in this county on this onerous toll roads.

Something new took place this week in regard to "Tillamook justice." The circuit court declared bonds forfeited in two cases, that of F. J. Smith, who was bound over to the grand jury and failed to appear, and in the case of W. Langworthy, whose case was decided against him by the supreme court for bootlegging. When business men go on the bonds of undesirable citizens who drift into the county to commit crime they ought to be made to forfeit their bonds. They may try to squirm out of it, and it is doubtful whether some of them have not placed themselves in a position where they are unable to pay. A few more instances in the forfeiture of bonds will teach some of our business men a good lesson, for it is not good business sense to back a stranger who may drift into town.

Another respected and honored citizen of Tillamook County passed away this week, and in the death of Horace F. Holden there is a general feeling of regret, for he was one of the few remaining pioneers who helped to make Tillamook County what it is today. He had the Western spirit for grit, perseverance and industry, and success crowned his effort. When Mr. Holden first visited Tillamook in 1856 this county was considered as belonging to the "Woolly West," but by dint of such hard labor and many privations and difficulties to contend with, Mr. Holden, as one of the pioneers, was

instrumental in helping make Tillamook County what it is today, "a land of milk and honey." It is no wonder, then, that we revered and revered Horace F. Holden for his sterling qualities as a pioneer, his uprightness as a citizen, and his purity of life and devotion to his wife and children. Horace F. Holden has gone to the great beyond, there is a vacant chair in the home, loved ones sorrow at the loss of a husband and father who had been good and true to them, and the whole community feel the loss and extend their sympathy to the bereaved family.

It is about time that the Port of Tillamook got busy and made the property owners and others along the water front get back to the Thomas donation line. Tillamook City needs a better harbor, and needs it badly right now. More room is needed right now for the commerce of the port and longer the work of widening the water front is put off more difficult will it be to carry out. No matter who it may inconvenience at the present time, the Port of Tillamook should decide right away to widen the water front to the Thomas donation line, serving notice on those who have encroached to vacate by a certain date.

HEAVY SENTENCES FOR BOOTLEGGING.

Grand Jury Returns a Number of Indictments—Case Against the Editor did Not Materialize.

The April term of the Circuit court was convened on Monday, with Judge Wm. Galloway on the bench, and Attorney Winslow, of Salem, acting in the place of District Attorney McNary. A Grand Jury was drawn and was composed of O. A. Lommen, F. Hobson, J. Wilson, H. A. Miles, W. S. Hays, Guy Vaughn and M. C. Trowbridge. The Judge appointed Mr. Trowbridge foreman of the Grand Jury.

Henry Jennings, one of the bootleggers who have been doing business at Garibaldi and who pleaded guilty at the November term of the circuit court for violating the local option law and was sentenced to serve 15 days in jail, was again indicted by the Grand Jury on a similar charge. His case was tried before a jury on Wednesday morning and he was promptly found guilty and Judge Galloway sentenced him to pay a fine of \$50 and to serve 30 days in the county jail. One peculiar thing about the arrest and conviction of Jennings was that he preferred a charge against Al Thomas for stealing money from him. It appears that Thomas, when he left the employ of Jennings, took what wages were due him and the Justice of the Peace bound him over to the Grand Jury, and being unable to furnish bail was locked up in the county jail. Thomas informed on Jennings and much to his surprise the latter was locked up in jail with the man he accused of stealing. The tables were turned on Jennings on Wednesday when the case against Thomas was dismissed and Jennings took his place in the county jail.

Jack Hill, a Russian Finn, was indicted on Wednesday charged with an assault with a deadly weapon at Nehalem the previous day, and on being tried was found guilty and sentenced to six months in the penitentiary.

Harry Mitchell and his wife, Mell Mitchell, were indicted by the Grand Jury on Wednesday charged with violating the local option law and were arraigned the same evening. They pleaded guilty and were each sentenced to pay a fine of \$20 and 20 days in jail.

John Bolin was indicted by the Grand Jury for killing a goose out of season, but being unaware that it was unlawful the Grand Jury recommended him to mercy, and the Judge imposed a fine of \$25, which was suspended.

Glenn H. Johnson, who was indicted by the November term of the Grand Jury, on a charge of violating the local option law and was one of those caught in the "muck rake" at that time, but evaded being arrested until after court, pleaded guilty to the charge and Judge Galloway imposed a fine of \$150 and 15 days in jail the jail sentence being suspended.

Lewis and Walter Smith, who broke into the store at Garibaldi, was indicted by the Grand Jury, and pleading guilty, the Judge sentenced them to six months in jail.

Deputy District Attorney Winslow asked the court that the bonds be forfeited in the cases of F. J. Smith with W. J. Stephens as bondsman, and that of W. Langworthy, with W. H. Easter and George Young as bondsmen.

The Grand Jury made a partial investigation into the matter of W. W. Wiley, late School Superintendent of this county, withholding about \$800 of school funds from discontinued school districts which had been turned over to him, and if the money is not forthcoming Wiley is liable to get into serious trouble.

The grand jury failed to take any action in regard to the case against Fred Baker, editor of the Tillamook Headlight, who was held to the grand jury charged with violating the Corrupt Practices Law. The editor simply printed an election circular for other parties criticizing the city administration in the last city election, and during the temporary absence from the county of Deputy District Attorney Cooper, C. W. Talmage, a local attorney, worked up the case against the editor. As he had nothing to do with the prosecution of the case on his return, Talmage was appointed by the late Justice Sappington to do so. After the preliminary hearing in the justice court, the justice expressed himself as to the law being a humbug. The whole affair is looked upon as a farce and was instigated by personal spleen.
