**ON TO TILLAMOOK!
AUTOISTS' SLOGAN.**

**Hundred Enthusiasts to Make
the Run from Portland to
Tillamook on Saturday.**

"On to Tillamook" will be the slogan of 100 Portland business men, members of the Portland Automobile Club, who will leave Portland for Bayocean by way of Tillamook in 25 machines July 2, for a four days' outing.

The machines belonging to the Automobile Club will be assembled in front of the Corbett building early Saturday morning and the start will be made at precisely 7 o'clock.

The procession will form with Vice-President W. J. Clemens, of the Portland Automobile Club, leading, and a distance of a quarter of a mile will divide the cars. This will do away with any possibility of a collision and will avoid annoyance from dust. All of the cars will be gaily decorated in holiday attire and the procession will be a waving mass of red, white and blue, giving it a gala-day appearance.

Families to Go Along.

Many of the members of the club will be accompanied by their families, while others will invite friends to make the trip. A number of out-of-town people will also accompany the excursion.

The following will make the run: Frank C. Riggs, H. G. Platt, T. B. Potter, T. L. Potter, E. J. Jaeger, Morris Dooley, Elwood Wiles, H. J. Hoyt, Mr. Foster, Dr. Whiting, John Yeon, W. J. Clemens, Dave Honeyman, Walter Cook, Oliver Jeffery, S. Benson and brother, Dr. J. R. Wetherbee, Lloyd Wentworth, I. N. Lipman, G. C. Moser, Tom West, Mortimer Fouch, E. H. Wempe.

The regular procession will be composed of members of the Portland Automobile Club and all of the people in this party will be guests of the T. B. Potter Realty Company at Bayocean.

It is said the club procession will be joined by other autoists, who will make the run to Tillamook merely for the pleasure of the run, and if all those who have announced their intention of doing so make the trip the procession will be ten miles in length.

The route taken will be as published in The Oregonian some time ago, which was laid out by the "Pathfinder."

Supplies to Be Carried.

Frank C. Riggs, of the Packard Automobile Company, will bring up the rear with a mechanic and supplies to repair any of the machines which may be damaged on the run. Dr. J. R. Wetherbee will also accompany the expedition and will be on hand in case of accident.

At McMinnville the cars will assemble and noses will be counted to see that none are missing. Gasoline will also be taken on here and the procession will form in the original order and continue the journey.

After leaving McMinnville a sack of confetti will be carried, and at each point where the road forks this will be strewn on the ground, indicating the road the leading car has taken.

The Tillamook County officials have had a large force of men at work on the road during the past month and if the weather remains dry the roads should be in the best possible condition. A telephone system has been installed at points along the route, and the road will be kept as clear as possible, and the danger from meeting teams on the steep mountainous passes will be largely eliminated.

Luncheon at Dolph.

The stop for lunch will be made at Dolph, on the summit of the mountains, where the tollgate is located. This point is the dividing line between Yamhill and Tillamook Counties. The lunch at this place will be a sumptuous affair provided by the T. B. Potter Realty Company. During the stop for lunch all of the machines will be examined by a mechanic before starting down the steep mountain grade to Hebo, the next station of the route.

From Dolph the road winds down a steep mountain to Hebo and from this on the route lies along a country composed of heavily timbered rolling hills where the road is said to be one of the finest in the country.

The party will reach Tillamook Saturday evening, and after the machines are stored in a warehouse which has been especially provided, the invited guests of the Potter Company will be served an elaborate

banquet by the Tillamook Commercial Club in the large reception hall.

After the banquet a fleet of launches decorated in the National colors and illuminated by Japanese lanterns will convey the party to Bayocean. Several brass bands have been engaged for the occasion and will accompany the excursion across the bay to Bayocean, where a grand ball has been arranged.

Sunday Pleasures Many.

Sunday will be a day of rest and no functions will be held. Many, however, will spend the day bathing, while others will go fishing or explore the numerous caves that exist about Bayocean. During the entire stay at the resort the members of the party will be the guests of the new hotel which is being constructed by the Potter Company.

Monday will be one continuous round of entertainment, consisting of band concerts, boat excursions on the bay and river, dancing and various other forms of amusement.

Water Carnival Monday.

A water carnival has been arranged for Monday and a regatta in which nearly all the boats along the coast for many miles will participate in. Monday evening another grand ball is to be given and hundreds of dollars' worth of fireworks will be displayed from a barge on the bay.

Reports from Tillamook and Bayocean are to the effect that the people for miles around will be present at the celebration and preparations are being made to accommodate thousands of people.

The return will be made to Portland Tuesday, July 5, the party arriving here in the evening.

Trial Run Made Quickly.

The run from Portland to Tillamook was made Monday by Blaine R. Smith and Frank C. Riggs in the actual running time of five hours and 30 minutes. They left Portland at 1 o'clock in the afternoon and arrived at Tillamook at 8:45 in the evening. Two hours was lost by the machine becoming stuck in a mudhole. The men were compelled to cut down trees and use them as prys to lift the automobile out of the mud, and before they could get the machine on firm ground two hours had been consumed. Fifteen minutes were lost at Willamina while they were taking on gasoline and this time deducted from the time taken for the trip leaves the actual running time five hours and 30 minutes. They report the roads in good condition between Portland and Dolph, but owing to the heavy rains of a few days previous to the trip, the roads from Dolph on were very muddy. On the hill between Hebo and Dolph the grade is 21 per cent and owing to the heavy, sticky clay it was almost impassable. Mr. Riggs says that with a few days' warm weather previous to the run the roads should be in fine shape for the trip down on July 2.

**SHERIFF MAKES CLEVER
CAPTURE IN CITY.**

**Arrests a Man Who Escaped
from U.S. Marshal at Seaside Last Week.**

Just before noon on Friday Sheriff Crenshaw received a message by wire to look out for a man by the name of Fred B. Gray, who had succeeded in getting away from a United States Marshal at Seaside. When the man made his escape he was in his shirt sleeves and wore a pair of light pants. The sheriff promptly devised plans to keep a sharp lookout on persons coming in from the north, and went down to the dock as the passengers were coming off the Henrietta. There appeared to be no one on board answering the description of the man as far as wearing apparel was concerned, but the sheriff sized up one man whom he thought might be the man, who wore a blue suit of clothes and a deer hat. The sheriff followed him to the barber's shop and watched him. The man took up a paper and commenced reading, but the sheriff saw that he was nervous. The man laid the paper down and walked over to Clough's drug store, and after he came out the sheriff accosted him and asked him his business and where he came from. Gray was non-plussed and hardly knew how to account for himself, when Crenshaw invited him to the sheriff's office to talk the matter over. Finding that Gray made so many misstatements, the sheriff told him he would have to hold him and wire the United States Marshal for a full description of the man. While in the sheriff's office Gray paced the floor and made several attempts to leave, but the sharp command of the sheriff not to try anything like that and to sit down soon convinced Gray that he was in the hands of an officer who knew his business and could not be fooled with. After taking Gray to the barber's shop to be shaved, and when about to enter the court house, he owned up and said, "Old man, you've got the right man." Deputy United States Marshal Hammersly, who was on the man's track, was delighted that Sheriff Crenshaw had captured him, and arriving in the city the sheriff turned the man over to him.

The Oregonian gave this account of Gray and his transactions.

The man hunt begun in Clatsop County Thursday morning with the escape of Fred B. Gray, after arrest by Deputy United States Marshal Hammersly, ended yesterday afternoon at Tillamook. Gray was arrested by Sheriff Crenshaw of Tillamook County as he limped into town. Gray was reported to be in a state of collapse following his 55-mile flight. At the County Jail he admitted his identity.

In addition to demonstrating his ability as a long-distanced cross-country traveler, Gray was able to procure a change of clothing while making his dash for liberty. That fact somewhat confused Sheriff Crenshaw in indentifying the man. When he sprang from the cottage window at Seaside Thursday morning, Gray wore gray trousers and a light vest. When arrested he was clad in blue.

Hammersly Close Behind.
Deputy United States Marshal Hammersly was only a short dis-

tance behind Gray. Hammersly arrived at Nehalem, 22 miles north of Tillamook, at about the hour Gray was captured. Hammersly remained at Nehalem over night, after arranging with Sheriff Crenshaw to bring the prisoner to that point in the morning. Hammersly will take Gray back to Astoria. Gray will be arraigned before Commissioner J. F. Hamilton and the examination will be held either tonight or Monday morning.

There never has been a reasonable doubt of the final capture of Gray. He is portly and in poor training for an active climb over the hills. Deputy Marshal Hammersly will be required by the regulations of the Treasury Department incident to the chase of Gray. When Hammersly allowed Gray to elude his custody, the expense account of the officer automatically ceased. Hammersly immediately used the telephone in notifying all peace officers in the surrounding country to look out for Gray and at the same time secured the aid of farmers and launch owners, so that the entire country was well guarded. Hammersly secured a clew Thursday night and procuring the best team to be had at Seaside started on the trail.

Wife is Being Watched.

Mrs. Gray, wife of the prisoner at Tillamook, is under surveillance at Seaside, and is considered to have important knowledge of the transactions charged against Gray. Gray is charged with having operated swindling commission stores at 75 Union avenue, North, Portland, and in other cities in various parts of the country. His plan was to obtain shipments of produce by offering a price in excess of market quotations, and when a large amount of goods had accumulated to sell them and pocket the proceeds. The scheme worked so well in Portland that Gray is said to have netted close to \$10,000.

After being arrested on the street at Seaside, Gray asked Hammersly to take him to a cottage where he was living with Mrs. Gray and her child. It was ascertained that the couple have been married since leaving Portland in March last. Mrs. Gray is said to have aided her husband materially in his escape from the officer.

Man Escapes Through Window.

At the cottage Gray said he would like to procure breakfast and Hammersly seated himself within three feet of the open door leading to the kitchen. He could see Mrs. Gray preparing the meal and heard the couple talking freely. After a while Hammersly noticed that the woman was doing all the talking and he failed to hear the tone of Gray's voice.

"Tell Gray to hurry up with that breakfast," said Hammersly. "All right," responded Mrs. Gray, as she continued her talk and work of carrying food between the stove and the table.

Not hearing the rattle of the dishes on the table, Hammersly walked into the kitchen to find the window up and Gray gone.

"Where is Gray?" inquired the officer.

"I don't know," responded the woman.

While Gray is the first prisoner Hammersly has allowed to escape in 16 years of service as an officer of the law, it is said to be the third time Gray has eluded officers by practicing the same trick. He is

believed to be the man who escaped twice from the United States officers of Pennsylvania, and it is asserted that he made use of the identical plan on both occasions. Gray was arrested on each occasion for conducting swindling commission houses in Pennsylvania and never was recaptured.

Operations are Widely Read.

At St. Paul, Gray established the Johnson & Co. commission house and is believed to have been the manager under the name of Fred G. Braden. At Indianapolis he operated under the firm name of Adams & Co. At Portland he established Gray's Market, and employed O. I. Marshall and his wife as clerks. The Marshalls secured the greater part of the assets of the business after it failed.

Marshall established the business at Seaside and asserts that he employed Gray to run it. Marshall says that he is a newcomer from Oklahoma, and has furnished references to the officers, who are now checking his story. Marshall says that he was honestly working for Gray on Union avenue, North, and that he has never been connected with any of Gray's previous operations.

Additional victims of the operations of Gray in Portland were discovered yesterday in Allen Bros., of Benton County, who shipped produce to the amount of \$110, and E. J. Howe, of Divonville, who asserts that he supplied goods to the extent of \$127.

Members of the Portland Merchants' Protective Association, whose names are withheld by Secretary Sabin, have accounts against Gray amounting to \$1500.

Attorneys for the association are unanimous in the expression that Gray is one of the smoothest swindlers they have encountered in years. His address is excellent and he has no trouble in obtaining large bills of goods and securing their delivery from some of the most conservative houses in the city.

The Primaries in Polk County.

Harmony, good-will and earnest interest in the welfare of the Republican party characterized the primaries held in the several precincts of Polk County, Wednesday. The attendance in each precinct was large and proved that there are yet many Republicans in the county to whom party principles and party success mean something—Republicans, who, while desiring clean politics and an untrammelled ballot, are not willing to see the party of Lincoln and Blaine and McKinley scattered and disrupted by a strained and foolish interpretation purposely placed on the primary law by Democrats and Populists.

Republicans who attended these primaries well knew that they were violating neither the letter nor the spirit of the primary law. These men respect the primary law as a law of the State of Oregon, whether they personally endorse it, or not; but while obeying this law, they reserve the right to exercise their own intelligence in interpreting its meaning. They refuse to see restrictions in the law that are not there. They well know that the final word as to the fitness of candidates will rest with the voters at the September primary election and that all that an assembly can do is to consider the fitness of aspirants for office and recommend

to the favorable consideration the voters such men as it behooves to be worthy of support. No word can be found in the primary law forbidding such a procedure.

The primary law itself is a menace to party. It is only strained and false construction of the law by cunning and designing schemers that can be held responsible for the destruction of an organization in this state. This is so well understood by the people in general that it needs no explanation. Demagogues and political self-seekers have sought to pervert the law a meaning it does not possess, and it must be some admitted that they have, in a measure, been successful. They led many voters to believe that political party is a thing of nothing that anything resembling party organization is a "machine," the men who aspire to leadership in politics are corrupt; that the primary law forbids all meetings of political nature, and that no candidates for office can be selected in a free-for-all scramble for the pie corner.

This is the argument that has been used in Oregon under guise of supporting the primary law. It is the argument that has been used by the Democrats and Populists to disrupt and scatter the forces of the Republican party. It is the argument of credited and discarded politicians in the Republican party who have been thrown out of office and are trying to get back at it. It is the argument of demagogue and the shyster. Republicans are done with it. It will be influenced by it no longer. The only wonder is that they have listened to it as long as they have.

The assembly will not destroy the Republican party. On the contrary, it is the one thing that will preserve the party. The Democrats pretend to believe that they will wipe the Republican party of existence. They do not know anything of the kind. They know that their only hope of success in keeping the Republican party in a disorganized condition, they know further that the assembly will do more to strengthen the disrupted majority party than any other influences combined. This is why every Democrat opposes the assembly. And that is why the Republican should favor the county Observer.
