**P.R. & N. CO.'S RAILROAD COMPLETED IN JULY.**  
**Large Amount of Material Shipped from Portland.**  
 Delivery of 45 miles of track and other equipment for the Pacific Railway & Navigation Company's line from Hillsboro to Tillamook Bay points has been completed by the tug George R. Vosburg in towing the barge Nehalem and the stock awaiting shipment here has been practically cleared. President E. E. Lytle yesterday said that he was positive the rail line would be operating August 1 and that every effort was being made to open the line July 1.  
 Weather conditions that held back the delivery of equipment by water during the winter also worked a hardship on the construction force and snow is yet so abundant on the summit that during the past week the grading crew was forced to shovel the right of way clear for a distance of one mile. The fact that the gasoline yacht Bayocean is to be operated between Portland and Tillamook after June 1 is not feared as a competitor for passenger business, as the train service will be so much more rapid and afford a daily schedule against two or three sailings a week of the Bayocean.—Oregonian.

### NEHALEM'S \$20,000 FIRE.

#### Fire Started in Tohl Hotel Wipes out Half the Business Houses.

One of the worst accidents by fire that has happened in this county for a number of years occurred Wednesday afternoon when about one half of the main business section of Nehalem, the most progressive little city in the north end of the county, was destroyed by flames. The fire started at about 1:45 p.m. in the roof of the Tohl Hotel and was first seen by Mrs. W. J. Stephens, who with her husband, had just had dinner in the building. There being a strong northwest wind blowing and the tide being out, which made it impossible to secure water, the flames held full sway and were soon sweeping away the entire Post Office Block.  
 The total loss amounted to something like \$20,000 with but \$7000 insurance. The main losses were: The Tohl Hotel, loss \$7000, insurance \$4,500; the Nehalem Drug Co.'s store, belonging to D. Morrison, together with the Telephone exchange, which was located within the building, loss \$2,500, no insurance; the U. S. Post office from which nothing was saved; the building of L. P. York, general merchandise, whose loss was \$4,000 with \$2,000 insurance; and three residences which were caught in the path of the flames. The flames also swept across the street and consumed the butcher shop, the saloon of S. V. Leabo, which was insured for \$500, the loss being \$1500, and a houseboat belonging to Mr. Linkhart.  
 The streets, which were made mostly of planking, were consumed by the flames.  
 Had it been a few weeks later the flames might have been stayed, as a water system is being built to that city.

### Commercial Club Meeting.

The monthly meeting of the Tillamook Commercial Club was held on Monday evening, and there was a large attendance, it being thought by some of the members that it was the annual election of officers, which does not take place until the fourth Monday in April. Treasurer Walton stated that all bills due had been paid and there was a balance on hand. The question of bay and harbor improvements came up for discussion and two letters were read from Russell Hawkins, of the Whitney Co., and discussed as were some statements made by Captain Schrader. The club passed a resolution expressing its confidence in the Port of Tillamook. President Holmes called upon M. C. Banfield, of Portland, who was a visitor to the club that evening, for a few remarks. Mr. Banfield created some enthusiasm by stating that he thought they should not depend upon the government for assistance but do the harbor improvements themselves. It was his experience when he was a member of the Port of Portland, that the government was too slow in accomplishing anything. He believed that with a proper dredge it would cost a comparatively small amount of money to dredge a channel from this city to the bay, and that they should go right ahead and improve it. As to which jetty should be built, and which channel was most suitable, he thought that the judgment of men like Captain Schrader was more valuable than the opinion of those who did not reside here.
