**BAYOCEAN MAKES FAST
TRIAL TRIP.**

**New Boat for Run to Coast
Surpasses Expectation
of Her Designer.**

Making a mile in excess of her contract requirement and traveling four hours without a hot bearing, the trim passenger yacht Bayocean, which left Supple's yards at 2:30 o'clock yesterday afternoon, returned at 6:30 o'clock, after a spin to a point a short distance below Reeder's. The trip was purely a builder's trial, as she had not been tested except for a short time Friday afternoon, and then with but two of her three gasoline engines. Her best speed was 17 miles an hour.

While Captain Hirsch acted as master of the vessel, she was virtually run by Fred Ballin, her designer, and A. B. Rober, of the Rober Machinery Company, which had the machinery contract. A few guests were aboard, including T. I. Potter, and Fred P. Baumgartner, representing the S. Elmore & Co. interests. As soon as the vessel can be placed in readiness, she will go on the Portland Bayocean route.

But one feature tended to interfere with a full trial of the machinery for the entire time; the exhaust was not carried off as expected, and slight changes are necessary. The water found its way to the main engine and prevented a free ignition for a short period. Mr. Rober expressed himself as satisfied with the showing and confident that the Bayocean will reel off better time when her engines have been thoroughly adjusted and bearings worn down, which will follow naturally after a few trips.

Little Vibration Noticed.

In establishing the water line, Mr. Ballin's calculations were approximately true, and in the model of the Bayocean, he says it will be proven that she is a good sea vessel, but one-third of her displacement being in the water. While her three engines were working and as many propellers revolving, there was little vibration noticeable. Each engine which is of the Speedway type, reeled off approximately 500 revolutions. The main engine is of 175-horsepower and the port and starboard engines each 150.

The main engine is air-starting and air-reversing, while the others are air-starting and have clutches for reversing. There is an auxiliary engine for electric lights, for which provision has been made for 120, while the same gear pumps from the blige and furnishes pressure for the fire pumps. A fresh water capacity is provided with 2000 gallons and other tanks will care for 2500 gallons of gasoline. It is estimated that with all engines working, 50 gallons of gasoline will be consumed each hour and her tank supply will last for two round trips.

Officers Are Experienced.

Captain Hirsch came here several years ago as mate on the liner Numantia, and until recently he was on tugs of the Port of Portland at the mouth of the Columbia. First Officer Vickman has been signed on the Bayocean, and in the engine-room Eugene Weideman and L. H. Campbell will preside. With the deck crew, oilers and those in the steward's department there will be a crew of 15 and the sailors are garbed in true yachtman's style, having white duck uniforms for fair weather and blue for other occasions. The officers are uniformed also.

In operating the Bayocean, an effort will be made to handle the tourist and regular beach classes, there being berth for 51 persons. Besides there are six extension berths that can be utilized in the after cabin and with her saloon and galley arrangement, she can care for a large number of daylight trips. Mr. Supple has about completed his contract and when the vessel is ready, she will leave here two evenings each week, making her third trip Saturday mornings.—Oregonian.

On any such acre weeds may grow sufficient to "seed down" a township and to increase the labors of the whole farming population. The broad acres of uncultivated land which form so large a percentage of Minnesota farms are a standing indictment of systems of land ownership and taxation, as unreasonable and unjust.

No man should be entitled to hold more land than he can fully cultivate or make otherwise useful to the community; as, for instance, in the growing of timber trees or in the maintenance of a well-stocked fish pond. Idle land should be so heavily taxed that nobody could afford to keep it out of use,—it must be "Cultivate or sell." But instead of observing this just rule, we punish with heavier taxation the farmer who improves and enriches his land and let off with a nominal taxation the owner of idle acres.
