BAYOCEAN WILL START WORK ON SOUTH JETTY

If Port of Tillamook will Follow Up the Work—Offers Use of Dredge for Harbor.

On Tuesday evening H. T. Botts, James Walton, Jr., and M. F. Leach, representing the Port of Tillamook, accompanied by Webster Holmes and Geo. W. Willett, president and secretary of the Tillamook Commercial Club, and Fred C. Baker, representing the Press, went to Bayocean at the invitation of Mr. I. B. Potter, where the party was entertained and partook of dinner. The object of the visit was to discuss bay and harbor improvements. Mr. Potter in expressing his views on this subject, advocated the three Ports getting together and deciding on some plan of action, and then go ahead and do the work without waiting for the government. He was strongly in favor of the south jetty being built first, and stated his reason for so doing. He made a proposition to the members of the Port of Tillamook that as soon as the Port of Bayocean was organized, they would bond for \$100,000 and appropriate that entire amount to the bar and start work at once on the south jetty, provided the Port of Tillamook would carry on the work where the Port of Bayocean left off. He also agreed that the Port of Bayocean would open up the Sturgeon channel to the jetty and meet the Port of Tillamook there, the T. B. Potter Realty Co. turning over their dredge, free of charge, to the Port of Bayocean to carry out the harbor improvement. The question of the north jetty, which is favored by the
