A replevin suit was up for hearing in Justice Stanley's court Thursday morning in which James Tone sought to recover possession of a milk wagon from R. R. Roberts. It seems that Tone had Roberts fix the top, and that Tone refused to pay the bill amounting to \$55.

One of our subscribers has it figured out that the solcons in the county are taking in one-third of what the cheese product is worth and nearly as much as was raised by taxation last year. Which proves that a large amount of money is diverted from other businesses.

The mail on Sunday was delayed on account of an accident and a runaway in the mountains. The tongue of the stage broke and one horse went over the grade on Saturday and it was Sunday morning before mail and passengers arrived at Trask and it was noon before it reached this city.

Fire destroyed L. L. Osborn's house and part of the furniture on Tuesday at noon. This is what is known as the Kelo place on the Wilson river north of the city. Mrs. Osborn was using a lamb curling her hair, when it exploded, setting fire to the place. Neighbors hurried to the scene as fast as possible and succeeded in saving some of the furniture and while helping, Rev. B. E. Emerick lost his hat in the fire. The house and furniture were insured for \$4,500 in the Aetna.

The T. B. Potter Realty Company has filed suit in the Multnomah Circuit Court to recover \$4000 and interest from July 24 from the Economic Marine Insurance Company, the Property Insurance Company, the Anglo-Scottish Insurance Company and the Lloyd Underwriters. The amount is the face value of an insurance policy covering the launch Richard which was burned while tied to a dock at Bayocean, July 2. The companies have refused to pay, the complaint asserts.

Booze was the cause of another fatal drowning on the bay on Thursday night. William Renick and Ben Centers, who fished for the Elmore Packing Co., were intoxicated that afternoon and evening, and about eleven o'clock that night their boat drifted onto the beach at the Life Saving Station, with only Centers on board. He knew nothing of what had become of his partner, but had a slight recollection of hearing Renick fall into the water. There was nothing to indicate that the men had had any trouble, and the supposition is that he fell overboard and was drowned and that Centers was not in a condition to render him assistance. Nothing is known of the man's home or relatives.

Some surprise was caused amongst the members of the Presbyterian Church on Thursday morning when a letter was received from Portland stating that the Rev. E. L. Jones who had accepted the pastorate of the church in this city and was to be ordained, had decided not to return to Tillamook and that it was his intention not to remain in the ministry. Mr. Jones left last week to attend the Presbytery and he was expected back on Wednesday with his wife. The ladies of the church feel greatly disappointed as they had provided a great many things for their comfort. There will be services, however, in the Presbyterian Church next Sunday, when Rev. Mr. Milligan will occupy the pulpit.

TOM KELLOW IS SHOT.

Night Watchman Wilt Pulled Gun to Defend Himself.

Soon after one o'clock on Tuesday morning a shooting scrape occurred on Main street, opposite the Ramsey House. Night Watchman Wilt was taking a man by the name of Mike Reade to his room, who was partly intoxicated. Tom Kellow appeared on the scene and Reade made the remark that he supposed if he was as drunk as Kellow the officer would run him in. Wilt asked Kellow if he had a room and he said he did, when he was advised to go to it. Wilt took him by the arm to assist him when Kellow used abusive language and began fighting. Wilt pulled his gun, which was a 32 automatic revolver, and Kellow grabbed the wrist of the hand which had the revolver in and commenced beating the officer with the other hand. Wilt fired once, but the bullet did not take effect, and he shot again. The revolver ranged downward, and the bullet entered the stomach, grazed the bowels, went clean through the hip bone and came out at the back of the right leg. He was taken to Dr. Boals' hospital on a stretcher, where he was operated upon to ascertain the injuries he had received. It is expected that Kellow will pull through, as he is making rapid recovery.

A strange coincident connected with the shooting is the fact that Marshal Reading clubbed a drunken man, who died from the effects of the fall, Wilt was one of those who severely criticized the marshal.

Mail by Train 1st November.

C. E. Clement, post-office inspector, came in on the stage on Wednesday morning to instruct the post-office staff in the postal saving bank system, but had very little time to do so, as he had to leave on the afternoon stage. Mr. Clement informed us that the mail will be carried on the railroad on the 1st of November, when the P. R. & N. Co. will put a train service on between Tillamook City and Hillsboro. The mail will leave Portland soon after 7 o'clock in the morning and will reach here about two on a slow schedule and the mail will leave here in the morning. All the stage routes east and north of Tillamook will be discontinued, and with the Balm post office discontinued and a new office started at Mohler, all the post offices north of Tillamook will be on the railroad with the exception of Nehalem, the mail for that place being ferried across the bay.

ASSESSMENT FOR 1911.

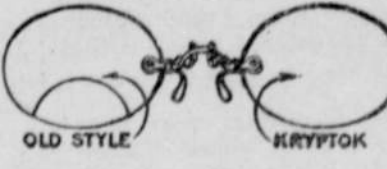
Amounts to about \$15,000,000 --Town and City Lots will Pay More Taxes.

Assessor A. M. Hare has completed the assessment of Tillamook County, which amounts to \$14,345,532, for the year 1911. This does not include about 50 miles of railroad to be assessed by the Railroad Commission, and if this is assessed at \$700,000, this will take the assessment about \$15,000,000. The assessment last year was \$13,920,278. Timber and tillable lands are assessed at about the same as last year, while there is an increase in town and city lots, which now number 32,897, assessed at \$1,113,537, last year \$729,248. The increase valuation in seaside property and the railroad are the two things which increased the assessment over last year, and it is expected that when buildings and other improvements are erected on the numerous places platted to beach resorts, this will help to swell the taxable property, adding probably two or three millions in a few years.
