 County Surveyor Jackson has completed the plans and specifications of the proposed road to Bay-ocena, with an estimated cost of \$40,000. It was at first thought that a 16 foot road would be wide enough, but as it was thought there would be considerable summer travel with automobiles over this road, a 20 road was decided upon. As a large proportion of the road on the bay will be made from dirt dredged out of Sturgeon channel, it will accomplish two things—make a road bed and deepen the channel at the same time. Instead of building the road around the shore at Flower Pot, a saving will be made by putting in a trestle across the mud flats at that place. As this road is to be built largely by subscription and by the property owners, it is expected that bids will be called for next week.

 Have you ever stopped to think long enough to conclude that if every man in the country were as clever and conscientious as yourself we'd have an ideal country? Great thought, that; and that is really the solution of the whole trouble. Personal honesty or dishonesty will make or break nations.
 The nation will live and prosper. It will take time to work out the problem that now confronts us. New problems will appear as our population increases and the country is developed. The solution of these problems, great or small, will be easy or difficult in proportion to the measure of individual responsibility which you and I will accept as our share.
 Let's all do our part.

SHERIDAN WILL BE VISITED
 Extension of Electrification as Far as Tillamook to Be Discussed.
 SHERIDAN, Or., Jan. 24.—Word has been received in Sheridan that D. W. Campbell, general superintendent of the Southern Pacific, will be here tomorrow to confer with the local business men, Council and Commercial Club regarding the matter of electrification of the Southern Pacific tracks from McMinnville to Sheridan. It is generally conceded here that this move is prompted by the fact that the Portland & West Coast Railroad, which has already obtained a franchise through Sheridan, is showing such activity at the present time.
 Mr. Campbell will, while here, discuss the feasibility of extending the electrification of the Southern Pacific to Tillamook, via Willamina and Grand Ronde. The valley towns in this district are considering the advisability of either requesting or petitioning the officials of the City of Portland for better facilities on this line in Portland.
