Two suits were filed in the county court the first of the week, one by F. D. Small and D. C. Urie in which they bring action against Webb Elliott for money due them on merchandise. The other is an action for money brought by Dr. R. T. Boals against L. D. Krake.

A petition has been circulated and freely signed for the construction of a road to Bayocean. The necessary notices have been posted and the petition will be presented at the August term of the county court, with the subscription list, which was circulated some months ago.

R. C. Glover, Secretary to Congressman Hawley, writes: "Congressman Hawley directs me to advise you that the Commissioner of the Bureau of Lighthouses on June 19, 1912, authorized the establishment of seven post lights in Tillamook Bay when funds become available for such purpose. The Commissioner states that 'It appears that, for the present at least, the lights to mark the dredged channel to the Bayocean resort should properly be maintained as private aids by the promoters of the resort, and they have been supplied with blank applications for this purpose. It is believed that the proposed aids when established will meet the needs of navigation in this locality.'"

The Executive Board of the Tillamook Commercial Club met on Monday evening at the club rooms, when two matters of interest to the public came up. The first was in regard to the site at Garibaldi for a motor life boat for the life saving crew. As it is necessary to raise \$600, the committee, Messrs. C. I. Clough, W. C. King, Carl Kundson and Webster Holmes recommended that as J. J. McCormick had agreed to donate \$50, each of the commercial clubs do the same, and with help from the shipping interests it was thought the money could be raised in that manner. The Board ordered \$50 to be drawn from the club to go towards the site.

In regard to 100 acres of land for the Oregon National Guard, to hold their summer encampment, it was stated that this could be obtained east of town, but as there are several patches of oats on the land the committee will have to make arrangements to take this over at a cost of \$380.

Johnson Brothers Drowned Off Nestucca Bar.

At about five o'clock on the morning of July 3rd Warren and Jim Johnson, who resided near Meda, ventured too near the Nestucca bar in a small boat and were carried out by the outgoing tide beyond the bar, where their boat upset.

Their dog, which was with them, swam ashore, and the paddles of the boat drifted ashore.

The anchor of the boat dropped out and held the boat when it upset.

The boys' bodies had not been recovered up to the time of our going to press.

Fracas at Pacific City.

Word was received here at noon this Friday in regard to a fight and stabbing affray which took place at Pacific City during the forenoon.

It seems that Henry Brooten, Jeff Fleck, Ben Via and others of that vicinity got mixed up in a free-for-all fight over a dispute in regard to some race purses that had been contested for, and that Deputy Sheriff Dwight Edmunds was seriously pounded and bruised up trying to restore order.

After the first fight Henry Brooten is reported to have stabbed Jeff Fleck in the back near the shoulder blade, injuring Fleck very seriously. Sheriff Crenshaw and Dr. Wendt were sent for and immediately departed for the scene of the disorder.

Sheriff Crenshaw, who was hastily summoned to Pacific City, returned in the evening in company with Deputy Sheriff Edmunds and Henry Brooten to arrange for bringing Jess Fleck before the Justice of the Peace on the charge of assaulting an officer. Fleck is reported to be badly cut and is confined to his bed. No arrest has yet been made.

The difficulty is said to have grown out of the Fourth of July celebration. Fleck, having been drinking freely on the Fourth, challenged Brooten to a fight and came to the home of Edmunds, where Brooten was working, on Friday morning, bringing with him a number of his friends. This man clenched and Brooten, who had a knife in his hand, cut Fleck under the shoulder blade.

Edmunds, who attempted to interfere, was set upon by Fleck and some of his friends and beaten up, but not seriously injured. He had sworn out a warrant for the arrest of Fleck. It is thought the attack on Edmunds is the result of his attitude in fishing cases about Neatucca Bay.

His Grace, Archbishop A. Christie, of Portland, will arrive in Tillamook on Saturday, to administer the sacrament of Confirmation the following day to a large class of Catholic children. A special delegation will meet him at the depot and welcome him to our city.
