Trickery of Port of Bay City in Annexing New Territory.

Another petition has been filed with the County Court to annex more territory to the Port of Bay City. The new petition embraces all the territory left out of the previous petitions (outside of the territory embraced in the original Port of Tillamook, which take in Tillamook City and fifty feet on either side of Hoquartion slough to Drystocking bar) that was included and had not been petitioned for or annex which belonged to the Port of Tillamook). Consequently there are two petitions and there will have to be two elections and two ballots to annex territory which is adjoining. There is trickery in the whole scheme, as the boundaries of the two petitions plainly show, for one petition embraces and circles round land where there are no residents, and the other petition is to annex the territory where there are settlers. If the Port of Bay City wanted to act square and white with the citizens of this county, it would and should have, included all the land in one petition, as it all adjoins. The County Court has ordered a special election for November 30th on both of these petitions. Following is the territory embraced in the last petition:

Beginning at the Ne corner of sec. 17, tp. 1 S., R. 8 W.; thence S to the Ne corner of sec. 20; thence E to the Ne corner of sec. 22; thence S to the Se corner of section 22; thence E to the quarter section corner common to sections 24 and 25; thence S. to the quarter sections corner of sections 25 and 30; thence W. to the quarter section corner common to sections 30 and 31; thence S. to the quarter section corner common to section 31, tp. 1 S., R. 8 W. and sec. 6, tp. 2 S., R. 8 W.; thence W. to the Nw corner of sec. 6; thence S. to the Se corner of sec. 13, in tp. 2 S., R. 9 W.; thence W. to the Sw corner of sec. 14; thence N. to the Sw corner of sec. 14, in tp. 2 S., R. 10 W.; thence N. to the Sw corner of sec. 2; thence W. to the Nw corner of sec. 3; thence N. to the point where the section line between sections 21 and 22, extended north intersect the shore line of Tillamook Bay; thence N. along section line extended to a point where same intersects the W. boundary of the Port of Bay City; thence southerly and easterly along boundary line to where the same intersects quarter section line running N. and S. through secs. 11 and 14, tp. 1 S., R. 10 W.; thence to the center of sec. 14; thence E, along the quarter section line running E. and W. through secs. 14 and 13 and sec. 18, 17, 16, 15, 14 and 22, extended north intersect the easterly to the Ne corner of sec. 17, tp. 1 S., R. 8 W. to the place of beginning; same and except from the above described territory the following: The present Port of Tillamook which is bounded and described as follows: All that part of City of Tillamook County embraced within the corporate limits of City of Tillamook on the 2nd Feb., 1899, and fifty feet on each bank of Hoquartion Slough as it was situated on the 2nd Feb., 1899 from the E. boundary of City of Tillamook westward to and including Drystocking bar.
