#### Accounting For It.

On a vote that, according to the official returns so far, is smaller than that given Mr. Bryan in any of his three campaigns, the Democrats gained nearly all the states by plurality. The Republican party, for the second time, rejected a third term movement in convention. It will be applauded in political history for fidelity, at any cost, to a vital national safeguard. At the same time every one of the time honored principles remain unchanged. Protection was a leading issue. Both the Republican party and the third party indorsed in their platforms. More than two-thirds of the voters of the United States are for it. It will eventually be established and stand unchallenged. Back of these facts is a condition of unrest not yet satisfactorily explained. One writer on the election says the American people are subject to periodical waves of hysteria. A former example is the free silver crusade, which no Democrat cares to mention now. Mr. Wilson himself voted for the gold standard in 1896.
