

FOR HARBOR IMPROVEMENTS.

Resolution Introduced in the State Legislature.

Senator Hollis and Representative Handley introduced the following resolution in the Senate and the House:

WHEREAS the completion of the Panama Canal emphasizes the importance of the improvement of every harbor on our coast line from the Northern boundary of the State of California to the Columbia River, and

WHEREAS there are many bays along the Pacific Coast capable of becoming splendid harbors, particularly those of Tillamook Bay, Yaquina Bay, Coos Bay, and others, each of which with a comparatively small cost to the Federal Government could be made ports of entry for all Coastwise vessels as well as those of deeper draft, and

WHEREAS tributary to these harbors are millions of feet of lumber in our matchless forests as well as large sections of agricultural land capable of producing great harvests, to say nothing of the products of our mines and our streams, all of which must reach the markets of the world through these channels, and

WHEREAS each of these harbors are now in direct rail communication with other parts of the world whereby a proper distribution of commerce and the assembling of the products may be maintained, THEREFORE Be It Resolved that the Senate, the House concurring, memorialize our representatives in Washington and request them to earnestly urge Congress to improve these ports and water ways and secure necessary and ample appropriations for the immediate improvement of these harbors that will open them for at least all Coastwise vessels so that the products of our forests, our mines, and our soil may thereby reach the world's markets.

Some of the Results.

It was to be supposed that the results of the trial at Indianapolis would assist in purging labor unions of some of the leadership that has and is now afflicting it, and affecting its future welfare most vitally, but the aggressive leadership, such as P. H. McCarthy, Eugene C. Cancy, and other precocious ruffians, who are always in the forefront in labor's ranks, have delivered themselves of furious pronouncements denouncing the trial at Indianapolis as a conspiracy, denouncing the court, denouncing the jury and everybody connected. That is not peculiar to the McCarthy's, and Clancy's of the Pacific Coast, but belongs to the same ilk everywhere, and they stand by their associates right or wrong, for reason or against reason. Their main reliance is upon threats of force, intimidation and bluster to carry their program through with their supporters and dupes at any rate, if not with the general public.

How far reaching the program of the self-styled leaders of unionism is going to be commended by the rank and file remains to be seen, for in the final analysis those who pay the bills of operating the union machinery must and will have some say. All who participate in the unionistic scheme are surely not lost to the common standards of decency, law and mercy. Yet in late reports from San Francisco, at a meeting of the San Francisco Building Trades Council held on January 1, it is a matter of record that the following resolutions were passed by unanimous vote: "Resolved, That we request every local union affiliation in this city and state immediately to request their national organization to assist financially to the end that proper presentation may be made to the appellate court for a new trial.

"Be It Further Resolved, That in reply to the question asked by Mr. Drew, 'What are you going to do with the Iron Workers' Union' and as a protest against the criminal and dominating power of the United States Steel Trust, we favor the sentiment now strongly maintained throughout the country for the declaration of a general strike throughout the length and breadth of this nation."

So it seems that San Francisco the hotbed of unionism and unionistic aggressions and methods for a good many years past, is the first to take up the cudgel in defense of the arch-conspirators and traitors to the country who were recently convicted at Indianapolis, and this in the face of overwhelming evidence as could not be refuted. This is in line with many things we have heard and known of the operations of the union labor political machine, and perhaps the move is instigated by McCarthy and his lieutenants in the hope that in the general melee of a strike throughout the country and the resultant civil war their own precious necks may be saved because the attention will be detracted from them. This is the manner that kings of old and quite recently have had of involving their country in wars and disputes when their own short comings were questioned too much by the people, and perhaps the McCarthy and Clancy labor lords, who have been ruling labor unions with an iron hand for a good many years past, will be successful in doing the same stunt. Let us see.

To Bring "Blind Lighthouses" In Touch With the Outer World.

There was a time when the keepers of lonely lighthouse stations were greatly to be pitied and when some went insane from solitude. Soon these men will be in touch with the affairs of the world and learn the news as quickly as the man who reads the latest editions of the newspapers.

For it has been proposed that in some of the lighthouses along our coasts a wireless equipment should be installed and supplement the work now done by the beacon light. The advisability of doing this is being carefully considered by government experts, and tests are being made with these "blind lighthouses," as they are called.

This plan seems very reasonable. Today these great land beacons throw out a flash signal or sweep of light, so that a vessel can recognize a particular lighthouse miles at sea. In very clear weather the most powerful of these lights are visible upward of forty miles, most of them, however, having a much shorter range.

A warning by wireless may, of course, be thrown hundreds of miles to sea, telling a vessel many hours in advance that she is approaching a dangerous coast. Nor is this all, for in the experiments now being carried on these wireless signals do more than warn ships at sea of the perils of the shore—they actually enable a ship to calculate its exact position, even should it be in the midst of the thickest fog or most blinding storm. The wireless or blind lighthouses flash their position, and the master of a ship receiving messages from two or more such points on shore can readily figure out his own position by a simple process of triangulation.

Such an extension of the wonderful system of wireless communication makes us realize that we have probably only begun to enjoy the benefits that this great discovery is destined to confer on humanity.—Francis A. Collins in St. Nicholas.

FEARFUL FINANCIAL BURDEN IT PLACES UPON THE GREAT NATIONS.

Since 1800 the war debts of the nations have grown by leaps and bounds. That of Europe as a whole amounts to more than \$26,000,000,000 and interest at the rate of \$1,150,000,000 per year. All these "endless caravans of elephants" represent sums which have never been paid, will never be paid, can never be paid, so long as the present system of national armament goes on.

At the present rate of expenditure the four countries of Germany, France, Great Britain and the United States will spend in the next forty years, the life of one generation, for the support of armies and navies an amount sufficient to build 20,000,000 country and village houses at an average cost of \$2,500 each.

With father, mother and four children in each of these houses they would furnish homes for 120,000,000 of people, which is more than the total present population of these four countries living in villages and the open country.

Thus the fear of war is consuming the homes of the rural and village population of these great nations in a single generation.—Albany Times-Union.

The Cement Gun.

There is a cement gun which is used to apply a mortar covering to structural steel work. A mixture of dry sand and cement is shot from a nozzle by compressed air. A second hose delivers to the same nozzle a supply of water under pressure, and the mixture of sand, cement and water is shot out with a velocity of about 350 feet per second. The nozzle is arranged to produce a thorough wetting of the material. As the mixture strikes the surface to be covered the coarse sand grains rebound until the fine cement mortar, which adheres immediately, has formed a plastic base in which the coarse particles become embedded. A covering of any required thickness is then rapidly built up. One of these guns has been used on the Panama canal in covering the sides of the Culver cut with cement to prevent the unstable earth from sliding into the canal.—Harper's.

Royalty and the Opera.

The Berlin opera costs the kaiser 1,000,000 marks a year. He bears the loss without indulging in any agonized wails. The Austrian emperor is not far behind Kaiser Wilhelm, for he gives more than \$150,000 a year to help out the opera, besides \$100,000 for the playhouse. The royal subvention for the opera house in Munich is 620,000 marks; in Dresden, 450,000. Even the grand duke of Hesse uncomplainingly pays 210,000 marks annually to keep the theatrical and operatic performances at Darmstadt on a high level.

A Queen's Telephone.

The queen of Spain possesses what is said to be the most remarkable telephone in the world. It is of solid silver with a gold transmitter and is supported by four bronze figures, among which a boy leaning against a Spanish coat of arms is conversing by telephone—a golden wire—with an English girl in close proximity to a British lion. Above the mouthpiece are two goddesses. This work of art stands on her majesty's writing table and connects with the royal nursery only.
