## Gives Counties Right To Issue Road Bonds.

Reames bill does not provide for adhered to. the calling of conventions to decide what roads shall be built or the amount of bonds to be issued. His bill provides that upon petition the County Court shall call an i election for the purpose of having the people vote bonds and to determine the roads to be built. Another difference is that it provides for the issuance of serial bonds. and that one-twentieth of the sum called for by the bonds issued shall be paid each year.


