THE HADLEY CASE.

Attorney Nolan Alleges Defendants Conspired to Cheat Plaintiff.

In the case of Otelia Hadley vs. C. E. Hadley, et al., Attorney Nolan filed replies to C. E. and D. J. Hadley's supplemental answers which admitted that the defendants paid the plaintiff \$7000 and that Clark Hadley and C. E. Hadley is one and the same person, but denies each and every other allegation. For further reply to the said supplemental answer Attorney Nolan alleges that defendants intended to cheat and defraud the plaintiff and entered into a conspiracy against the plaintiff; that each defendant was to give false testimony at the trial to defeat the plaintiff and deprive her of her dower and inheritance; to cheat and defraud the State of Oregon out of its inheritance tax and to cheat and defraud plaintiff's attorney out of his fee. The answer goes on to state that D. J. Hadley and Maud Sharp became dissatisfied and thereupon demanded of C. E. Hadley that he should immediately make settlement with them and pay them their share of the estate, whereupon all of the defendants further conspired with each other and against the plaintiff to cheat and defraud the plaintiff and to force plaintiff to make some settlement of the estate. In pursuance of the said conspiracy and in the execution thereof, D. J. Hadley called upon the defendant at her home in Tillamook and thereupon represented that C. E. Hadley was having some family trouble and that he liked plaintiff very much and wanted to have her friendship; that plaintiff could not recover and that C. E. Hadley would pay \$7000 as her share of the estate and pay all costs of the suit; that the offer must be accepted and closed at once without notice to plaintiff's attorney, or that C. E. Hadley would refuse to make any settlement whatsoever; that if plaintiff refused the offer all the parties would give false testimony at the trial. Plaintiff, it is alleged, did not know what sum was due her from the estate, and had no means of knowing, which were known to the defendants. Other allegations are set out, it being contended that plaintiff would not have accepted the offer nor have executed the said instrument if she had been given the time to consider and consult her attorney.

This is a case where the plaintiff, without consulting her attorney, accepted an offer from the defendant whereby she was paid \$7000, and now Attorney Nolan is endeavoring to obtain an attorney's fee of
