To show its hospitality and appreciation of the visit of the Third Regiment, Oregon National Guard, to this city, the Executive Board of the Tillamook Commercial Club thought it would be a treat to give the boys a mess of clams and a sample of Tillamook's famous cheese. On Wednesday evening two tons of clams, in two drays, were taken to the camp grounds and distributed. A delegation from the club accompanied them, and on Friday morning the club sent several cases of cheese to advertise the home product. When President F. C. Baker and Dr. S. M. Kerron, chairman of the entertainment committee, called upon Colonel Martin, he authorized Chaplain Gilbert to make the apportionment of the clams and cheese when told what the club proposed to do. He was greatly pleased that the club had taken such an interest in the regiment and thanked the officers of the club.

## THE PAVING CASE. Engineer Richardson Is Unreliable Witness.

Since Monday morning the interest of citizens and taxpayers has been centered at the courthouse where the suit of certain interested property owners against the Warren Construction Co. and the City of Tillamook is being heard before Circuit Judge Campbell, of Oregon City, in an injunction suit to restrain the city council from making an assessment for street paving.

The case promises to be one of the most notable ever tried in the courts of this county, both by reason of the amount of money involved in the issue, and because of the sensational nature of some of the charges made by the plaintiffs. Collusion and corruption of city officials, violation of contract and general fraud and misrepresentation are some of the charges that those who have been most active in promoting the litigation have openly and persistently promised to prove to the full and complete satisfaction of the public and the court. Up to the time this is written these charges and the proof of them have failed to materialize, and the showing made by the prosecution has been little less than farcical.

A notable array of counsel is engaged in the trial of the case, both for the plaintiffs and for the defense. The plaintiffs are represented by Ex-United States Senator C. W. Fulton, Tongue & Tongue of Hillsboro, Bagley & Hare of Hillsboro and Forest Grove, and some others less noted but perhaps none the less learned. On behalf of the defendants the City of Tillamook is represented by Ex-United States Senator John M. Gearin, while the interests of the Warren Construction Co. are being cared for by James Head, of Boston, counsel and vice president of the company, State Senator Dan J. Malarkey, Richard W. Montague, C. W. Huntington and others. Such a galaxy of legal lights has never before been gathered together under one roof in this county and the spectacle is one well worth the price of admission, which is free.

In his opening statement to the court on behalf of the defendants Attorney Malarkey offered for record an undertaking on the part of the Warren Construction Co. to execute to the City of Tillamook a guarantee, protected by a sufficient bond to be approved by the city, insuring the pavement laid on city streets for a period of ten years. Mr. Malarkey stated that his clients had certain knowledge of the character and durability of the pavement laid here, and to show their good faith they are willing to voluntarily increase the guarantee period from five years, as provided in the contract, to ten years, knowing full well that the character of pavement laid here would justify even a longer guarantee period.

While the sensations promised by the plaintiffs have not been forthcoming, the case so far as it has progressed has not been without incidents of a dramatic nature, each in its own way being a distinct shock to the prosecution and apparently completely satisfactory to the defense. The first of these was the highly entertaining and perfectly good grilling to which Ex-City Engineer Richardson was subjected by Attorney Malarkey, which said grilling, when completed, left Mr. Richardson in a state of total eclipse. The other notable incident was the withdrawal from the case of five of the plaintiffs, they appearing by special counsel, M. J. Gersoni, and petitioning the court to be relieved of further participation in the case. It seems to be generally understood that the withdrawal of these parties is but the beginning of a long list of similar requests, as it is known that many of those named as plaintiffs have expressed dissatisfaction with the circumstances under which they were induced to become parties to the suit and now desire to be relieved of the financial burdens of a litigation that promises to be costly and long drawn out and which, as now begins to appear, has been promoted for selfish reasons by foreign interests and a few local speculators.

One of those who withdrew from the suit, A. L. Perry, filed an affidavit with the court declaring that he had never authorized the use of his name as a plaintiff in the case and had never had and has not now any desire to evade or contest payment of the assessed cost of the improvements. When this affidavit was read to the court counsel for the defendants

suggested that plaintiffs' attorneys be required to show their authority to act for each of the plaintiffs named in the suit, stating that as it now appears that they acted without authority in one instance it might reasonably be assumed that there were other instances of the same character. It is a matter of common knowledge about town that several of the plaintiffs have openly and frequently asserted that their names had been used without their knowledge or consent.

Those who petitioned the court to be relieved from further participation in the suit as plaintiffs are: A. L. Perry, M. R. Hanenkratt, Mrs. Frances A. Bailey Hunter, Mrs. E. B. Stewart and Samuel Vierick.

The grilling of Mr. Richardson, late Consulting Engineer in-Charge for the City of Tillamook, was an incident that failed to materially advance the interests of the plaintiffs, whose star witness he was supposed to be. He occupied an uncomfortable seat on the witness stand for the large part of two days, and the character and quality of his testimony was such as to provoke the court to comment on it in a manner not wholly complimentary to the witness. One of his statements was that he considered the members of the City Council to be either fools or crooks, whereupon he was asked if the fact that the Council had employed him had anything to do with the formation of his judgment on this point.

Mr. Malarkey questioned Richardson something like this: You said in your testimony that Mr. Giebisch intimated that he was to pay Mayor Harter \$3,500, and after he had paid the contractors he would have nothing left on his sewer contract; and you also said you believed the report, and circulated it; that you were employed by the city as a paving expert engineer; that now you say you know nothing about bitulithic paving; that you said that the Mayor and City Council were either fools or crooks. Did you not?

Answer: "Yes, sir."

Question: "Now when you said all that and acted as you did, do you not consider that you yourself are either a fool or a crook?"

Answer: "Yes, sir."

When cornered he was forced to admit that he had no personal knowledge of graft; that his statement had no further foundation on which to rest than rank hearsay; and that he had not even apprised the council of what he claimed to have heard. As a cap-sheaf to his discomfiture he was forced to admit that he had no expert knowledge of paving and that the representations under which he secured employment by the city were in a large degree shams of the facts. It was rather a sorry spectacle, viewed from whatever angle, and his final retirement from the witness stand appeared to be a welcome relief to both himself and the eminent counsel who had hoped to establish their case through his testimony.

Still another witness called on behalf of the plaintiffs and whose testimony proved to be a boost for the defense, was Walter Heinke, a paving contractor of Portland and proprietor of the Rockalite paving process. This witness declared that he had never stated that the Warren Construction Co. had paid 50 cents a yard for promotion of the Tillamook contract;

that such a payment was impossible under the circumstances of the price received for the pavement and the quality and cost of same; and that he knew nothing and had heard nothing that would indicate any questionable transaction in connection with the Tillamook work, the contractors or the city officials.

All of Tuesday afternoon was occupied by the court, counsel and officials in going over the paved streets and making sample cuts at various points selected for the most part by the plaintiffs. In all, 21 cuts were made and the samples so selected were carefully measured under the eye of the court, tagged and preserved to be used as exhibits in the trial of the case. Contrary to the expectations and extravagant claims made in advance by some of the chief promoters of the litigation the samples in all instances, without a single exception, showed the pavement to be from one-half inch to two inches thicker than called for by the specifications.

As the trial of the case progresses it becomes more and more apparent that outside interests, operating through a few local men who are in a position to reap some financial advantage from the situation, have used our local citizens to further an industrial warfare in which this city has no concern and which can only result in injury to the city as a whole and to the individual interests of the great majority of our citizens.

The case is liable to take another week, as both sides have a number of expert and other witnesses.
