A new co-operative company has been organized, The Beaver Creamery Company with a capital stock placed at \$1,000. The incorporators are A. O. Jackson, E. L. Kingman and J. P. Woods. A new factory will be built at Beaver.

Immediately on notice of its approval being received plans will be carried out for beginning the work.—Oregonian.

In reply to a telegram sent by the Tillamook Commercial Club, the Railroad Commission said the railroad was making all possible progress under the circumstances. Mail, six days a week, have been established between this city and Willamina and Nehalem.

F. R. Beals vs. W. O. Chase and Mima M. Chase, and the Tillamook Co. Operative Fish Co., is a suit filed in the circuit court to recover the sum of \$3,000, with \$500 for attorney's fees. On the 18th of February, 1913, the defendants, W. O. Chase and wife signed ten promissory notes payable in ten years at \$300 per annum and having failed to pay the first note plaintiff sues for the whole amount.

Frank Long, sen., et al vs. W. J. Hawkins and J. H. Hawkins is a suit filed in the Circuit Court to recover \$300.37. In May, 1913, the plaintiff's being the owners of the Yellow Fir Saw Mill, entered into a contract with the defendants to operate the saw mill, the latter to pay \$2.50 per thousand for any and all lumber manufactured. Since 1st July, 1913, the mill manufactured 147,752 feet of lumber, for which they have failed to pay the plaintiffs, amounting to \$300.37, which is now sued for.

On Thursday evening the Tillamook Hose Company held its annual meeting, when all the officers were re-elected viz. President, E. J. Clausen; chief, Allen Page; secretary, E. E. Ginn; treasurer, T. R. Monk. Fire Chief Page, who has been one of the most faithful members of the company for many years, complained of the lack of interest taken in the company and for that reason wanted to resign, but he was persuaded to remain with the company, with the hope that the boys would get out and drill and the business men would take more interest in the company.

### WANTS A RECEIVER.

J. P. Worrall's Mismanagement of Hotel Tillamook the Cause of Suit.

A complaint has been filed in the Circuit Court by John Leland Henderson, in behalf of the stockholders, against the Tillamook Hotel Co., a corporation, P. J. Worrall, Anna A. Worrall and Charles Kunze, directors, asking that a receiver be appointed. Defendant Worrall is the owner of 85 shares of stock and Mrs. Worrall 85 shares, which gives them a majority of stock. They are both directors of the company.

It is alleged that P. J. Worrall and wife caused said company to adopt certain by-laws, among which is one section which provides that these may be changed or altered by the board of directors without submitting the change to the stockholders. The original by-laws provided that no indebtedness should be incurred in excess of \$1000.

That under the by-laws the president is the general manager and as such is authorized to transact all the business, including the purchasing of supplies, etc.

That as directors P. J. Worrall and wife voted themselves salaries, Mr. Worrall receiving \$100.00 per month and board, Mrs. Worrall \$35.00 and Hazel Worrall, as secretary, \$25.00.

The hotel was built at a cost of \$30,500, with an additional \$10,000 for furniture. It is alleged in the complaint that P. J. Worrall has been a man of grossly intemperate habits, has been quarrelsome and abusive, not only to the help employed but to guests. So quarrelsome had P. J. Worrall become, he had frequently drawn a revolver and threatened to shoot those with whom he quarreled. He has been almost continually engaged in brawls and disputes, to such an extent that the business of the hotel is now operating at a loss of upwards of \$300 per month on account of operating expenses.

That in addition to the building the company leased from the Tillamook County Bank the upper two floors at a rental of ranging from \$120.00 to \$150.00 per month. To furnish the hotel a mortgage of \$10,000 was placed on the building, which is payable in monthly installments of \$216.40; \$6,000 was borrowed from other sources, and it is believed that the company is indebted in other matters in the sum of upwards of \$1000.00.

The building could be leased for \$400.00 per month, but the defendant P. J. Worrall refuses to lease it, except for an exorbitant rental, to wit, \$600.00 per month.

That P. J. Worrall wholly fails and refuses to keep books, and that in addition to the salary drawn by him as president and manager, wrongfully and fraudulently converted to his own use the money and other property of the company, which he refuses to account for, the result being that the company is without means with which to pay its current expenses or to pay off the monthly installments as they become due.

That by reason of the gross mismanagement of P. J. Worrall the property of the company has become grossly depreciated and the stock of the plaintiff and other stockholders cannot be sold on the market for as much as 30c. on the dollar if the present management is continued.

That the defendant Anna A. Worrall, the wife of P. J. Worrall, is under the control and dominated by her husband, which give him absolute control of the hotel.

That it was the intent of P. J. Worrall to cheat, wrong and defraud the rest of the stockholders, rendering the company insolvent and the stock of the stockholders of little or no value, so that the defendant may be able to purchase it for a very small fraction of the par value.

Wherefore, plaintiff prays that a receiver be appointed for the property and business; that defendants be enjoined from in any way transacting business as directors; that defendants be required to account for all the property and funds received by them and pay the receiver the same; that if it be found necessary to do equity among the stockholders, the whole of the property be sold.

Judge Worrall Made Interesting Talk--Attorney Talmage wants Get Together Spirit.

There was a large attendance of members at the Tillamook Commercial Club rooms on Tuesday evening, the Entertainment Committee having sent out invitations for a "smoker." The enjoyable features of the evening comprised a band concert by the Tillamook Military Band, three round boxing contests, all of which were declared "draws" by the referee, instrumental music by C. W. Thomas and L. V. Eberhardt and interesting talk by Cal Worrall.

The talk of Judge Cal Worrall deserves more than passing notice. His reputation as an eloquent talker and deep thinker, his wide personal acquaintance with public men, his ripe experience in the political, business and social world, enables him to entertain. Speaking of well-known writers who make people laugh, he called attention to their love of morality, home and family, he quoted Mark Twain's beautiful epitaph at his wife's grave, as one of the gems of American verse: Warm Summer sun, shine kindly here,

Warm Southern wind, blow softly here, Green sod above lie light, lie light, Good night, dear heart, good night. He called attention to Riley's favorite poem, "Along 'bust knee deep in June" and many others. Mr. Worrall said that in this age of commercialism and mad rush for gain and gold, that brotherhood was lost sight of, hearts trampled on, homes wrecked, wife and children neglected, hence graft and immorality were increasing. He eloquently appealed for an every day Christian life of morality, honesty, temperance in all things, the practice of the Golden Rule, love of home and wife and children, respect for women and chastity, and that these and only these, brought true happiness, that false ambition led to an empty grave, without a flower, that Fame's crown was only a crown of thorns, that when old age comes upon us, as come it must, when memory lived in the past which each had made for himself, we could not get away from

the life we had lived. Closing, he said "If you see a man in woe, walk right up and say 'Hello,' 'say 'Hello' and grasp his hand." Give kind words and let him know you are his friend and care." Mr. Worrall highly complimented the Tillamook Commercial Club, and said he had not seen its equal in any town many times the size of Tillamook.

This was followed by a Dutch Supper, after which several short addresses were made. These were all to the point and showed that considerable interest was taken in the club. Charles Kunze was the first called on and he took up the question of raising Logan berries in this county. He hoped that the club would devote its next monthly meeting to this subject.
