Some of the Seers Hit the Year Exactly-One Dates Back Six Centuries.

MANY PROPHETS.

An extraordinary number of prophecies have been made with regard to the great European war-prophecies old as well as new-prophecies which are already partly fulfilled. Perhaps that by the Parsian chiromancer Mme. de Thebes, in her alman-nac ion 1914, issued last winter, deserves first mention.

"This year we shall pass through the gravest and most decisive hours. It will be a year especially happy for France, in spite of blood, in spite of tears, and in spite of uneasy omens. Victory! Victory! We have nothing to fear from the trials of fate. France will emerge renewed in strength, reconstituted by war. All is disquieting in the destiny of Germany. The person of the emperor is most threaten ened by fate. It is not the eagle of victory he wears in his helmet."

Mme. de Thebes was curiously cor rect too, in her forcasts of Italian and Austrian events, for she foretold new pope, and great changes with him," and of Austria, she said: "The drama in the imperial valley which I foretold is near to accomplishment. None can arrest the hand of fate."

An earlier dictim of hers appeared in her almanac of 1912. "Germany menaces Europe in general and France in particular. When the war breaks out, hers will be the responsibility, but after the war there will no longer be Hohenzollern or Prussian hegomony. This is all brutality of her political methods. I have said, and I repeat, that the days of the emperor are numbered and that after him all will be changed in Germany. I say the years of his reign. I do not say the years of his life."


"Slavs Heavy With Fate."

Another Parisiam prohetess, Mme. Sybilla, an interview with whom appeared in the Stampa of Turin last January, said:

"The sky of Europe could not be more turbid. On every side the outlook is of blood and war. The hands of the Slavs are heavy with fate. Indeed the hands of all politicians are steeped in fury and dissimulation. An imperial drama is imminent. The German outlook points to profound convulsions. The person of the kaiser is the aim of destiny. I cannot see the rehabilation of European equilibrium until Prussia is re-entered into the limits of a small state. Kansas Women Urge Better Homes.

Making housekeeping a profession as much as stenography, the law medicine and any other profession undertaken by women and the rearing of children with the same care that the farmer looks after his pigs and cattle, is a new plan of the Kansas clubwomen. The Kansas schools have been asked to help the women in their plans and the outline of a course of study to bring homemaking up to a professional rank in the colleges of the state, is being developed by the clubwomen and the State Board of Administration, in charge of the state's educational institutions.

"The home ought to be put on business basis," said Mrs. J. H. Ward of Hays City, chairman of the home Economics Department of the Kansas Federation of Women's Clubs. 'The same business and scientific principals that the men apply to their business ought to be applied to the home by the women. Making homes ought to be as much as a profession for women as engineering, the law medicine, farming and stockraising.

"The home embraces all things. Whatever is good for the home is good for the nation. Make housekeeping an inspiring profession by using brains in your housewrk. It is as important to use time-saving devices in the home as in the factory. Organize the home thoroughly and let each member have his or her work to do as a large business concern does. The kaiser realized that the tactics of Roberts in Afghanistan and also in Abyssinia, were the tactics which govern all military success, whether the number of troops engaged run into the tens or the hundreds of thousands. Information, calculation, and a final decision leading to swift and sustained action-these are the elemental things of war, and they can be shown

as well in one field as another. If any doubt remains of Roberts' true place in the annals of war, the campaign against the Boers in South Africa removed it. Roberts was then 68 years old. Another well known prophecy says that "the kingdom of a ruler who has six sons and who mounts his horse on the wrong side will be swept away.

Three years ago, it is said, the kaiser's horoscope was given in L'Echo du Mervilleux, and the fall of the German Empire was foretold for 1913 or 1914. "If there is war in 1914 between France and Germany France will be victorious," it said.

An Indian Magi, in an almanac published last January, announced: In the month of July, 1914, all Europe will be overwhelmed by a war between the great powers, and terrible disasters will result. But in November a great emperor will lose his crown and hostilities will cease."

A Japanese prophecy dates back as far as 1703. This ran: "When men fly like birds, ten great kings will go to war against each other; the universe will be under arms.'

On the Continent two prophecies are well known. One is called the "prophecy of Strasburg." The other is that of a gypsy women, which is said to have had a great influence with the miser; so great, indeed, that in 1890 Herr von Jagow gave this as a reason why there should be no European war until after 1913.

The apparatus on the premises is capable of going down 1,800 feet. The shale strata indicates an oil formation and it is possible that once the drill passes through this soil, such a lucky strike as oil might be possible and far more welcome than water. Mr. Jannsen has had much experience in drilling wells, sinking proposed holes and making soundings. He says that the shale may extend for another 1000 feet. This information is gained through experience in sinking other wells at different locations along the Pacific coast. The report that oil had already been struck in this well is unfounded.

The railroad company has already erected a 100,000 gallon water tank immediately over the well and hopes to be able to fill it with either oil or water within the next thirty days.
