Editorial Snap Shots.

Who will be the next official to be recalled.

We wish everybody a happy prosperous New Year.

A good new year's resolution for Tillamookers: Cut out the knocking, back-biting habit and boost for the county's development and improvement.

We are glad to hear so many persons express their approval of the County Court in appropriating \$10,000 for the Bayocean road. Justice always wins out in the long run.

Democratic shin plasters have to be placed on notes, mortgages, insurance policies, express packages, etc. The shin plaster party is a peach, but it is all owing to the European war shin plasterers have the gall to tell you.

Let's have a little more civic pride in this city the coming year. Get in and back up the city council and the commercial club and do things. We've had too many drones in the city who never put their shoulders to the wheel or help out.

We heard a disinterested person say, and who knows the policy of the government engineers, that they would never allow a bridge to be constructed from Dean's Point to Wheeler. We have had our doubts about that also.

The people of Tillamook County was pronounced on Tuesday in the recall election when they recalled District Attorney Gersoni and elected T. H. Goyno to succeed him. That should end it and Mr. Gersoni should abide by the will of the people, for it sustains the action of the grand jury.

We are glad to hear so many per- letter from L. M. Kramer in regard to the budget meeting. It was Mr. Kramer who first brought up the matter of having the county surveyed for a State Highway, when he advocated \$500,000 for the road fund being tied up until that time. Although he did not succeed in this respect, he accomplished the object he had in view creating a sentiment for the survey and obtaining the additional money for that purpose. Mr. Kramer is one of those who believe that if Tillamook County is contributing money for the State Highway Commission, the county should be in a position whereby it can get some of the money back. We agree with him.

If the editor of the Wheeler Reporter would take a trip to Bayocean and see for himself the large amount of money spent there for improvements, he would be a booster and not a knocker for that road. The snap shot man boosted for a road from Mohler to Wheeler some few years ago, and no one objected at the cost. But we want to call the attention of the Reporter to the two items of \$18,000 in the new budget for the road from Wheeler to the beach, \$15,000 having been spent on this road the past year. And it is safe to say that the cost of the road will be \$100,000 before it is finished. Surely the south side of Tillamook Bay is just as much entitled to a road as the south side of the Nehalem bay.

Most everybody appears to be perfectly contented with the levy for road work, and the large amount of work to be done in each road district next year. Of course there are a few knockers who would like to cut out some of the road and bridge work but that would raise a rumpus and ill feeling. It is up to the new county court to carry out the improvements in the revised budget in every particular, for that appears to be the will of the people and what they want. One hundred and ninety thousand dollars is a good round sum to expend on roads and bridges next year and most of that amount will be for labor distributed over the county. This should

make a good showing, and we hope that every locality benefitted by next year's road work will appreciate this large expenditure.

The south part of Tillamook County, when County Commissioner Farmer retires to private life next week, will lose a faithful conscientious servant, who has been instrumental in carrying out a number of permanent improvements in that part of the county that are a credit to him and the county. There is this much that can be said of Mr. Farmer. He was no slipshod, make-shift road builder, but believed in and went ahead with substantial and permanent road work. The office of county commissioner is not one of the most pleasant positions to fill, when there are so many grouchy back-biting people to contend with who oppose public improvement in most every shape or form, unless it is right at their own doors. Mr. Farmer retires from office with a good record and the confidence of the people, and we believe he is justly entitled to a word of commendation from the press, for improvements in the roads in the south part of the county is conclusive proof that Mr. Farmer made good and he retires with the respect of his fellow citizens.

We want to give another illustration to prove what untenable positions Bro. Trombley take up politically and how easy it is for one to come back at him. When the so-called progressives were cutting a swarth in politics, our esteemed Bro. was a full fledged progressive and he denounced Republicans who advocated the assembly and assembly candidates. He also called Republican leaders corrupt bosses and that the Republican party was boss ridden. In the recall election this week Bro. Trombley supported an assembly candidate for district attorney, who was endorsed by the Tillamook Civic League, which is just as much a political organization dominated by leaders or political bosses as the Republican party. We don't see any difference, and we contend that both have a right to hold meetings and nominate or endorse candidates for office. But we all know how Bro. Trombley howled a few years ago about assembly candidates. We want to make a passing remark before we close, and it is this: Our contention is that a church dedicated to the worship of God, is too sacred a place to hold political meetings with ring rule bosses dominating it. Nor should a church be used for amusement or to entertain people. This may not be in accord with twentieth century ideas, but we are glad that the Republican party is not using places dedicated to worship of the Divine Being to hold political meetings. Probably Bro. Trombley must think that the bosses in the Tillamook Civic League are sanctified and are a superior class of being to the leaders of the Republican party, hence they can hold an assembly and endorse candidates for office but it is a grievous sin for Republicans to do so. Doesn't this prove that Bro. Trombley is a political hypocrite?

Two Psychological Problems.

There is to be an investigation of the motives of rich men in making bequests to philanthropy, education, science and other presumably useful things. The commission on Industrial Relations, recently appointed, is to take up the exacting work, it is reported, but just how it proposes to go about it there is no hint given. All we are told is that Mr. Rockefeller, Mr. Carnegie, and others who have parted with great sums of money for ostensibly beneficent ends, are to be investigated for finding how they were moved to begin letting go of their accumulated wealth after the habit of accumulation had long been fixed upon them. This is a question which must have forced itself upon every reflective mind.

The appetite for hoarding money, once acquired, is one of the strongest of appetites. The hoarding habit is one of the hardest of habits to swear off, for the reason that it grows with the growth of the accumulation. How a change was ever effected in such hoarders as Messrs. Rockefeller, Carnegie and others, how they first felt it working on them, how they first struggled against it, and how, after a long time, they surrendered to it and began giving away the thing they had always fought for and conspired to get from others—this would be a revelation worth having. It would be turning human nature inside out. Whether it will ever be made or not, is another matter. Should the commission succeed there might be hope of it looking at the inside of multi-millionaires who never do give anything to anybody or any cause. That is another psychological problem.

Three Rivers Creamery Ass'n., By Carl Haberlach, Sec.

In Oregon, there are 400 active saw-mills, employing 18,000 persons, with an annual pay roll of \$12,000,000. Of the 28,000 wage-earners in the state, 64 per cent are engaged in the lumber industry. The capital invested in the industry in Oregon is \$35,000,000 and the mills are producing each year 2,000,000,000 feet of lumber, valued at about \$30,000,000. The standing timber of the state, if manufactured into lumber and shipped in carloads of 10,000 feet each, would fill 37,500,000 cars. Coupled together they would would make a train 28,000 miles long. Nearly two thirds of the persons employed in the state are vitally affected by the industry. A great proportion of the state's business is entirely dependent upon the industry.—Oregonian.

Some things are out of the question of what was hoped to be accomplished by the German naval attack on the east coast of England. Among these can be placed, without ceremony, the one giving it no larger purpose than that of "striking terror to the British heart." In vain have a thousand pages of history been written in red ink, in the dawn of this century, there could be found anywhere a government of such folly. An equal folly on the part of the Germans would have been that of making such a demonstration against English shores for no other purpose than one of showing that the thing can be done. Such an adventure might stir the blood of young navies and midshipmen, and might even appeal to higher officers aboard ship, for all of whom "glory beckoning on to death" is ever a subconscious element in calculating the chances of war. But the men higher up in German counsels, those who have to deal with problems of putting the smaller against the greater number of ships, are not to be suspected of having sent out, across a sea swarming with an enemy's vessels, a squadron for making an attack only on peaceful unarmed burghers in unfortified seaports.

In announcing his break with President Wilson and Secretary McAdoo and Huston over the character of the rural credit system, Representative Bulkley of Ohio declares that 75 per cent of the Republicans will join him in demanding a provision whereby the government itself will become surety for every loan. The subject of rural credits is one of the most important with which the government must soon deal. President Taft often emphasized the necessity for a system under which the farmers of the United States might procure money at low terms and for long periods for the "building of farms." It is recognized that fenced land, even with essential buildings, does not constitute a "farm" in the full sense. Nor can a farm be made in two or three seasons. It requires years of work and the expenditure of considerable money to prepare a farm for such productivity as that of the "worn out" land of France and Germany. Mr. Herriek, who recently returned from Paris with such bright laurels, was especially charged by President Taft to investigate the rural credit system of France. Commissions and individual congressmen have likewise studied the problem.
