### COMMERCIAL CLUB MAKES NOMINATIONS.

#### Take Lively Interest in Bayocean Road and Civic Improvements.

There was a good attendance at the monthly meeting of the Commercial Club on Monday evening, when President Dwight called it to order.

The first business taken up was the financial report of Secretary Callahan which showed that there are 97 members and a small balance on hand, amounting to \$8.62 and \$9.50 in the entertainment fund.

#### The State Grange.

The Secretary reported receiving a letter from the Grange asking that a committee of the club be appointed to help in the entertainment of the State Grange which will meet in this city next month. Several of the members thought that the Women's Civic League should take part in the entertainment of the Grangers and a committee from that organization should be appointed to meet with those who have charge of the entertainment features of the Grange meeting here. The president appointed R. C. Jones, A. H. Gaylord and F. C. Baker a committee to represent the club.

#### Bayocean Road Endorsed.

The club went on record recommending that the County Court expend the \$10,250 appropriated for the Bayocean road, which met with the unanimous support of the members, who made strong arguments favoring the completion of that road as soon as possible, the club passing a resolution to that effect. It was also decided that a committee be appointed to wait on the County Court and the President appointed M. F. Leach, C. J. Edwards and Jack Olson.

#### Civic Improvement.

The matter of civic improvement was taken up by Prof. Onthank, principal of the public school who drew several pictures on a sheet showing some of the rubbish and filth of premises in this city. He made a plea for civic improvement and advocated having the pupils of the school get busy at their homes and in offering of prizes. This was acquiesced in, and it was decided that the club appropriate \$35.00 for prizes and that the Women's Civic League take charge of this matter.

### Nomination of Officers.

President Dwight, previous to the nomination of officers, made some pertinent remarks about the future management of the club and read the preamble of the by-laws, which referred to the aims and objects of the club. He thought too much time had been wasted in the entertainment features of the club and too little to the commercial end, and advocated that this be made the main feature of the club the coming year. He thought the club had not been accomplishing the good it should have done and advocated a change in policy. Several of the members concurred in his ideas and they thought that some arrangement could be made to take care of the amusement features by changing the by-laws, and a committee was appointed for that purpose, composed of A. H. Gaylord, B. C. Lamb and J. R. Callahan.

President Dwight was then nominated for president to succeed himself, and announced that he would accept, only on condition that the club would get on a business basis and be a commercial club in reality as well as in name.

### Death of Mrs. Robert Stillwell.

We are sorry to announce the death of Mrs. Robert Stillwell, which took place early Friday morning at the Tillamook Sanitarium, where she was operated upon several weeks ago for appendicitis, but other troubles having developed she was operated on again on Wednesday of last week, but succumbed two days later.

There was a large and sympathetic congregation at the funeral services at the M. E. Church on Saturday.

Violet Adelaide Noyes daughter of Mr. and Mrs. W. E. Noyes was born in Burr Oak Kansas on January 26th 1892 and died in Tillamook Oregon on March 26th, 1915, at the age of 23 years and two months. At an early age Violet was converted and united with the Methodist Episcopal church in Burr Oak Kansas. In the summer of 1906, she with her parents and family came to Tillamook County, Oregon, which place has since been her home.

October the 19th, 1911 she was united in marriage to Robert R. Stillwell. She was a member of the Methodist Episcopal Church and Sunday School in Tillamook. She leaves to mourn her loss, her husband, and little daughter Marcia, her father and mother and two sisters, Mrs. Mabel Folks and Mrs. Eula Finney, both of Tillamook County, an da large number of relatives and friends. The funeral services were held at the Methodist church in Tillamook at 2:00 o'clock, on Saturday afternoon March 27, 1915. The old hymns of Faith and Hope were sung. The Rev. D. A. McKenzie, pastor of the Presbyterian church read a lesson from the book of Job, the twenty third chapter, and the Rev. H. F. White, Pastor of the United Brethren church led in prayer, the pastor of the church Rev. Edward Gittins read the obituary of the departed one, and based his remarks on the eleventh chapter of the book of Job, and the seventh verse, "Canst thou by searching find out God, canst thou find out the almighty unto perfection." The Rev. D. L. Shrode an intimate friend, and former pastor, paid a beautiful tribute to the life and character of her who was so richly adorned with the graces of the Christian life, so lovely in disposition, so modest, and unaffected in the transparency and simplicity of character which is the growing glory of womanhood, he also comforted the sorrow-

ing hearts of her loved ones, with words of tender consolation, and inspiring hope. Young men in the strength of life's morning, with tender solemnity carried the casket, which held the form of the departed one and the words of immortal life were read from the ritual of the Methodist Episcopal church, over her who left this world in the full assurance of the glory of the home beyond. A floral wreath of carnations, the gift of the young people's Progressive Sunday School class with other flowers of beauty from sympathetic friends, were laid on her grave. The large number of people attending the services at the church and the cemetery was a glowing tribute of esteem and affection to her, and to those who are so sorely bereaved.

### Management of Bayocean.

From Journal:  
Authority to receive, collect and enforce payments for Bayocean lots is given S. B. Vincent, appointed receiver of the property and affairs of the T. B. Potter Realty company, and manager of the company under the receivership. This authority is given in the order signed by Circuit Judge Gatens making the appointment. The order follows an agreement between property owners and the realty company. The suit for the appointment of a receiver will remain pending but all other suits involving the company's affairs which grew out of the trouble between the company and certain property owners, have been dismissed with the exception of such suits as are for collection of amounts due on outstanding contracts.

With the advice of a committee composed of three from the company and three property owners, Vincent will manage the affairs. A four-sevenths vote of the committee will decide all matters. Vincent is authorized to sell lots, exchange lots that the district of improvement may be centralized, and carry out as funds are available, the agreements of the company embodied in the contracts for sale of lots.

Vincent is to post a \$25,000 bond before taking charge. The committee members are to be named by each side within 15 days of the decree which was signed March 23. All employees of the company will be let out at once and Vincent is empowered to appoint such employees as are deemed necessary by himself and the committee. Vincent's compensation is to be fixed by the committee.
