

Notice of Intention to Improve Certain Streets in Tillamook City Oregon

Notice is hereby given, to all whom it may concern, that the Common Council of Tillamook City, Oregon, deems it expedient to improve certain streets in Tillamook City, Oregon, and to that end said Common Council did on the 12th day of May, 1915, at an adjourned session of a regular meeting thereof, adopt a Resolution and Notice setting forth therein the streets that said City proposes to improve, and also the kind and manner of improvements that said City proposes to make, the estimated cost thereof and defining the boundaries of the assessment district to be benefited thereby and assessed therefor, which said Resolution and Notice, letters and figures as follows, to-wit:

Resolution and Notice of Intention to Improve Certain Streets in Tillamook City, Oregon

Be it resolved, that the Common Council of Tillamook City, Oregon, deems it expedient, and hereby declares its intention to improve the following streets:

Fifth Street from the East line of Second Avenue East, East to the East boundary of Tillamook City, and Third Avenue East from the South line of Fourth Street to the North line of Fifth Street in the following manner:

By establishing the grades of said streets; By grading said streets to proper sub-grade; By rolling the roadway thereof; By laying on said streets a concrete roadway 34 feet in width, 4 inches in thickness at the sides and 5 1/2 inches in thickness in the center. Together with a standard sheet asphalt wearing surface 1 1/2 inches in thickness.

By constructing along each side of said roadway a combination concrete curb and gutter;

By building concrete catch basins and laying drain pipe, together with inlets and making provisions for the necessary surface drainage of said streets, with all of the appurtenances thereto, and

By laying and constructing concrete headers with sheet asphalt wearing surface.

All of said improvements to be made in accordance with the charter, resolutions and ordinances of Tillamook City, Oregon, and in accordance with the plans, specifications and estimates of work therefor, and of probable cost thereof, made and prepared by the City Engineer of Tillamook City, Oregon, and filed in the office of the Recorder of said Tillamook City, Oregon, on May 3rd, 1915, and all of said improvements to be made at the expense of the property, and all thereof adjacent thereto and especially benefited by said improvements and within the limits of the assessment district established and defined by this ordinance.

Be it further resolved, that the plans, specifications and estimates for the proposed improvements so made and prepared by said Engineer and filed as aforesaid (the estimate of the probable total cost of said improvements as made and prepared by the City Engineer being the sum of \$22,012.73) be and the same are hereby approved.

That the boundaries of the assessment district to be benefited by said improvements and assessed therefor be, and the same is hereby established as follows:

Beginning at the intersection of the center of the West line of Block 7 of Thayer's Addition to Tillamook (now Tillamook City) with the East line of Second Avenue East, and running thence East to the center of said Block 7; thence North to the North line of said Block 7; thence East along the North line of said Block 7, and of Block 8 in said Addition, to the center of the North line of said Block 8; thence South to the center of said Block 8, and 35; of Thayer's Addition to Tillamook City to the East line of said Block 35; thence Southeasterly to the West boundary of Block 34 of Thayer's Addition to Tillamook City, at a point 167 feet North of the Southwest corner of said Block; thence Southeasterly in a direct line, intersecting a line 105 feet North of the South side of said Block 34 at a point 100 feet East of the West line of said Block 34; thence East along the said line in said Block 34 and the center line of Block 3 and 4 of Miller's Addition to Tillamook, and of blocks 4, 5 and 6 of Park Addition to Tillamook City, to the boundary line of said Tillamook City, thence South along said center line through Blocks 7, 8, and 9, of said Park Addition, and Blocks 5 and 6 of A. A. Miller's Addition, and Block 37 of Thayer's Addition, to the West line of said Block 37; thence in a Northwesterly direction to the center of the East side of said Block 36 in Thayer's Addition; thence West, following the center line of Blocks 36, 19, 10 and 9 in Thayer's various additions to Tillamook City, Oregon, to the East line of Second Avenue East; thence North along said East line to the place of beginning.

That the said assessment district shall be and is hereby designated as "Local Improvement District No. 1," and that the property, and all thereof included within said Local Improvement District No. 1, is the following: In Thayer's Addition to Tillamook City, Oregon, the following: Lots 2, 3, 4, 5, 6, 7 and 8 in Block 8; Lots 1 and 2 in Block 9; Lots 1, 2, 3, and 4 in Block 10; Lots 5, 6, 7, and 8 in Block 11; Lots 1, 2, 3, 4, 5, 6, 7, and 8 in Block 12; Lots 1, 2, 3, and 4 in Block 13; Lots 5, 6, 7, and 8 in Block 14; Lots 1, 2, 3, 4, 5, 6, 7, and 8 in Block 15; all that part of Block 34 lying South of a line running from a point in the West line of said Block 34, 167 feet North of the Southwest corner of said Block, and running thence Southeasterly to intersect a line 105 feet North of the South side of said Block 34 at a point

100 feet East of the West line of said Block 34, and running thence East to the East side of said Block 34, and Lots 1, 2, 3 and 4 of Block 37.

In A. A. Miller's Addition to Tillamook (now Tillamook City) Lots 5, 6, 7, and 8 in Block 3; Lots 12 in Block 4; Lots 2, 3, and 4 in Block 5; and Lots 1, 2, 3 and 4 in Block 6.

In Park Addition to Tillamook City Lots 5, 6, 7, and 8 in Block 4; Lots 5, 6, 7 and 8 in Block 5; Lots 5, 6, 7 and 8 in Block 6; Lots 2, 3, and 4 in Block 7; Lots 1, 2, 3, and 4 in Block 8 and Lots 1, 2, 3, and 4 in Block 9.

Be it further resolved, that the City Recorder be, and he is hereby instructed to cause this Resolution and Notice to be published for three consecutive publications in the City official newspaper, and that the City Engineer be, and he is hereby directed to cause to be conspicuously posted at each end of the line of the contemplated improvements a copy of this Resolution and Notice within 3 days from date of the first publication of such notice. The said published Resolution and Notice, and the posted resolution and Notice, to also contain all of the matters with reference to said proposed improvements that are required by the charter and ordinances, and resolutions of Tillamook City, Oregon, and all persons concerned are notified to govern themselves accordingly.

All persons concerned are hereby further notified that the first publication of this notice is made the 14th day of May, 1915, and that objections and remonstrances to said proposed improvements may be filed with the City Recorder of Tillamook City, Oregon, within 20 days from the said date of the first publication.

Notice is hereby given, to all whom it may concern, that the Common Council of Tillamook City, Oregon, deems it expedient to improve certain streets in Tillamook City, Oregon, and to that end said Common Council did, on the 12th day of May, 1915, at an adjourned session of a regular meeting thereof, adopt a Resolution and Notice setting forth therein the streets that said City proposed to improve, and also the kind and manner of improvements that said City proposes to make, the estimated cost thereof and defining the boundaries of the assessment district to be benefited thereby and assessed therefor, which said Resolution and Notice, letters and figures as follows, to-wit:

Resolution and Notice of Intention to Improve Certain Streets in Tillamook City, Oregon

Be it resolved, that the Common Council of Tillamook City, Oregon, deems it expedient, and hereby declares its intention to improve the following streets:

Second Avenue East, from the North line of Ninth Street to the South end of said Street. Also, that street sometimes described as Twelfth Street, which connects the South end of Second Avenue East with the South end of Stillwell Avenue, from the West side of Ninth Street West 211.5 feet to the West side of the street running South along the Township line between Township 1 South, Range 9 West and Township 1 South, Range 9 West, W. M., and that certain street, the center line of which is the Township line between Township 1 South Range 9 and 10 West, W. M., from the South line of the Edrick Thomas Donation Land Claim South to the South boundary of Tillamook City, in the following manner:

By establishing the grades of said streets;

By grading said streets to the proper sub-grade;

By rolling the roadway thereof;

By laying on said streets a concrete roadway 24 feet in width, 4 inches in thickness at the sides and 5 1/2 inches in thickness in the center. Together with a standard sheet asphalt wearing surface 1 1/2 inches thick.

By constructing along each side of said roadway a combined concrete curb and gutter;

By building concrete catch basins and laying drain pipe, together with inlets and making provisions for the necessary surface drainage of said streets, with all of the appurtenances thereto, and

By laying and constructing concrete headers with sheet asphalt wearing surface.

All of said improvements to be made in accordance with the charter, resolutions and ordinances of Tillamook City, Oregon, and in accordance with the plans, specifications and estimates of work therefor, and of probable cost thereof, made and prepared by the City Engineer of said Tillamook City, Oregon, and filed in the office of the Recorder of said Tillamook City, Oregon, on May 3rd, 1915, and all of said improvements to be made at the expense of the property, and all thereof adjacent thereto and especially benefited by said improvements and within the limits of the assessment district established and defined by this ordinance.

Be it further resolved, that the plans, specifications and estimates for the proposed improvements so made and prepared by said Engineer and filed as aforesaid (the estimate of the probable total cost of said improvements as made and prepared by the City Engineer being the sum of \$8,812.69) be and the same are hereby approved.

That the boundaries of the assessment district to be benefited by said improvements and assessed therefor, be and the same is hereby established as follows: Beginning at the Northwest corner of Lot 4 of Block 15, in Thayer's Addition to Tillamook City, and run-

ning thence East along the center of said Block 15, 71.5 feet; thence South to a point 101.5 feet South and 101.5 feet East of the Southeast corner of the Edrick Thomas Donation Land Claim; thence West 101.5 feet East of the West line of Section 30, Township 1 South, Range 9 West, W. M.; thence South to the South boundary line of Tillamook City; thence West along said South boundary line to a point 135 feet West of Township line between Township 1 South, Ranges 9 and 10 West, W. M.; thence North to the South line of the Edrick Thomas Donation Land Claim in Section 25, Township 1 South, Range 10 West, W. M.; thence East 105 feet; thence North 135 feet; thence East to the Southeast corner of Lot 5, in Block 4, of Drew Addition to Tillamook City; thence North following the center line of Block 4 and 2 in Drew Addition, and Blocks 5 and 4 in R. Notice of Special City Election.

Notice is hereby given, that in pursuance of a Resolution adopted by the Common Council of Tillamook City, Oregon, on the 12th day of May, 1915, a special election will be held at the City Hall in Tillamook City, Oregon, on the 1st day of June, 1915, at which election there will be submitted to the qualified electors of Tillamook City, for their adoption or rejection, a measure to amend Article XI of Chapter VIII of the Charter of Tillamook City, Oregon, proposed by initiative petition, the said measure being in words and figures as follows, to-wit:

"A measure to amend Article XI of Chapter VIII of the Charter of Tillamook City, Oregon, as said Article was adopted by the legal voters of Tillamook City at a special election held in said city on March 29, 1915. Be it enacted by the people of Tillamook City, Oregon, as follows:

Chapter VIII. Article XI.

Section 1: The legislative power of the city is vested in the Common Council, but the same is subject to and shall be governed by all of the initiative or referendum provisions of the constitution of the State of Oregon as the same is now in force or may hereafter be amended, and subject to any of the initiative and referendum provisions of the Charter of Tillamook City or ordinance legally enacted under pursuance of the constitution aforesaid, or of any of the provisions of said Charter.

Section 2: Whenever any initiative or referendum measure is to be voted upon at any general or special election, the City Recorder shall cause to be placed upon the ballot at the election at which any such measure is to be voted, a ballot title and brief description of the measure to be voted on in such form as may be prescribed by the Common Council in accordance with the Charter of the city.

Section 3: The people of Tillamook City, or the Common Council thereof, subject to the initiative and referendum powers reserved to the people, shall have full power and authority to provide by appropriate

Shall a Measure for the Amendment of Article XI of Chapter VIII of the Charter of Tillamook City, Oregon, as proposed by initiative petition filed May 8th, 1915, and as referred to the people of Tillamook City, Oregon, by Resolution adopted by the Common Council of Tillamook City, Oregon, May 12th, 1915, be enacted:

The Measure proposed amends the Charter of Tillamook City, Oregon, by adding to Article XI of Chapter VIII a new Section authorizing the issuing of \$300,000.00 of bonds of Tillamook City, the proceeds to be credited to "City Hall Fund" and authorized the Common Council to use so much thereof as may be necessary for the construction of a city hall. Said measure further raises the debt limit of Tillamook City from \$70,000.00 to \$90,000.00, exclusive of sinking funds and improvement bonds.

ordinance or ordinance not to conflict with any superior power or authority, for the purpose of erection, construction or maintenance and operation of a complete water system of water works, electric or gas light plant or plants, to create a sewer district or districts within said city, and to put in and maintain a sewer system or systems, or a system of drains for the city, and to make the cost of such drains or sewers, or any part thereof, a charge or lien upon the abutting or adjacent property within said district, and to compel the connection of closets, cess pools and drains with said sewer or sewers, and to borrow money upon the credit of the city therefore by issuing bonds or otherwise. Section 4: The Common Council of Tillamook City is hereby authorized to issue forthwith bonds in any sum not to exceed \$30,000.00 upon the faith and credit of Tillamook City, in such denominations as the judgment of the Council, in its discretion, may deem expedient, the same to be known and designated as "City Hall Bonds," and bearing a rate of interest not exceeding six per cent per annum, interest payable semi-annually. That upon the issuance of such bonds, the same be advertised and sold to the best and highest bidder therefor, and the proceeds of such sale be placed in the hands of the Treasurer of Tillamook City and credited to the "City Hall Fund." That so much of said fund as may be necessary shall, under the direction of the Common Council, be forthwith expended in the erection, construction and completion of a City Hall to be located and erected on grounds now owned by said Tillamook City, and any sum not expended in such erection, construction and completion shall be transferred to the General Fund.
