Editorial Snap Shots.

According to the Austrian Ambassador, President Wilson is a self-willed man, and Secretary Lansing's arguments "are certainly very weak."

Of course we'll shed crocodile tears when the Austrian Ambassador leaves this country. It is time that a smart alex he proved himself to be should be told to get out, boots and baggage.

We want to remind the "wets" that it is now only three months before the "dry" season commences. It is safe to say that a large amount of money will be expended in these three months getting in a good supply, for its a long, long way to California.

We do not see why the Boundary Board cannot form one school district of the county. All that it needs is a petition of the citizens, for the Boundary Board has the right to do so. Here's an opportunity for those who want to cut out the special school levies and advocate equal taxation for property owners and educational advantages for the children to get busy.

It is reported that the allies have commenced their long expected "drive." Call it by its right name: "Another horrible butchery of human life," thanks to militarism. There is no getting away from the fact that before this brutal butchery is over two thirds of the armies now in the field will be slaughtered, wounded or taken prisoners. It is plain to see that the war is one of physical exhaustion.

The city will have to cut down the running expenses of the city or increase taxation, as a result of the loss of saloon licenses. Why not start in right now and cut off some of the trimmings. Is it really necessary to have a night watchman and day policeman? By cutting out one of these officials it will save more than one saloon license. That is a good saving to start with, for there's going to be considerable complaint if taxes are raised these close, hard-up Democratic times.

According to the newspaper reports it was stated at the M. E. conference at Roseburg that a still more stringent Sunday closing law was in preparation and would be submitted at the next general election. So "straight laced" is the proposed law that it will be impossible even to purchase a newspaper on Sunday. It is surely going to put the lid on good and tight, and the citizens of Oregon will have to toe the line, should the proposed Sunday closing law carry. But the people have something to say in this matter whether they want to be governed by extremists on Sunday closing.

It seems that Marion County has succeeded in reducing the cost of hard surfaced county roads. It does its own work and it costs only \$5,600 a mile, including royalties. Not long since it was estimated that it would cost a million dollars for 60 miles of hard surfaced highway through Tillamook county. If the work can be accomplished in this county as cheaply as in Marion—there is no reason why it shouldn't—with an expenditure of \$100,000 annually on hard surfacing, in four years this improvement could be completed, to say nothing of the saving each year in maintenance charges that are now eating up a lot of the road fund every year.

There is one thing that the snap shot man and Bro. Trombley agree in and that is small print shops and other small industries should not come under the industrial law. We don't want to taunt Bro. Trombley, but the law is the fruit of the Oregon System that he so loudly proclaimed a few years ago, and which was to cure all of our political ills. We are sorry to have to admit it Bro. Trombley don't like his own medicine now that he has to go down in his jeans every month. Well, all of the taxpayers have had to do the same thing as a result of the Oregon System, for they must all own up that taxation, instead of being on the decrease, is jumping higher every year.

As we expected, some of the District Attorneys who want notoriety are going to enforce the Sunday closing law, which hasn't been enforced since the state was taken into the Union. After being a dead letter for so many years, there is no public demand that it be enforced. If it is necessary to have a Sunday closing law, then pass one that is more in accord with present conditions. For instance it is unlawful for a garage to keep open on Sunday but a livery stable may do so; hotels can stay open and serve meals; but restaurants must not

open. All kinds of comparisons can be drawn to show that the Sunday closing law is out of joint with prevailing conditions.

So Tillamook County won first honors at the National Dahlia Show in Portland, in the amateur class, showing the best display of dahlias outside of Portland, thanks to the efforts of a few ladies who were determined that Tillamook should be represented. Had the first plan been carried out, in which the Women's Civic League was to have taken the initiative, a much larger and more varied assortment could have been gotten together, but this fell through at the last minute. However we hope the League will take the initiative next year and send a bumper display to the National Dahlia show, not only entering the amateur class, but professional class, for its "Show Me" where dahlias grow to greater perfection than in Tillamook.

We are a lot of "idiotic Yankees." This is what Captain Fritz von Papen the German military attaché at Washington, calls us. Probably we are in one respect. The United States is not a party to the idiotic war and the biggest butchery of human life ever perpetrated upon man kind by a war lord and idiotic Kaiser, whose aim and object is world wide power. Most of us in this country think militarism is idiotic, for death—horrible deaths—destruction and misery follow in its wake. If Captain von Papen was a military attaché in another country and said the people were "idiotic" it is safe to say that he would be kicked out immediately. This is what he used in a letter to his wife "I always say to these idiotic Yankees, that they had better hold their tongues."

We think that District Attorney Goyme is using good judgment in not attempting to enforce the so-called Sunday closing law, for, in our judgment, it would be a useless waste of the taxpayers' money to prosecute everybody who violate the law. How would the District Attorney get around a case like this: Suppose he closed up the fruit and candy stores, there is nothing to prevent the store keeper from selling his goods outside his store. He would have complied with the letter of the law, but there is nothing in the law to prohibit a person from selling goods on Sunday. For another illustration: What would the District Attorney do in regard to railroad, telephone and telegraph offices, which are open on Sunday in violation of the Sunday closing law? Probably the plea would be made that they are a public necessity. We don't believe anything of the kind, for if there is to be a Sunday closing law then make everybody conform to it without exceptions. We do not think it is good law and good common sense to have such a fool law on the statute books. The good old book says something about swallowing a mountain and straining at a gnat, and this is what our Sunday closing law is endeavoring to make us do.

"It would be a good plan for the County Court to finish up all road projects now under construction next year, and be careful about starting others." This was a remark made by one of our citizens when discussing road matters which, we think is worthy of consideration, for we do not think it is a good policy to have too many expensive road projects in hand at the same time. For instance, there is the Sour Grass and Hebo roads that should be completed and improved for next year's travel, the Sandlake road, the road to Bayocean and the Garibaldi-Wheeler road. These roads are in different parts of the county, and of equal importance to the entire county. It seems to us that a united effort should be made to have these roads completed next year. Already there are petitions being circulated to have the Garibaldi-Wheeler road completed, signed by citizens from all parts of the county, but it is just as important to have the other roads well next year, and all parts of the county should pull together for this object. The central part of the county is just as much interested in the Dolph road and Garibaldi-Wheeler roads as those living in those localities so let's make a united effort to have all these roads completed early next year.

The snap shot man feels that the city is not doing the right thing in not encouraging and allowing oil stations to be located in the city. Or is it because the citizens are slow to adapt themselves to modern devices and safe guards against fire? Most every live progressive city have from one to three oil stations, and we do not see why Tillamook City should not be allowed to enjoy this safe way of handling and economical distribution of oils. Here's a chance to obtain oil from the producer to the consumer at much less cost to the consumer than heretofore. We had occasion recently to see what other towns were doing in this respect, and we find they have adopted the modern system of oil stations in preference to having oil barrels distributed in buildings, which are a menace to the city by way of fire. The way to do away with some of our fire risks is to encourage stations, and every business man with a large stock of goods, or property owners, should wake up to these facts and not allow anyone to prevent this improvement. Some years ago a few individuals monopolized most everything, even the corner lots, and they did not want to see new industries, business houses or people locate here. The snap shot man thought we had lived down and out grown that kind of thing, but every once in a while the same spirit appears to crop up to oppose progress and modern ways of doing business. Harvey Wells, State Insurance Commissioner, in the Fire Prevention Bulletin, says, speaking of gasoline: "Unless the stuff is indispensable to your business or household, avoid its use. One pint of gasoline will impregnate 200 cubic feet of air, and make it explosive. When used at all, it should be handled by

daylight only. Keep it outside of the building, in air tight cans—never in glassware or uncorked receptacle."

THE CHILDREN'S PARK.

Thomas Gilford Stillwell Agrees to Accept the City's Proposition.

Thomas Gilford Stillwell, who deeded 4 1/2 acres of land within the city limits, for a children's park and play ground, having brought suit to recover the land, accepted the City's offer to deed one acre of the land to the city on condition that he be allowed to take judgment against the city. This was mutually agreed upon by Stillwell's attorneys, S. S. Johnson and T. B. Handley, and City Attorney H. T. Botts, the following stipulation having been placed on file in the suit pending in the Circuit Court:

It is stipulated and agreed that the plaintiffs have a decree on condition that the defendant Tillamook City shall be compensated for money expended by it on the property, plaintiff agreed to convey to Tillamook City an acre of the land, beginning at a point 17.67 chains south and 2.65 chains west of the southeast corner of Block No. 6 in W. D. Stillwell's addition to the town of Lincoln (now within the incorporate limits of Tillamook City, Ore.), and running thence 135 feet; thence north 322 2-3 feet; thence east 135 feet; thence south 322 2-3 feet to the place of beginning, and that immediately upon the entry of the decree Thomas Gilford Stillwell shall convey this property to the city by a good and sufficient warranty deed, free and clear of all incumbrances, and without any restrictions whatsoever.

COUNTY PAVES OWN ROADS.

Marion County Figures - Cost at 67 Cents Per Square Yard.

Salem, Or., Sept. 25.—Since the first of the year Marion County has laid 23,936 yards of hard surface pavement for a total cost of \$15,933.86, or at the rate of 67 cents a square yard. The cost of a mile \$5600 for a 12-foot roadbed. Figures compiled by the County Court show that of the 67 cents a yard paid for paving, 15 cents has been for royalties.

This is the first year in which Marion County has laid its own pavement, and the work is being watched with interest by officials of other counties.

College Dairy Students Engage in Dairying.

Oregon Agricultural College, Corvallis, Sept. 27.—Work directly related to their special training in dairying at the Oregon Agricultural College is now being performed by 18 members of the 1915 graduating class and seven members of the 1914 class constituting the entire number of dairy graduates for the last two years. This seems to justify the claim that graduates of Agricultural Colleges are very likely to find immediate employment and go at once into the practical occupation that the state has trained them to develop.

It has been the purpose of the dairy department officers to place these graduates in positions advantageous to themselves and also to their employers. Six of the eighteen are employed in official cow testing; three are superintendents of public instructions interested in dairying; two are managing cooperative creameries; one is a milk inspector in a metropolitan bureau of health; two are butter makers in creameries; and two are taking advanced college work. These are all graduates of the 1915 class.

The highest salary received by any of these men is that of the manager of a large dairy farm who receives \$1200 and quarters. Three others receive \$1200 without accessories. Two receive \$1000 each, while several receive \$720 with board and lodging approximately equal to this amount. By following the career of these students and noting the degree of success attained by them in their special lines, the College dairy officers expect to be able to relate more intimately than ever before the work of instruction and training to that of practical fields of endeavor.
