

NOTICE OF DELINQUENT TAXES OF REAL PROPERTY IN TILLAMOOK COUNTY OREGON, FOR THE YEAR 1914.

The following list of real property situated in Tillamook County, State of Oregon, is hereby advertised for delinquent taxes assessed for the year 1914. This advertisement is authorized by an act embodied in chapter 301 of the General Laws of Oregon as passed by the 1913 session of the Legislative Assembly.

The taxes on the following advertised list of real property became delinquent October 1, 1915, and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum until the said taxes shall have been paid.

Notice is hereby given that six months after the taxes charged against the following real property first became delinquent the Sheriff as required by law will issue Certificates of Delinquency against the said property for delinquent taxes. The said Certificates of Delinquency will bear interest at the rate of 15 per cent per annum until the Certificates are redeemed.

Any time after the expiration of three years from the first date of delinquency of any tax included in a Certificate of Delinquency the holder of such Certificate may cause summons to be served on the owner of the property described in the certificate, notifying the owner that he will apply to the Circuit Court of the county in which such property is situated for a decree foreclosing the lien against the property mentioned in such Certificate.
