Justice Stanley rendered a decision in the case of H. E. Spencer and E. E. Parker vs. F. D. Small and D. C. Urie, in favor of the plaintiff Parker, placing the damage at \$83.56. This was a case where the value of a Ford auto was involved, which the defendants had taken possession of. At the trial the value of the auto was placed as high as \$250.00 by one of the witnesses.

According to the new federal game laws which are now in force, the duck hunting season in Washington and Oregon will open on October 1 and close on January 15. The federal law conflicts with the state law but all hunters are warned that the federal law is the one that will be enforced.
