### TILLAMOOK CHEESE WINS FIRST PRIZE.

At the National Dairy Show at Springfield, Mass.

Three Tillamook cheese makers competed at the National Dairy Show at Springfield, Mass., with some of the best cheese makers of Wisconsin and the Eastern states and the local cheese makers carried off the best prizes. This will not only add to the fame of Tillamook cheese, but it is a great honor that the cheese makers of Tillamook County gained in competition with Eastern cheese and cheese makers. This is a record we all feel proud of.

H. M. Biberstein, of Red Clover, won first prize with a score of 98 1/2 points, which is a splendid showing. Hugh Barber, of the Fairview Dairy Association, tied with a Wisconsin cheese maker with a score of 98 for second prize.

A. J. Schmeidler was fifth with a score of 97.75 points, of the M. T. Chance & Co's factory, Beaver.

There were 27 entries, as follows: Wisconsin, 16; New York, 3; Oregon, 3; Idaho, 3; Pennsylvania, 1; and Vermont, 1.

This not only proves the splendid quality of Tillamook cheese, but that it excelled in quality with the Eastern and Wisconsin cheese.

### ONE MILLION DOLLAR BID FOR TIMBER.

Bond Owners Buy in Timber of Tillamook Timber and Logging Co.

There were only seven persons present on Monday morning when the timber lands belonging to the Tillamook Timber and Logging Co., situated in Tillamook, Washington and Lane counties were put up for sale by public auction. Attorney Wallace McCamant, master in chancery, Attorney Littlefield and W. H. Jacob, of Chicago, came in on Sunday for the purpose of disposing of and buying in the property for the bond holders.

Mr. McCamant stated the condition of sale and asked for bids when Mr. Jacob said he offered a bid of \$1,000,000 for John P. Olsson, of Chicago. There being no other bid the property was sold to Mr. Olsson. Mr. McCamant said he had received the necessary certified check of \$25,000 and Mr. Jacob said that bonds would be put up in Chicago for the amount of the bid. Mr. Olsson who bought the property, is assistant cashier of the First National Bank, of Chicago.

The property of the Tillamook Timber and Logging Co., was bonded to the First Trust and Savings Bank of Chicago, for \$3,000,000, and it is estimated that it includes 2,000,000,000 feet of timber in the three counties, a large portion, however being in Tillamook County.

When the company's property was bonded it was generally thought that that the bond holders would have to take over the property, as it was thought the company had been well paid for its property.

When judgment was entered against the Tillamook Timber and Logging Company last July, Wallace McCamant was made master in chancery. He was to open the timber land for public sale and under the terms of the judgment any one of the complainants, or those holding the bonds, were allowed to become out and out purchasers of the timber land and the sawmill and other equipment thereon.

Litigation in the District Court of the United States was commenced by the First Trust and Savings Bank, of Chicago, May 29, 1916, when that corporation filed its complaint praying for a foreclosure of the trust deed it held on the timber land by reason of its purchase of the timber company bonds.

Judgment was entered July 10, 1916, by Federal Judge Bean.

The bank had advanced \$3,100,000 on a bond issue to the timber company. The remainder of the amount named in the judgment was far in excess of the semi-annual interest payment which was default, taxes, and \$15,000 of the bank's fee.
