

**Call For Bids.**

**Tillamook Men Invent Nut.**

A device which they believe will become a feature of importance in practically all future mechanical construction has been perfected by John A. and G. W. Stubblefield, of Bay City, who have applied for a patent. The former was in Portland Tuesday arranging some details with regard to handling the manufacture and marketing the device.

It is a lock nut, one that Mr. Stubblefield says will do away with trouble in mechanics in the future, due to bolts becoming loose through results of vibration. The new device he declares, can be adjusted so that vibration tightens it, or it can be adjusted so as to be immovable in either way. Mr. Stubblefield says that it is easily adjustable and does not strip the threads on the bolt, and that it can be removed easily or can be adjusted to lock so that nothing short of a coldchisel will take it off.

**John Adolph Dahlgren.**

At the Dalles, on Saturday, Jan. 13, occurred the death of John Adolph Dahlgren of acute dilatation of the heart. With his family he had but a few days before gone from Dallas to The Dalles in the hope of benefitting his health. He was in his 55th year. Mrs. Dahlgren was formerly Miss Minnie Gallentine, who grew up at Dallas and is well known there. The family before going there resided in Sheridan and Tillamook. Besides his wife, one child, Jack, age six, survives. Funeral services were held on Monday at St. Barnabas' church at 2 p.m. conducted by Rector E. H. Clark. Burial was in Masonic cemetery. Those attending the burial from out of town were Mrs. Florence Hopkins, of Milwaukee, a sister of Mrs. Dahlgren, and Mr. and Mrs. C. W. Talmage, of Portland. The sympathy of many friends is extended to Mrs. Dahlgren in her bereavement.

**Judge Belt Asks Correction Be Made**

Relative to a story appearing in the Journal of January 16, in which Circuit Judge H. H. Belt of the Twelfth district, Dallas, was quoted as being in favor of the elimination of many circuit judges and the consolidation of judicial districts, Judge Belt asks that the following correction be made:

"The Journal fairly quoted me as saying that one judge could do all the work in Yamhill, Polk and Tillamook counties, and that the district, of which Tillamook county is now a part, created during the 1915 session of the legislature, was made over my protest. This statement, was made, however, in connection with the subject of the creation of judicial districts and had no reference to the elimination of circuit judges or the consolidation of judicial districts.

"Whether any judicial districts are consolidated is a matter to be determined by the legislature and I do not wish to be understood as taking the position which you ascribe to me."

**High Bred Heifer Calves Will Be Bought Here.**

In order to improve the breed of dairy cattle in Lane County, James Olsen and Edwin Jensen, of R. F. D. No. 1, Eugene, made a trip to Tillamook County recently at the suggestion of the Bank of Commerce, which is deeply interested in the dairy business, and made arrangements to buy a number of high-bred calves to be shipped to Eugene in the near future.

The Bank of Commerce will include calves in its Boy's club work this season, and it was for the purpose of obtaining the best of stock that the suggestion was made to Mr. Olson and Mr. Jensen to make the trip to Tillamook.

They visited the best herds of dairy cattle in that region, and as a result they return with first hand knowledge of the best herds there, and made arrangements to handle the calves from a number of them. Mr. Olson will handle the Holsteins and Mr. Jensen the Durhams.

The idea is to handle these calves in this territory to furnish the farmers who want Holstein and Durham heifers of a superior breed. The calves which Mr. Olson and Mr. Jensen arranged to secure run from

three-fourths pure bred to full blood. Mr. Olson and Mr. Jensen while in Tillamook made arrangements with J. Merrill Smith "The Calf Man" to buy up the required calves, and he will look after their business at this end.

**SENATE VOTES TO ABOLISH TAX BOARD**

Measure is Carried by 26 to 2.

Salem, Or, Jan. 22.—With colors flying, the first consolidation measure of the season went through the Senate today by a vote of 26 to 2.

The measure submitted Senate bill No. 18, introduced by the Senate committee on consolidation, of which Senator Dimick is chairman. It abolishes the State Tax Commission and confers its powers and duties on the Public Service Commission.

The only Senators voting no were Pierce of Union and Wallowa, and Strayer, of Baker, both Democrats.

In the lively debate preceding the roll call, however, Republicans and Democrats alike disclaimed that any political issue was involved. Three Democrats—Senators Garland, Baldwin and Wilbur—joined the Republican majority in voting for the consolidation.

With the passage by so nearly a unanimous vote of this measure, a real beginning has been made in the promised consolidation programme of the present Legislature. And that start has been made at the beginning of only the third week of the session.

There still remains nearly four weeks in which to complete the programme for elimination of various boards and commissions, or their consolidation with others.

**BOPP AND THREE AIDES GET TWO YEARS EACH**

German Counsel General and Other Neutrality Violators Sentenced

San Francisco, Jan. 22.—For the first time in the history of the United States a foreign Counsel-General, Franz Bopp, one of three Counsel-Generals of Germany in this country, was sentenced to prison and payment of a fine today for violation of American neutrality. Judge William H. Hunt, in the United States District Court, sentenced Bopp to two years in a Federal prison at McNeil's Island Wash., and one year in the county jail and assessed an aggregate fine of \$10,000 against him, the prison and jail terms to run concurrently.

Three of Bopp's aides, Vice-Consul E. H. von Schack, Lieutenant George Wilhelm von Brincken, and C. C. Crowley, a war-time secret agent, received like sentences. Mrs. Margaret W. Cornell, Crowley's secretary, received concurrent prison and jail sentences of one year and one day and one year, with no fine.

All were convicted by a federal jury on January 11, of conspiring, first, to violate American neutrality by setting afloat a military enterprise against Canada in aid of Germany; second, of conspiring to violate the Sherman law by dynamiting munition shipments in interstate commerce. The first is a felony for which all save Mrs. Cornell, received the maximum prison sentence. The second is a misdemeanor carrying as the maximum sentence that laid upon the defendants, saving Mrs. Cornell, who escaped the \$5000 fine.

Judge Hunt gave the defense 30 days in which to perfect an appeal to the United States Circuit Court of Appeals and he fixed bail for Bopp and von Schack at \$10,000.

Mrs. Cornell injected the dramatic into the solemn procedure of sentencing by leaping to her feet when her attorney Samuel Platt, of Reno, Nev., was asking for mercy.

"I want no leniency. Why should I ask for leniency? I have experienced no justice in this court."

There being no woman's quarters at McNeil's Island, Mrs. Cornell will have to serve her sentence, if it is sustained, either in San Quentin prison, Cal., or in some Eastern Federal penitentiary.

Dr. Erich Zoepffel, of Seattle, took over the German consulate at noon today, Bopp having been removed by Count von Bernstorff, German Ambassador.
