Editorial Snap Shots.

Cleanup time is here. The city needs a spring clean up as usual.

No one can doubt the loyalty and patriotism of the people of Tillamook after the meeting Sunday night.

A Granger told us a few days ago that he believed a large majority of them would vote for the state and county bonding measures. We do not know why they should not do so, for the proposed hard surfaced roads will be a great benefit to every farming community.

One thing is certain the war is going to bring more women into the industrial life of the country. With 1,000,000 men mobilized, this will make labor scarce in all parts of the country, and it will not be long now when women will be holding positions now held by men.

Everyone should commend the Oregonian for its patriotism and outspoken stand in this trying crisis. Putting aside party politics and silly sentimentalism, The Oregonian has always denounced the barbarous manner in which Germany killed our citizens, which was not war, but cold blooded murder. We feel proud of Oregon's great daily newspaper.

As the cost of living will get higher and higher it behooves everybody, especially in this county to raise more food stuffs this year than in previous years. By raising plenty of garden truck and chickens this will help some in reducing the cost of living, for it is going to become much more costly to live if the government does not step in and put a stop to the exorbitant charges now made for all the necessities of life.

Just a word of advice about so-called treasonable language. Quite a number of reports have reached the officials, who have taken time to investigate but in doing so have found in most cases that these reports have been exaggerated. If any one knows of treasonable language used by anyone, it should not be made common gossip but should be reported at once to the proper authorities. It is doing harm to circulate false reports against some of our citizens.

The best friends of this city are those who give financial support to help new industries. We are glad to say a large number of our business men put their heads together and promised financial aid to start a ship building plant, and others are ready to join in the movement and lend their financial support when called upon. These are our progressive citizens who have large investments here, who have great faith in the future of Tillamook city. This is the right spirit and is something worth striving for far better than dividing the citizens, over local politics, which always leave more or less sore spots.

It is too bad that the taxpayers' money should be thrown away. A large sum of money was expended last year, about \$60,000, to dredge a channel in Tillamook Bay, and reports now say it is filling up. It was that channel which was to benefit one timber company, and it, no doubt, played its cards in having the channel located there. Suppose the county court had squandered that amount of money, what a big howl some of the timber men would have raised. Some day somebody with good common sense and engineering ability will decide that a great mistake was made and a lot of good money was thrown away because the Sturgeon channel was not selected. It is time to get down to brass tacks and do the sensible and proper thing.

It is young men who are wanted for the 10th Company Coast Artillery, unmarried men who should respond to the country's call in this critical crisis. We make another appeal to the young men of Tillamook County to offer their services. It was dropping bombs on England that aroused that country and gave recruiting a great impetus, and should a raider drop a few shells into Tillamook County, which it could easily do, young and old would be aroused and want to enlist. The country calls you young men to defend it in its hour of need. It is not flowery, patriotic speeches, it is young men with patriotic spirit, who are wanted, and we feel assured that in a few days the necessary number of young men will be found who will bring the company up to 150 strong. We Tillamookers will feel proud of the Tillamook Company.

It is safe to bet that the \$600,000 state bonding measure will carry over to one, and that the county bonding measure will go through with a whoop, for the people of this county are overwhelming in favor of a hard-surfaced highway through the county. And why shouldn't they be in favor of these measures when the highway can be obtained with state and federal aid? Tillamookers know a good thing when they see it, and no one need be surprised that they are all jumping on the right side of the

fence. We anticipate that those who are opposed to bonding the state and county for good roads will soon be advancing the argument that we should go slow on account of the war, so as to spare people. It will not work however, for everybody knows that good roads are the first step to preparedness.

One phase of the war situation was not touched upon at the meeting Sunday night, which would not be out of place for us to dwell upon at this time. Notwithstanding that Germany violated her treaty obligation with Belgium, over ran and devastated that small country, and leaving the people to starve, it was the kind hearted people of the United States who subscribed hundreds of thousands of dollars for food to keep them from perishing from hunger, but the ruthlessness of the Kaiser and his war lords have sent dozens of relief and hospital ships to the bottom and destroyed the food that was intended for a starving people. The war started with an outrage when the big German army was pushed through poor little Belgium, and ever since that time Germany has been committing cold blooded outrages one after another. It is not to be surprised at that the whole world is rising up as one man to prevent Germany carrying on that kind of outrageous, barbarous warfare. And the Kaiser has been telling the German people, and they appear to believe it, that God is on his side.

We are all more or less tarred with the same brush when it comes to saying unkind things about other persons and peddle gossip. In fact, there is too much scandal and gossip being indulged in by the gossips about persons of German extraction. It is true that some of our German citizens have shown more or less partiality with Germany in the terrible war that is now raging, but that is now a thing of the past with most of them now that the United States have declared war on Germany. In circulating unfounded reports, and peddling gossip about persons of German extraction is wrong. It looks like the snap shot man that it is about time to round up the scandal mongers and gossips and prosecute them. We will ask our citizens not to report any false gossip they hear about our German citizens, but if any person has the evidence of anyone uttering treasonable language they should immediately inform District Attorney Goynne or Sheriff Campbell. These two officials have been kept busy trying to ferret out reports, started by gossip mongers, but they have found them false and scandalous. This is no time to be peddling scandalous gossip.

If our respected friend, Bro. Trombley, is such a good Christian it would be a true Christian and gentlemanly act on his part to apologise to Bro. Cady for publishing a dirty, libelous slander about him: "He and his kind may always be counted on to stand with those who favor open saloons and brothels on Sunday." But we want to ask our respected brother a pointed question. If it is perfectly just, right, and proper to prosecute bootleggers and others who violate state laws, why shouldn't you, who published libelous matter about a Christian gentleman, be prosecuted also, under the criminal libel laws of Oregon? We are not wanting to see our good brother persecuted for the "big whopper" he published about Bro. Cady, if he will do like all good Christians ought to—repent and ask for forgiveness for the un-Christian act. CALLS ON GERMAN-AMERICANS TO STAND WITH US.

F. C. Hesse Assails Ingratitude of Group of Malcontents Who Arouse Distrust.

Astoria Or., April 6.—(To my fellow-citizens of German extraction.)—Like Hercules we German-Americans are standing today at the parting of the ways. The land of our birth, and the country which we have made our home by choice have been drawn into the maelstrom of the bloody conflict of the world war and we German-Americans are today confronted with the difficult task of deciding to whom we shall throw our support. In my humble opinion there is but one conclusion to be drawn, and that is to stand with America, and behind America to the utmost of our ability. In arriving at this conclusion, I beg of you to remember the various motives which caused us or our forefathers, to leave the country of our birth and become citizens of this great nation.

Some of us came starving and service and upon arriving here, were not forced to devote from our three years of the most valuable period of our lives to compulsory military service.

Welcomed to America. Eome of us came starving and hungry as a result of the over-population of our native country and compelled to immigrate by its concomitant conditions entered the government service, the professions, went into business, and as a result the American public supported us heartily.

Some of us came, tired of the caste and class distinction and the attending prerogatives and privileges prevailing in the country of our birth, and upon arriving here, we found a free land where everybody, including ourselves had equal rights.

Some of us came, tired and disgusted of the bare and meager existence and livelihood which we were only able to earn in the fatherland in spite of incessant hard work and endurance. Upon settling here some of us have become immensely rich, the greatest majority of us have amassed a comfortable fortune and all of us at least have earned an abundant living.

Some of us came without child or chattel, America gave us a home we have married and settled since.

Some of us came because all of the real property of the country of our birth was in possession and tenure of aristocratic, landowners who held possessions either at exorbitant prices, or would not sell at all. America received us with open arms, took us, like a compassionate mother, to her bosom, allowed us to share in the taking up of our public domain, resulting in the acquisition by thousands of us, of some of the most valuable land of this hemisphere.

Some of us came thoroughly dissatisfied with German conditions and after settling here and becoming acquainted with American habits and conditions of living are now receiving the protection of this government and the privileges of immunities of the land of our birth, and are settled and satisfied.

Ingratitude Base as of Vices. Brethren avarice is the root of all evil, but ingratitude is ten thousand times worse than that, and is the worst of all crimes. For no other reason but gratitude should we stand behind this government. But there is another reason. When we applied to become and when we became citizens of this great country we rendered and subscribed to a solemn oath and renounced all political allegiance to the emperor of Germany and to our native country and pledging our support to this government. Those are the conditions upon which we were allowed to become citizens. In our native language we say "A man-a-ward," the meaning of which is well understood by you, and I feel that we are in duty bound to remain faithful to our oath.

"Whose song I sing," is an anthem of our well-known German expositions. America has given us a home, has protected us, has clothed us, has fed us and our families, and I say again I feel we are in honor bound to support America in this conflict and that it is our sworn and solemn duty to do so. When I use the word "support" I do not mean to be understood as saying that I request of you to rush to the nearest recruiting station in order to offer your military services to this country, but that is the individual privilege of those who wish to do so, unless we are drafted into service by the government. This government has always maintained a reasonable attitude and I am fully convinced will adhere to principles of sound reason even in this critical hour. I am sure our American does not expect our German-American brothers who have brothers, nephews, and other blood relatives fighting in the field for Germany, to voluntarily take up arms against them and urge them to kill. All that I want to be understood in saying, when I use that word that we should justify and approve the actions and steps of the American government in every respect and give it our hearty and unanimous support. No form of government heretofore devised is faultless. All have their advantages and disadvantages, but I fully believe and therefore express myself to that effect, that the American government is as near a perfect government as we can conceive. You and I will see the time, and the time is not very far off, when all the nations of the universe, including the country of our birth, will be republics, will adhere to the principles of a government "of the people by the people, and for the people" and America will lead them all. It will be American freedom, American principles, American policies they will all strive to obtain. Each of you is entitled to your private opinion but matters having come to a climax and having compelled this government to arrive at a definite decision, I feel that all of your personal opinions should step into the background and we should stand as one behind this government.

Assail German Ruthlessness. It cannot be denied that England, France, Germany, in fact all the nations involved in this bloody war, have violated international laws. Germany, however, has been guilty of the severest violations. The ocean since time immemorial has been the open highway of commerce and traffic of the whole world and no nation has the right to sink, capture or blow up vessels of neutral nations engaged in peaceful commerce without warning. Germany has done so not only once or to times, but hundreds of times. She has done so after this government strenuously objected and protested against such practice. She has done so after she solemnly declared after the sinking of the Lusitania, to abstain from such conduct in the future. She has done so without distinction as to the ship's errand, nationality. She has sunk Belgian relief ships and hospital ships. The consequence must, therefore, fall upon Germany, and Germany alone, and although all of us may be in sympathy with her people's plight, with her valor, her superciliousness, her admirable sacrifices, her marvelous resourcefulness, affairs have come to an open break between the country of our birth and the country of our home. I maintain that we have no longer the right to voice our private opinions and sympathies, but we should assure the United States of our loyalty.

I am of the firm opinion that by far the greatest majority of the German-Americans are on the side of the American government in this conflict. It is only a small number in comparison with the entire number of German-Americans—only a handful—who raise their voices against the action of the American government, and who ruthlessly, wilfully, unlawfully, with bombs, dynamite and other means have destroyed and threatened to destroy American lives, property, American ships, American means of defense, or who have dealt a similar fate to the property and ships of the allies. It is neither right nor justifiable that the antipathies, prejudice, the hatred and contempt of the entire American nation should be visited upon the whole number of German-Americans, that we are loyal German-American citizens should be punished with distrust or disrespect; that we should all be held in contempt as a result of the actions of a handful of stubborn, cantankerous, ungrateful individuals who do not represent the feelings of the majority of this great number of splendid peaceful, law-abiding German-American citizens.

More Light Leaks Out. In the Roseburg Review is revealed some more information concerning the proposed re-organization of the Oregon system of government referred to in last week's Voter as emanating from Master C. E. Spence of the State Grange.

At a conference held in Roseburg Friday and attended by C. E. Spence, Master of the Oregon State Grange, and Robert E. Smith, Chairman of the legislative committee of the Taxpayers' League, it was decided that a reorganization of the legislature should be attempted by the members of the latter organization at the earliest possible moment.

This puts the matter squarely up to the Taxpayers' League, which was organized by Mr. Smith in behalf of the taxing timber interests. Mr. Smith is the able lobbyist of the timber owners. Doubtless with him behind the movement it will take form and loom up as one of the main issues of the 1918 election, for anything that takes hold of it is because of the large interests it represents, but because of his demonstrated ability to carry off his projects by vote of the people of his state.

Spence probably can line up the labor organizations, as at the recent legislative session he helped them put their program through, sacrificing nearly everything the Grange and Farmers' Union asked in order to help the labor bodies.

According to the Review, the Spence-Smith plan to abolish the lower house altogether, and as an alternative, to reduce the representation in the upper and lower houses to one-half their present membership.—Oregon Voter.

It may appear queer justice but it is exactly what was meted out in these two cases.—Banks Herald.

"That \$6,000,000 is a large sum to take away from the taxpayers," is an assertion being made a good deal in commenting upon the pending road bond issue. The assertion is based upon a prevalent misunderstanding of what the act involves. Nothing in the act requires any increase in taxation in order to get the \$6,000,000. It is the automobile which pays the money Auto license fees have been doubled, and with a normal increase in the number of machines owned in Oregon, the fees will more than cover the interest and the sinking fund payments to retire the entire bond issue. Should there be no increase at all in the number of autos used it would still be unnecessary to raise taxes, for the extra money would come from the present quarter-mill road tax. Supporters of the road bonding measure will do well to correct the misunderstanding.—Umpqua Valley News.

The war lords of Europe look on the United States with contempt. They regard us as "too fat to fight." We are supposed to be absorbed in money getting, full of ease and love and pleasure. But before they rate us too far down, they want to reflect on American history a bit. Every tale of heroism and endurance and daring form Verdun and the Somme can be matched right out of our own history. The kings and kaisers would better let sleeping dogs lie!—Umpqua Valley News.

A Beaverton man tells of a funny sequel to the meeting of the parent-teachers association of that town Wednesday night. Robert Krohn, physical director of the Portland schools, had expected to address the meeting, but found at the last moment that he could not fill the engagement. A Portland organization was appealed to for another speaker and the gentleman selected was met at the train by a reception committee. Being a stranger the visitor was inquired as to the subject of his proposed address and replied that he would talk against the bonds. The ladies were in a quandary for a moment, but finally explained that Beaverton was for the bonds and they did not think it proper to introduce the topic in an educational meeting. He therefore returned to Portland with an undelivered address and it is said that inquiry as to who he was brought the reply that he was C. E. Spence.—Independent.

Last Friday evening the two evening papers of Portland printed full page advertisements signed by the "Emergency Peace Federation" of New York. It purported to be an appeal from the east to the west to prevent the United States from entering the war. Telegrams and letters were solicited to be sent to the President and members of congress, urging action against a declaration of war. Appearing on the same day that the Oregon soldier boys left for the mobilization camp, it was decidedly ill-timed. The people of Oregon, especially those who had given boys to the ranks, were in no mood to entertain such a proposition, even had they believed it came from genuine American pacifists. But the advertisement that it had an effect opposite to what was intended and hundreds of letters and telegrams were sent to Oregon congressmen and senators, urging them to stand by the President. Americans favor peace, but they won't be insulted.—Itemizer.

Woman's Great Victory in England. Russia's revolution is a great victory for democracy. The promise of the vote of the English commons that the English women shall receive the ballot so soon as the registration lists are compiled is another great victory. The acceptance of woman suffrage by Lloyd George and Asquith is the most important gain which the movement has made in half a century. The statesmen of England realize that without the women it would be impossible to carry on the war and that they have worked out their political emancipation. In view of the marvelous sacrifices and enduring heroism of English women in a war as to entering upon which they had no voice the statesmen can do nothing else than do the right and wise thing. They recognize the political equality of women with men as citizens of their common country.

There may be delays. Postponement of woman suffrage from these days of battle until the end of the war may be advisable. The law may not be amended at once. Parliamentary elections have not been held since the war began, except a by-election or two, and none may be ordered before the return of peace. But if an electoral reform statute be enacted this year, it will probably include votes for women, and the parliamentary franchise has been their aim. The policy and principle of woman suffrage have entered into the theory and practice of the English constitution.

The strategy of Mrs. Pankhurst has succeeded. At the outbreak of the war she had her followers enlist in support of the very government they had been opposing and assured them that if they would but make themselves indispensable to the nation, no leader or party could afford to refuse their rights to them. The suffragists took their leader at her word. They went into the munitions factories and replaced the men who had gone to the front. They proved their loyalty. They demonstrated their ability to organize and their power to toil and endure. They devoted themselves to the defense of England with a vim and fectiveness which show that they are qualified to handle affairs of state.—Spokesman Review.

Learn From the Negroes. For an example, those Americans of Caucasian race who cudgel their brain for excuses to keep out of war when Germany makes war on the United States are commended to a citizen of negro blood. This is what Roscoe Conkling Simmons, of Louisville, Ky., a nephew of the later Booker T. Washington, said recently to an assemblage of his own race:

"We have a record to defend, but no treason, thank God, to atone or explain. While in chains we fought to free white men—from Lexington to Carrizal—and returned again to our chains. No negro has ever insulted the flag. No negro has ever struck down a president of the United States. No negro ever saw a military map or secret to a foreign government. No negro ever ran under fire or lost an opportunity to serve, to fight, to bleed and to die in the republic's cause. Accuse us of what you will—justly or wrongly—no man can point to a single instance of our disloyalty.

"We have but one country and one flag, the flag that set us free. Its language is our only tongue and no hyphen bridges or qualifies our loyalty. Today the nation faces danger from a foreign foe, treason stalks and skulks up and down our land, in dark councils intrigue is being hatched. I am a Republican but a Wilson Republican. Woodrow Wilson is my leader. What he commands me to do, I shall do. Where he commands me to go I shall go. If he calls me to the colors, I shall not ask whether my colonel is black or white, I shall be there to pick out no color except the white of the enemy's eye. Grievances I have against people, against this government, injustice to me there is, but laws there are upon the statute books, but in this hour of peril I forget—and you must forget—all thoughts of self or race or creed or politics or color. That, boys, is loyalty."

Those words come from a member of a race which the United States released from the slavery only a little more than fifty years ago and which has since been denied the lawful rights in many states, but that does not prevent exhortation of unflinching loyalty. Though the negro's skin is dark, his liver is not bleached nor does he give evidence of a yellow streak. Let the six Senators who voted against the war resolution sit at the feet of their negro fellow-citizens and learn patriotism.—Oregonian.
