The committee will nominate a number of young ladies for the Goddess of Liberty, and the business men who contribute toward the demonstration will be given a certain number of votes in proportion to the amount given, the voting commences on the 18th and ending the 23rd of June.

Patriotic addresses are being arranged for by the local speakers and several ladies have kindly offered their services to provide a large choir, and a number of the local musicians will provide the music.

Captain Johnson has kindly consented to have the 10th Company, Coast Artillery, participate in the demonstration, and with the G. A. R. W. R. C., and other organizations it will be the biggest patriotic gathering ever held in Tillamook county.

COMPANY TO BE MUSTERED IN.

Date Will be July 15th—Leaves Tillamook Two Weeks After.

Captain S. S. Johnson, of the 10th Company, Coast Artillery, is instructed to recruit the company up to its full strength which is 109 men. Owing to several men being discharged eight more men are required, and there will be little trouble procuring that number now that it is known the company is to be mustered in on the 15th of July, and two weeks after that date will entrain for Fort Stevens or some other point for a course of training. Before leaving the company will take part in a patriotic demonstration in this city on July 4th, which will enable people from all parts of the county to see the boys and give them an ovation.

Captain Johnson has received the following memorandum, to enable civilians to take the physical examination as specialists. It says:

"A special examination for Coast Artillery enlisted specialists will be held June 18. Specially competent civilians who have passed physical examination and other requirements for recruits may take examinations without enlisting and no obligation will attach to them in case of failure. Circular 29 shows number allowed in each grade. Results of last examination will be announced as soon as possible. Please advise those concerned."

It will be noted that only civilians will be permitted to take these examinations. They will be required to first undergo the physical examination required for all recruits. This can be given by the examining physician located at any company station or at Eugene on the day preceding the examination.

Applicants will send in their names to Captain W. G. Williams, 640 Morgan Building, Portland, Oregon, or to 1st Lieutenant Charles B. Hamble, Eugene, Oregon. They should give age, married or unmarried, education, profession, experience or other qualifications for examination to be taken.

The designation of place of examination will be made later and will probably be Eugene.

Death of L. D. Ackley.

Lorenzo D. Ackley, a well known citizen of Tillamook County for many years, passed away at his home at Medford, Ore., where he had resided for several years. The remains were brought to Tillamook for burial and the funeral services were held today. The deceased is survived by his wife and nine children, viz: Ralph Ackley, Portland, Ore.; Claude Ackley, Mrs. James Williams and M. D. Ackley, of Tillamook, Ore.; Harry Ackley, of Company C, O. N. G.; Lee Ackley, and Nellie Ackley, of Medford; Mrs. H. Williams, Turlock, Cal., and Mrs. F. O. Fredericks, of Medford, Ore.

Mr. Ackley was born on a farm near Cincinnati, Ohio, August 5, 1884, and is the third of the seven sons and five daughters born to Samuel and Charlotte (Ripley) Ackley. Samuel Ackley was born in New York state in April, 1812, and his wife was born near Marietta, Ohio, on Duck creek, in 1813. As a young man just starting out in the world, Samuel Ackley went from New York to Ohio, married there, and when Lorenzo D. was a year old moved to Putnam county, Ill. A few years later he moved to Iowa, and after a winter spent in Black Hawk county, returned to Illinois, where he lived four years. His next home was in Sullivan county, Mo., removing from there in about a year to Page county, Iowa, his intention being to get away from the trouble over the slavery question. Until 1861 he roamed around over Illinois, Iowa and Missouri, and that year crossed the plains with ox-team, arriving at his destination in California at the end of five months. After a winter in Butte county he removed in the spring to a different locality, and for nine years had no settled home for any length of time, in the meantime engaged in ranching. In time the disposition to locate in Oregon led him to make the journey over the mountains with teams, and from Portland he took a boat for Tillamook county, where he lived on a farm until 1871. Then, with the faithful wife who had shared his many wanderings, he moved to San Bernardino county, Cal., where four years later, in 1875 his death occurred his wife and helpmate surviving him for two months only. Lorenzo D. Ackley remained in Oregon when his people went to California, and the following year, in 1872, was united in marriage with Mary J. Jenkins, who was born near Knoxdale, Iowa in 1851.
