Sir Douglas Mawson's Expedition Secures Pictures Abounding In Strange Sights and Thrills

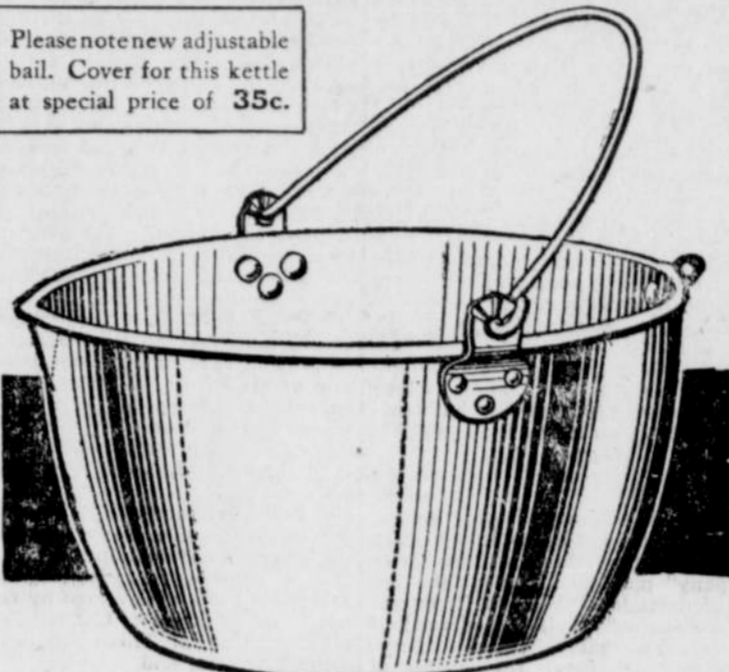
