OPENS ON SATURDAY.
Tillamook City's New Fire Proof Moving Picture Theatre.
The new fire proof moving picture theatre will throw its doors open for the first time to the public on Saturday evening. The new movie theatre is a vast improvement over the old wooden frame building, and is equipped with all modern improvements and conveniences. The new theatre is along the lines of improvement in this city, and the citizens will appreciate it.
The theatre is equipped with the best of everything, new folding opera chairs, new Powers 6B projection machine, absolutely the latest thing in picture machines; new picture screen, as good a screen as can be found in any city; a splendid stage for the accommodation of good theatrical troops, ventilation on the same plan as adopted by the Portland schools; lights are of the inverted indirect type; there are three large roomy aisles dividing two seating sections, making it handy for the patrons in this respect, and aisles are covered with a rubber runner so that there is no chance for any one to slip or fall; the foyer is covered with a cork carpet, which is easy and restful to the feet, as well as a silent covering, the lobby is of large proportions, making splendid display room for all advertising, with a flood of light in the lobby, ceiling and in the transom bar. Entrance is direct into the foyer from lobby. Exits have been put in for safety of the public, which are according to requirements of the State Board of Underwriters. There is also a fire standpipe in the building which is continuously connected and will be ready in an instant should the occasion for its use ever arise. The exits are marked with "Exit" in large red letters, a light being placed at the back making them always conspicuous. There is also a rest room and toilet for the accommodation of the patrons. In fact the building as a whole come far above the average for towns of this size, and a credit to towns of several times the size of Tillamook.
