Editorial Snap Shots.

The banks of the county did a land office business selling Liberty Bonds last week, but the snap shot man did the boosting. Bully for the banks of Tillamook county for they made a splendid showing.

No business man or firm is safe as long as lawbreakers and bootleggers resort to shipping whiskey in their name. The district attorney is to be commended for unearthing the conspiracy, and we hope the county officials will unearth the culprits and bring them to justice. Business men should render the officials every assistance, for if that system is allowed to continue it would involve innocent persons in the bootlegging business.

There is a question as to whether the county can hold another special election before next June. It is another nice point of law. If the special election in June was illegal then there was no legal election. The only way to ascertain is to attempt to do so, and put it up to the supreme court whether it can be done. This is all the law says on the point "Only one special election shall be held in any county in one year."

Of course we are in hearty sympathy with the conservation of food, but other things should be conserved as well. We have received a number of booklets from the United States food administration with Mr. Hoover's name attached, and we find that only one side of the page in the booklet are printed on, and the other being blank. To our way of thinking it is just as right to conserve paper as food, so why this wilful waste of paper by the food administration that is calling on the people to conserve food?

The decision of the supreme court in the county bond measure is, to say the least, disappointing to the people of Tillamook County, as well as to the County Court and the good road boosters, who believe it to be the best interest of the county to construct a hard surface road through the county with as little delay as possible. The overwhelming majority at the special election proved this. But feeling disappointed will not help matters. The next best thing to do is to take off your coats, roll up your sleeves and go to it again. That is what we are going to do.

This office received a gratifying telephone message on Wednesday afternoon stating that the Brighton Mills Co. and its employees had subscribed \$16,100 for Liberty Bonds, giving the names of the subscribers which will be added to Tillamook's quota, raising the total amount subscribed in the county to \$153,200.00. This came as a great surprise to the Liberty Bond Boosters in this city. They greatly appreciate the splendid showing that Brighton made, for it was a most liberal addition to the amount of money that had been raised in other parts of the county. The subscription from the Brighton Mills Co., and its employees was placed in the company's bank at Portland.

Miss K. Mills is no longer deputy county clerk, which position she held for nine years with considerable credit to herself and satisfaction to the public. Always courteous and obliging and always at work she served the county well and faithfully, and for that reason we believe she is deserving of a word of commendation. If everyone who worked for the county did their work as efficiently as Miss Mills did hers no one would be able to say that county funds were wasted or persons were getting paid for idle time. To the victors, however, belong the spoils, and this, no doubt, is the reason Miss Mills had to vacate her position.

It is exceedingly unfortunate for Tillamook County that the county bond measure was knocked out just at a time when the money was needed to consummate the 20 miles of hard surfaced road that is being built and to be built in the south part of the county by the State Highway Commission. Another election cannot be held until next June, only one special election can be held in a county each year. This may have the effect of the State Highway Commission postponing the building the other 15 miles of hard surfaced road, unless some plan can be devised by the County Court to obtain the county's share of the expense, which is estimated at about \$7,000 a mile. We do not know what action the County Court will take, but it will have the backing of the people if it can devise some plan that will not delay the building of the additional 15 miles of hard surfaced road, even to the extent of taking nearly the whole of the road apportionments of the two road districts. It would be far better to delay all other road work in these two districts to obtain the additional 15 miles of hard surfaced road next year. This is about the only way the money can be obtained as far as we can see, that is if it is required before another election is held. Throwing out the measure presents a hard problem for the County Court to deal with, and it will entail some careful

consideration and close figuring to know how best to proceed in making up the next road budget, and for that reason the court should have the earnest co-operation of all good road boosters. It is safe to say that when the matter of bonding the county is re-submitted to the people there will be a larger majority than last June for people can now see for themselves that it was no idle talk in obtaining state aid for Tillamook county roads.

We agree with the Supreme Court that people readily sign petitions and do so often without proper consideration, but we take exception to its contention that this was the case in Tillamook County when the citizens were asked to sign the county road bond petitions, for when they signed it they were intelligently informed and understood what they were about. It was no snap shot judgment on their part. The matter had been thoroughly discussed in the newspapers and in every part of the county months before the petitions were even circulated, and it seems to us that the Supreme Court was not well informed on that point. However, because of a slight technicality, which to the average layman does not amount to anything, the Supreme Court adhered to what it considered a strict interpretation of the law instead of allowing the sovereign will of the people to prevail. The fact that 1499 citizens voted for the measure and only 678 against should have had some consideration, for if every person voted intelligently at an election the people of Tillamook County did so at the special election in June. They were not responsible because the petition was faulty in on trivial particular but they voted intelligently as to what they wanted, and to our way of thinking the will of the people should have had more consideration than a technical point over which attorneys disagree. Whether the Supreme Court would allow a rehearing with these points more fully explained to the court we do not know. It would do no harm to try. The decision of the Supreme Court simply means this. It is putting the county to the unnecessary extra expense of holding another special election and delaying what the people of the county have shown a decisive manner they want, and a questionable technicality should not be used to defeat the will of the people.

About Goat's Milk.

High price of cow's milk has started a boom for goat's milk. Why, asks some bright citizen, should not every person have a goat on his back lot to be milked every morning and evening? That suggestion rises visions in the mind of the suburban Portlander of a goat doing double duty, devouring the pesky weeds and brush from the vacant lots in his vicinity and also providing milk for the baby. But there are drawbacks. It is a mistake to suppose that neglected goats will give milk free from objectionable flavor. Under good conditions, we are told, the taste is not disagreeable, but these presuppose care which is only practicable when goats are kept as a business venture. A common goat gives only two or three quarts of milk a day, although well-bred stock does better than that, and you must catch your goat before you can milk her. That takes time, and milkers' time costs money these days.

Taking one consideration with another, it seems that we must rely on good old bossy for our milk, or on the milkman for the stuff which he slanders bossy by calling it milk. There was a time when some of us might have refreshed ourselves with a more seductive substitute, but that was in the bad old days before prohibition.—Oregonian.

FOOD CONSERVATION

Appeal to the Women of the United States to Help.

From President Wilson's letter to Mr. Hoover.

"The women of the nation are already earnestly seeking to do their part in this, our great struggle for the maintenance of our national ideals, and in no direction can they so greatly assist as by enlisting in the service of the food administration and cheerfully accepting its direction and advice. By so doing they will increase the surplus to food available for our own army and for exports to the allies. To provide adequate supplies for the coming year is of absolute vital importance to the conduct of this war, and without a very conscientious elimination of waste and a very strict economy in our food consumption we can not hope to fulfill this primary duty."

Pledge Card for United States Food Administration.

To the Food Administrator:
I am glad to join you in the service of food conservation for our nation, and I hereby accept membership in the United States Food Administration, pledging myself to carry out the directions and advice of the Food Administrator in my home, insofar as my circumstances permit.

The Food Administration wishes to have as members all of those actually handling food in the home.

Anyone may have the Home Card of instruction, but only those signing pledges are entitled to membership window card, which will be delivered upon receipt of the signed pledge.

This is the pledge card you are asked to sign. Who would refuse? See what it says! Nothing more than a promise that you will live according to your own conscience. You do not need to promise wheatless days nor meatless days. You just promise that you will live according to your conscience; and who of us is opposed to such a pledge?

Of course, when you sign it does mean that you will try from that day to live according to the pledge—try a wheatless or meatless day if you think you ought—and surely by all means help us stop that senseless waste.

Remember, too, that this pledge card is sent direct to Washington when you sign your name—this card is sent and filed in the archives and you get your acknowledgment—an honor for every patriotic American woman.

Mrs. Woodrow Wilson was the first woman to sign this food pledge card. This is pledge to the pledge—now. So you will have no regrets later.

Appeal to the Conscience.

In every home the conscience must reign. If not, what then? Picture America—on compulsory rationing! Not a new idea, hardly, this idea of a home conscience about food. We need but get back, back once more to the old-fashioned home, the kind of a home in which many of us older folks were raised, where even if there was plenty, the waste of foods, as we were taught by our mothers, was a sin.

Can we not all of us, every patriotic man and woman, help spread that sense of idea?

Plant it with a few words deep down in the minds. And your epicure who insists that his wife shall use butter in cooking, will soon pass such uncomfortable moments that his palate prefers meat cooked with vegetable fats. Never forgetting, however, amid this appeal to altruism, the other fact, that healthier habits of eating can easily be cultivated with a corresponding fattening of the pocket book.

Food the Deciding Factor.

The three factors which will determine the issue of this war are men, money, and food. We are reverently dedicating lives. We are freely spending money. The third task is hardest—to modify food habits of 110,000,000 Americans.

This can be done only by cooperation, universal, whole-souled, decisive. This cooperation must begin in the home. Mother, father and children are equally under obligation to enter the partnership. The outcome of the war and the welfare of the world depend upon active participation in their 22 million American households.

To All Patriots of the Home.

In these stirring days when our country faces the most colossal task in its entire history, the spirit and determination which every man does his bit may prove to be the turning point of the war. Nothing should be left undone to save our boys who are going to the front. On the other hand, there is not a boy who is going to the front, even life itself, to preserve the honor and integrity of the nation under whose banner he fights.

What kind of boys are we sending to the front? We expect to send one million brave boys. Most of them are just approaching manhood,—filled with hopes and aspirations, and who little dream that they had been preparing themselves to defend the country they love against the most highly organized foe the world has ever known. The responsibility which rests upon them calls for courage, a determination and a patriotism almost sublime. That these boys will meet the responsibility, meet it bravely and victoriously, none of us entertain the slightest doubt.

Not long ago at a great college regatta a dozen crews were lined up on the Hudson for a four mile race. In every boat were eight men, clean morally and mentally; physically perfect. The banks of the river were lined with thousands of people waiting to cheer their favorite crew along to victory. The signal was given. At

that instant almost a hundred oars touched the water, and with perfect rhythm these crews shot down the river. Toward the end of the race one eight-oar shell took the lead and finished a few inches in advance of the others. As this boat took the lead thousands of people remarked upon the rhythm of the stroke and the grace with which the men rowed. There was no hesitation, no flinching, no casing up on a single oar.

After this boat crossed the line, the crew rowed over to the dock and every member of the crew except one stepped out. What had happened to him? Early in the race a brass screw had worked loose in the footrest and had, during the race, gradually worked through the thin sole of his shoe, penetrated the skin, entered the flesh and finally embedded itself in the bone of the boy's heel. He had to be yanked loose from the boat. Imagine if you can the pain he suffered during the four-mile race and yet not once did he fail to throw all his power into the stroke that was to win the race.

This boy is not an exception; he is one of a million young men going to the front. Every one of these fellows will stick whether he faces machine guns or the cold steel of the bayonet. But this is not the important question. We have undertaken a task in this enrollment campaign. Our task is to see that every other person sticks to his task, which is to supply these fighting boys of America with sufficient wholesome food to enable them to fight as we know they can fight and will fight, providing they are loyally backed by the people at home.

The campaign is almost here. This is the time when every person is going to make his great drive. This is the time when we are going to know just how many American families are going to back the boys at the front. This is the time when we are going to find out who sticks and who quits. Let us assume our responsibility, not in part, but in full. Let us see to it that every family in our country or city enrolls. No matter what our engagements, no matter what the weather may be, no matter how much money we may earn during the time that we will have to give up to this work, let everyone be a true patriot and join the ranks of those who pledged themselves to stick; to see it through; to fight it out and not quit.

Reports from all through the South and Central West and the Northwest indicates that this is going to be one of the greatest national campaigns in the history of the country. Your state has furnished its proportion of young men. Your state will pledge its full proportion of families committed to food conservation. There is no apathy in your part of the country, and we know that you do not want it. You are called to duty, you are going to respond for your country and for your boys.
