But practically everybody became scared, and as far as Hillsboro is concerned a local merchant says sugar was bought faster than it could be shipped in, and the total sold was much greater than can be consumed in many months. If that was all there was to it, however, no particular harm would be done, but with everybody hoarding sugar a real shortage will probably develop and inconvenience to those not hoarding and incidentally a tilt in price will result. This same Hillsboro dealer believes that the merchants themselves should take a hand in these scares and when they appear should agree a limit individual sales to a quantity that was probably necessary.—Independent.

Country Editors Were Right.

Several weeks ago a spokesman of the Department of Agriculture at Washington delivered an address in which he scolded the American farmer for the ruthless slaughter of calves, citing statistics as to the number of calves butchered, and arguing that farmers should raise these animals, and thus add to the meat supply of the country. Immediately, and in almost every agricultural section of the United States, there was a protest and explanation by the country editors who are in reality in closer touch with the farmers than are the Department chiefs in Washington.

It was explained in the country press that the male calves of dairy breeds do not make profitable beef animals—that the grown animal will not sell for enough to pay the cost of production. This explains why a large proportion of the calves are slaughtered, and the other slaughterings were explained by the fact that many farmers have not the feed or other facilities for raising even female calves and hence send them to the butcher.

Now the food administration has secured reports from the stockyards in all the principal centers and finds that the country editors were right. The farmers did not deserve the scolding administered to them.—Banks Herald.

Proved It By The Paper.

There is one man in the United States who will never again say that he doesn't believe the newspapers. He will probably fight any man who says that you can't believe what you see in the papers, for a musty old newspaper saved him from a term in the penitentiary.

This gentleman lives "out West." He didn't register, because he claimed to be too young—by something like six months. But the town gossip said he was old enough; they knew exactly when he was born, and they told the government. One old woman said he was born two weeks after her Rachel was born, and Rachel was twenty-two. An old he-gossiper said he remembered the date of the birth, because it was the same week he sold a horse, and that was twenty-one years ago. Still another town historian said it was when they had the big storm on Walnut Run—twenty-one and one-half years ago to the very day. So the government arrested the fellow and he was being tried as a slacker.

The government said it was satisfied, for the date showed the boy to be less than twenty one, and the court said it was satisfied, for the old newspaper would be taken for the best of evidence. And the old woman and the he-gossiper and the town historian were greatly disconcerted, but not convinced.

Obituary Notice.

David O'Donnell, one of the pioneer settlers of Buxton, died last week, Wednesday, October 24th, 1917, at the home of his daughter Mrs. Fred Caldwell, at Buxton. He was born near Portland, Leeds county, Canada, and when a small boy moved to Detroit Mich., with his parents, and later to Saginaw, where he married Margaret McParland. Nine children were born to this union, of whom eight survive: Mrs. Frank Caldwell, Mrs. Nellie Worthington, David, Frank, Hazel, Mrs. Kitty Nolan, Felix and Geoffrey. Mr. O'Donnell spent fifteen years in the South, and had many friends in New Orleans and Galveston. In 1890 he went to Portland, Ore., where he engaged in steamfitting. In 1893 he moved to Buxton and settled on the site of the Standard Box Lumber Co.'s big Washington County lumber mill. About four years ago he moved to Tillamook, where he resided until recently, his health failing. Mrs. O'Donnell brought him back to the old home for his last days. He was a member of the I. O. O. F., which order conducted the funeral. His remains were laid at rest in the Buxton cemetery.

Patriotism Knows No Class.

The fires of American patriotism are burning brightly on high mountain peaks and in the heart of the desert. Strange stories are coming to light, revealing how Uncle Sam's foster children are being fused by Liberty Bonds in the melting pot of a common cause.

Not the least of these inspiring stories he told in a matter of fact report from Superintendent F. L. Burkhalter of the Portland division of the Southern Pacific. On the summit of the company's Tillamook branch in Oregon, where verdant mountains front the sea, and where the outside world seems a thing apart, twelve Japanese section hands, without solicitation, each subscribed for a hundred dollar Liberty Bond. They were not much in advance of Greek and Italian sectionmen, who showed anxiety to assist in return for what America is doing for their native lands.

One foreman of a bridge and building gang on the Southern Pacific's Portland Division subscribed \$18,000 in cash, and a conductor came forward with \$6,600 in cash.

Among the Southern Pacific employees who enrolled in the Liberty Loan army was a group of Chinese section hands who numbered some of the last of the original workers who helped to build the Central Pacific. They were employed in what was known as the "forty mile desert" were so many of the old emigrants lost their lives.

Miss Millie Iler Passes Away.

The community was greatly shocked Tuesday morning when it was learned that Miss Millie Iler had passed away during the night. She was operated on a little over a week ago at the Nektucca Valley hospital and reports of her condition had been favorable until Monday, when a change for the worse took place and she died about midnight. Her mother Mrs. John Iler, and her uncle Chas. Ray, were at her bedside.

Miss Iler was well known throughout the county, having lived here with her parents a number of years and afterward taking care of her uncle's home.

In her quiet, pleasant way she made many friends and retained them. She was a member of the Rebekah lodge at this place and held an office at the time of her death. She was a member of the Eastern Star Lodge of Tillamook, and has taken an active part in church, Sunday school, W. C. T. U., and Red Cross work.

The funeral was held Wednesday at 1 o'clock at the Presbyterian church, the services being conducted by Rev. Curtis of the Christian Church at Tillamook. People from all parts of the county were in attendance and without doubt it was the largest funeral ever held in Cloverdale. The floral offerings were beautiful and bespoke of the high esteem in which she was held.

In her immediate family she is survived by her father and mother, Mr. and Mrs. John Iler, and two sisters, Mrs. Neva LaTrace and Mrs. Emma Evans, of Heppner, and a brother Roy Iler, of Portland.

She was buried in the Oddfellows cemetery and a beautiful service was conducted by the Rebekahs at the grave.

The bereaved family have the sincere sympathy of the entire community in their sorrow.

Millie Caroline Iler was born at Gales Creek, Washington, June 30th, 1878. She was baptized in infancy and has lived a faithful Christian life. She was ever kind and true to all who knew her, a loving daughter and a good sister. She has lived for the past 18 years with her uncle, Chas. Ray, in Cloverdale.—Cloverdale Courier.
